### **OFFICIAL PROCEEDINGS**

The Board of School Trustees of the Fort Wayne Community Schools met in regular session in the Lester L. Grile Administrative Center on Monday, August 28, 2006, at 7:04 p.m. President Geoff Paddock called the meeting to order with the following members in attendance:

Approval of Minutes – August 14, 2006 A motion was made by Kurt A. Walborn, seconded by Robert A. Armstrong, that the minutes of the regular meeting of the Board of School Trustees held August 14, 2006, be approved. Roll Call: Ayes, unanimous; nays, none.

Dr. Wendy Robinson, superintendent, presented the following information and recommendations concerning awards and recognitions:

Christopher Columbus Award – Memorial Park Middle School **RECOMMENDATION**: It is recommended that the Board recognize the A.C.M.E. Disaster Masters team from Memorial Park Middle School for receiving the Chairman's Award from the Christopher Columbus Fellowship Foundation.

**RELATED INFORMATION**: From tornadoes and floods to hazardous chemical spills, the ability of community leaders to get information to citizens can spell the difference between life and death. Memorial Park Middle School students, under the direction of Larry Lesh, formed a team called the A.C.M.E. Disaster Masters to look at how that communication process in Fort Wayne could be improved. Their hypothesis was that young students could effectively take home and return to school information about disaster preparedness. The eighth-graders - now ninth-graders at South Side and Northrop - prepared a survey with the aid of Allen County Homeland Security Director Bernie Beier. Their survey of over 750 students from different grades proved their hypothesis and also gave them information about what students and adults already knew about being prepared.

As part of their solution, the team prepared a DVD program on disaster preparedness, based on the results of the survey, and showed it to the students in the 35 participating classrooms. In addition, the A.C.M.E. team gave students a pamphlet the team had prepared to review with their families. The team also designed billboards, and were featured in reports by local news media. For their efforts, the A.C.M.E. Disaster Masters earned the coveted Chairman's Award.

For the national honor, team members received a \$1,000 U.S. Savings Bond, and a \$5,000 cash donation in the team's name will soon be given to the Allen County School Safety Commission to continue the ideas of the project. They also received an all-expense-paid, five-day trip to Walt Disney World to participate in the Christopher Columbus Academy held May 28 - June 2.

APEX Awards for Publication Excellence **RECOMMENDATION**: It is recommended that the Board recognize Tom Sims, Coordinator of Technology Projects/Webmaster and Debbie Morgan, Public Information Officer, for receiving two national APEX Awards for Publication Excellence for their work on the district's website.

**RELATED INFORMATION**: APEX awards are based on excellence in overall communications effectiveness. This year, nearly 4,800 entries from educational institutions, business and industry competed for top honors in 11 categories. Fort Wayne Community Schools receive Awards of Excellence in two categories: Home Pages and One to Two Person-Produced Web & Intranet Sites. Tom Sims is responsible for the design and operational components of the district's websites and Debbie Morgan, oversees content and writing. If you haven't looked at our Internet website, we would invite you to do so – and often! There is a tremendous amount of information – including news releases, calendars, school and bus status information and more. You will find it at http://www.fwcs.k12.in.us.

The Board recognized Tom Sims and Debbie Morgan.

D.A.R.E. American Educator of the Year Award **RECOMMENDATION**: It is recommended that the Board recognize Nita Auer for receiving the 2006 D.A.R.E. American Educator of the Year Award.

**RELATED INFORMATION**: A teacher at North Side High School since 1985, Nita Auer has played a key role in the success of the highly acclaimed D.A.R.E. program at the local, state and national levels. She has served as the education advisor to the Indiana Training Team since 1990 and was selected as one of only six educators across the country to assist in the development of the new D.A.R.E. elementary curriculum and corresponding training model. Through the years, Mrs. Auer has been an instructor at many D.A.R.E. in-service training conferences. Officials from the program call her involvement "substantial and on-going" and selected her as recipient of their most prestigious honor, the D.A.R.E. American Educator of the Year Award. She was recognized during the group's international conference held last month in Orlando, Fla.

This year, 36 million school children around the world -26 million in the U.S. – will benefit from the D.A.R.E. program, which provides children with the skills they need to avoid involvement in drugs, gangs and violence.

The Board recognized Mrs. Auer and principal, Charles DeFord.

Vouchers

Dr. Robinson presented the vouchers for the period ending August 16, 2006, with the recommendation the vouchers be approved. A motion was made by Kurt A. Walborn, seconded by Jon J. Olinger, that the vouchers appearing in the listing numbered 06-16 be approved without exception. Roll Call: Ayes, unanimous; nays, none.

T-Mobile Central Wireless Communications Site Lease – Wayne High School

Dr. Robinson presented the following recommendation concerning the T-Mobile Central Wireless Communications Site Lease – Wayne High School:

**RECOMMENDATION**: It is recommended that the Board approve a site lease between T-Mobile Central and Fort Wayne Community Schools – Wayne High School for land on which to construct a communications building and authorize the Superintendent to execute the lease. T-Mobile Central will co-locate on the communication tower of *Cingular* Wireless.

**RELATED INFORMATION:** T-Mobile Central has offered to lease space below the light pole at Wayne High School football stadium for a payment of \$600 per month for five years for the purpose of constructing a cellular communications building. The lease is renewable for an additional rental payment after the initial term.

A motion was made by Robert A. Armstrong, seconded by Jon J. Olinger, that the recommendation concerning the T-Mobile Central Wireless Communications Site Lease – Wayne High School be approved. Roll Call: Ayes, unanimous; nays, none.

Dr. Robinson presented the following recommendation concerning the Purchase of Property – North Side High School:

**RECOMMENDATION**: It is recommended that the Board authorize the purchase of the following property located near North Side High School:

**RELATED INFORMATION**: The purchase of this property is part of the purchase plan for the site. Purchase of this property will provide flexibility in the future at the North Side High School site. The current school site is below the state minimum acreage recommendation. The owner has agreed to a purchase price that is the average of the two appraisals. This purchase is funded from the Capital Projects Fund.

A motion was made by Jon J. Olinger, seconded by Kweku Akan, that the recommendation concerning the Purchase of Property – North Side High School be approved. Roll Call: Ayes, unanimous; nays, none.

Renewal of Insurance Policies Dr. Robinson presented the following recommendation concerning the Renewal of Insurance Policies:

**RECOMMENDATION**: It is recommended that insurance coverage for property, commercial general liability, inland marine, foreign package, business automobile, commercial umbrella liability, law enforcement professional liability, school leaders errors and omissions, and boiler and machinery be awarded through Acordia Insurance to three underwriting carriers at a cost of \$1,236,734.

**RELATED INFORMATION**: After several years of skyrocketing insurance premiums, FWCS and other commercial insurance buyers are seeing a break in the trend. Total premiums decreased \$323,306 or about 21% with this renewal effective September 1<sup>st</sup>. The Indiana Insurance Company will remain the largest underwriter for our coverage. Indiana Insurance insures a large majority of the school corporations in Indiana and provides the best alternative among a limited number of carriers. They not only offer programs which afford the necessary coverage to address the exposures of a public school corporation, but provide the claims administration and risk management services to support their customers.

A motion was made by Robert A. Armstrong, seconded by Stephen Corona, that the recommendation concerning the Renewal of Insurance Policies be approved. Roll Call: Ayes, unanimous; nays, none.

Employee Health Insurance and Dental Insurance Dr. Robinson presented the following recommendation concerning the Employee Health Insurance and Dental Insurance:

**RECOMMENDATION**: It is recommended that the Board renew the contract for the self-funded health insurance program with Anthem Blue Cross and Blue Shield effective October 1, 2006 through September 30, 2007.

It is further recommended that the Board renew the fully-funded dental insurance for teachers through ISTA Insurance Trust and Delta Dental effective October 1, 2006 through September 30, 2007.

**RELATED INFORMATION**: Anthem has provided a renewal of administration fees with no increase. Reinsurance premiums are declining as a result of an increase in the deductible recommended by our advisors. The overall projected effect will be a 25.6% decline in fixed fees, a savings of about \$571,000.

The renewal rate for the teachers' dental plan which covers both fixed fees and claims costs is projected to decrease by less than 2%.

A motion was made by Carol J. Coen, seconded by Kurt A. Walborn, that the recommendation concerning the Employee Health Insurance and Dental Insurance be approved. Roll Call: Ayes, unanimous; nays, none.

Public Hearing on the 2007 Budgets and Capital Projects Plan Dr. Robinson presented the following recommendation concerning the Public Hearing on the 2007 Budgets and Capital Projects Plan:

A public budget presentation was made at the August 14, 2006, regular Board of School Trustees meeting. All nine tax-rated funds and proposed budgets were discussed, and estimated tax rates were reviewed. The budgets were advertised on August 17 and August 24, 2006. The hearing on the nine tax-rated fund budgets and the Capital Projects Plan is scheduled for this evening's meeting of the Board of School Trustees.

The intent of the hearing is to allow Board members the opportunity to receive community input. Board members will be asked to vote on the 2006 budgets and the Capital Projects Plan on September 11, 2006. Kathy Friend, chief financial officer, is available to answer questions.

This was the appropriate time for members of the public to address the Board regarding the year 2007 budgets and the Capital Projects Plan.

Speakers

Representing Fort Wayne Education Association, Mr. William Gist spoke to the Board about the greater demands being placed on classroom teachers. Considering those greater demands, Mr. Gist would like the Board to consider an appropriate salary increase for teachers. He also thinks that it is important for FWCS teacher salary scales to be competitive with local districts' salary scales.

Mr. Tim Morgan spoke to the Board about the accuracy of the reports being presented at Board meetings, specifically regarding the ages of FWCS buildings. He would like to see tracking on the budget of the new Food Service Center and a comparison of the FWCS budgets from last year and this. Mr. Morgan would also like the budget presentations available on the FWCS website in a timely manner.

Public Hearing on the 2007-2016 School Bus Replacement Plan

Dr. Robinson presented the following recommendation concerning the Public Hearing on the 2007-2016 School Bus Replacement Plan:

According to Indiana Code 21-2-11.5-3.1, effective July 1, 1995, the school corporation must conduct a public hearing on a ten-year bus replacement plan before the governing body may collect property taxes for the school transportation fund's school bus replacement account. The Bus Replacement Plan was advertised on August 17 and August 24, 2006. The hearing on the Bus Replacement Plan is scheduled for this evening's meeting of the Board of School Trustees. Board members will be asked to vote on the plan on September 11, 2006.

The Bus Replacement Plan calls for the purchase of 33 replacement buses for the 336 bus fleet. Due to the tax neutrality requirement of the pension bond law, we recommend that the purchase be reduced to 28 at the tax hearing. This bus replacement reduction will not negatively impact the fleet.

The intent of the hearing is to allow Board members the opportunity to receive community input and to consider the Bus Replacement Plan.

This was the appropriate time for members of the public to address the Board regarding the Bus Replacement Plan. No one spoke.

Bid Recommendation for Food Service Papers and Supplies, P/B #9640

Dr. Robinson presented the following recommendation concerning the Bid Recommendation for Food Service Papers and Supplies, P/B #9640:

**RECOMMENDATION**: It is recommended that the Board approve awards to the lowest responsive and responsible bidders meeting specifications and quality standards:

**RELATED INFORMATION**: This bid is for papers and supplies to be used in the school lunch program at the Food Service Center and the 11 cooking kitchens from September 1, 2006 through August 31, 2007. The bid includes consumable items such as bags, bowls, foam containers, cups, foil wrap, gloves, plates, and trays.

Refugee Children School Impact Grant Dr. Robinson presented the following recommendation concerning the Refugee Children School Impact Grant:

**RECOMMENDATION**: It is recommended that the Board approve the application for and acceptance of the Refugee Children School Impact Grant for 2006-2007 in the amount of \$40,000.00 from the Division of Language Minority and Migrant Programs of the Indiana Department of Education.

**RELATED INFORMATION**: Funds from this grant will allow for the continuation of a range of services for the district's refugee students who participate in the English as a Second Language (ESL) program. The grant supports a refugee coordinator to work with intake of refugee students and their families in areas such as enrollment, evaluation and arrangement of transportation. Additionally, the grant funds a refugee remediation assistant to tutor individual or small groups of refugees and collaborate with ESL and general education teachers in support of those refugee students who have the greatest educational needs.

This non-competitive grant written by Greg Slyford, manager of Support Services, supports advancement intended and outlined in the FWCS Strategic Plan, Strategy 1: We will ensure high levels of learning for all students, and Strategy 3: We will function as a professional learning community.

A motion was made by Jon J. Olinger, seconded by Kweku Akan, that the recommendation concerning the Refugee Children School Impact Grant be approved. Roll Call: Ayes, unanimous; nays, none.

Title III: Language Instruction for Limited English Proficient and Immigrant Students

Dr. Robinson presented the following recommendation concerning the Title III: Language Instruction for Limited English Proficient and Immigrant Students:

**RECOMMENDATION**: It is recommended that the Board approve the application for and acceptance of the Title III: Language Instruction for Limited English Proficient and Immigrant Students for 2006-2007 in the amount of \$406,805.00 from the Division of Language Minority and Migrant Programs of the Indiana Department of Education.

**RELATED INFORMATION**: Funds from this grant will allow for the continuation of a range of services for the district's English as a Second Language (ESL) program including evaluation, instruction, interpretation, translation, coordination and monitoring. The Title III grant is allocated based on the number of limited English proficient (LEP) students in Fort Wayne Community Schools.

This non-competitive grant written by Greg Slyford, manager of Support Services, supports advancement intended and outlined in the FWCS Strategic Plan, Strategy 1: We will ensure high levels of learning for all students, and Strategy 3: We will function as a professional learning community.

A motion was made by Carol J. Coen, seconded by Kurt A Walborn, that the recommendation concerning the Title III: Language Instruction for Limited English Proficient and Immigrant Students be approved. Roll Call: Ayes, unanimous; nays, none.

St. Joseph Community Health Foundation Grant for Automated External Defibrillators Dr. Robinson presented the following recommendation concerning the St. Joseph Community Health Foundation Grant for Automated External Defibrillators:

**RECOMMENDATION**: It is recommended that the Board approve the application for and acceptance of a grant in the amount of \$24,000 from St. Joseph Community Health Foundation and/or Parkview Hospital Foundation to make available Automated External Defibrillators (AEDs) at all eleven FWCS middle schools and at the North Side High School pool.

**RELATED INFORMATION**: An Automated External Defibrillator (AED) is a medical device used in the event of a sudden cardiac arrest. An AED can analyze and identify fibrillation, an abnormal heart rhythm, in an unconscious person and deliver an electrical shock in an attempt to return normal heart function. AEDs are used in tandem with CPR and are designed to be operated by trained non-medical personnel. Currently all FWCS high schools, the Anthis Career Center, and the South Side Natatorium have AEDs available in their buildings. This grant would provide AEDs to our eleven middle schools and the North Side pool. All of these sites, like the high schools, are public gathering places for students, families, and community at large.

American Heart Association statistics from 2004 estimate approximately 333,000 deaths annually to cardiac arrests. About two thirds of these arrests occur outside the hospital setting. In cases of cardiac arrest, minutes matter. For every minute that defibrillation is delayed, the victim in sudden cardiac arrest decreases his chance of survival by 7-10%. On site AEDs are thought to provide non-medical rescuers with the resources to increase survival rates by up to 50%.

This non-competitive grant written by Mary Hess, supervisor of Health Services, supports advancement intended and outlined in the FWCS Strategic Plan, Strategy 2: We will provide a positive culture for students and staff.
