The Board of School Trustees of the Fort Wayne Community Schools met in regular session in the Lester L. Grile Administrative Center on Monday, September 8, 2008 at 6:02 p.m. President Mark GiaQuinta called the meeting to order with the Pledge of Allegiance and the following members in attendance:

Approval of Minutes – August 25, 2008 A motion was made by Kevin Brown, seconded by John Peirce, that the minutes of the regular meeting of the Board of School Trustees held August 25, 2008, be approved. Roll Call: Ayes, unanimous; nays, none.

Dr. Wendy Robinson, superintendent, presented the following information and recommendations concerning awards and recognitions:

Visiting Teachers from Taiwan **RECOMMENDATION**: It is recommended that the Board recognize teachers from Taiwan who are participating in the Visiting Teachers from Taiwan Program.

RELATED INFORMATION: The Visiting Teacher from Taiwan Program is a joint venture between the Indiana Department of Education and the Ministry of Education, Republic of China (Taiwan). Through this program, Indiana school districts are able to recruit highly-qualified native Chinese speakers from Taiwan to teach Chinese language and culture. Fort Wayne Community Schools Chief Academic Officer Carol Lindquist traveled to Taiwan last spring to interview applicants, and we are very pleased that two teachers are joining us this year to teach Chinese at Elmhurst High School and North Side High School. We welcome them to FWCS and to Fort Wayne and thank them for the contribution they will make to our students this year.

RELATED INFORMATION: A public presentation of the proposed budgets and tax rates was made at the August 11, 2008 regular Board meeting. All legal requirements for advertisement and hearings have been met for all nine funds, the Capital Projects Plan, and the Bus Replacement Plan.

RESOLUTION 09-08-08 TO ADOPT THE YEAR 2009 BUS REPLACEMENT PLAN

This resolution is adopted by the Board of Trustees of Fort Wayne Community Schools of Allen County, Indiana:

WHEREAS, the Board of Trustees is required under I.C. 20-46-5-8 to adopt a plan with respect to a School Bus Replacement Plan; and

WHEREAS, the Board of Trustees held a public hearing on the plan on the 25th day of August 2008, at 6:00 pm in the Lester L. Grile Administrative Center,

THEREFORE, BE IT RESOLVED, by the Board of Trustees that the plan entitled School Bus Replacement Plan, for the years 2009 through 2020 is hereby incorporated by reference into this resolution and is adopted as the Board of Trustees' Plan with respect to the School Bus Replacement Plan.

BE IT FURTHER RESOLVED, that the Board of Trustees shall submit a certified copy of this resolution (including the adopted plan and the Calculation Worksheet) to the Department of Local Government Finance as required by IC 20-46-5-8 for approval.

RESOLUTION 09-08-08 TO ADOPT THE 2009 CAPITAL PROJECTS FUND PLAN

This resolution is adopted by the Board of School Trustees of The Fort Wayne Community Schools, Allen County, Indiana.

WHEREAS a School Capital Projects Fund has been established, and

WHEREAS, the Board of Trustees is required under I.C. 20-46-6-5 to adopt a plan with respect to the capital projects fund; and

WHEREAS, the Board of Trustees held a public hearing on the capital projects fund plan on the 25th day of August 2008 at 6:00 p.m. in the Lester L. Grile Administrative Center,

THEREFORE BE IT RESOLVED by the Board of Trustees that the plan for Fort Wayne Community Schools, for the years 2009 to 2011, is hereby incorporated by reference into this resolution, and is adopted as the Board of Trustees' plan with respect to the School Capital Projects Fund.

BE IT FURTHER RESOLVED that the Board of Trustees shall submit a certified copy of this resolution (including the adopted plan) to the Department of Local Government Finance as required by I.C. 20-40-8-8 for approval.

Levy Neutrality and Resolution **RECOMMENDATION**: It is recommended that the Board approve reductions in the Bus Replacement Fund and the Capital Projects Fund Plan to support the tax neutrality requirements of the Pension Bond.

RELATED INFORMATION: Public Law 199 requires that districts, who issue a pension bond to replace their retirement severance programs, must make the annual bond payment a tax neutral event to taxpayers. As a result, Fort Wayne Community Schools has chosen to reduce the levies in the Bus Replacement Fund and the Capital Projects Fund Plan. With this reduction the district will purchase eight fewer buses and will reduce its Capital Projects Fund Plan.

RESOLUTION SEPTEMBER 8, 2008 PENSION BOND FUND LEVY NEUTRALITY

This resolution is adopted by the Board of School Trustees of The Fort Wayne Community Schools, Allen County, Indiana.

WHEREAS the Pension Bond Fund expected levy of \$3,470,216 needs to be tax neutral. THEREFORE BE IT RESOLVED that the tax levies of Bus Replacement Fund and CPF will be reduced. It is expected that the tax levies will be reduced as follows:

CPF \$2,602,662 Bus Replacement 867,554

The Board further agrees that any levy greater than \$3,470,216 will be reduced from the Bus Replacement Fund.

Closing of Capital Projects in the CPF **RECOMMENDATION**: It is recommended that certain Capital Projects Fund (CPF) programs be closed. It is further recommended that the Board approve the resolution to reduce the attached list of CPF programs.

RELATED INFORMATION: CPF project appropriations expire either when they are spent or when the Board takes action to close the project. A project needs to be closed when the purpose for the appropriation has been achieved.

Unspent appropriations in projects that are completed and closed revert to the fund balance where they become available to be reappropriated for another project. The attached list of unspent appropriations will help fund the 2009 CPF plan.

Property Tax Levy Shortfall Appeal and Resolution **RECOMMENDATION**: It is recommended that the Board approve a resolution to petition the Department of Local Government Finance to levy additional property tax levy of \$1,310,412 to recover levy shortfalls.

RELATED INFORMATION: Indiana Code 20-45-6-5 provides for an increase in the property tax levy whenever the assessed valuation figures that were provided to and used by the school corporation to determine the property tax rate did not accurately reflect appeals filed by property owners.

The appeal process requires the Board of School Trustees to approve a resolution for a shortfall appeal. The School Property Tax Control Board makes an initial recommendation to the Department of Local Government Finance on the appeal, which has ultimate authority to decide the appeal.

RESOLUTION September 8, 2008 Petition to Appeal 2006 and 2007 Levy Shortfall

The Fort Wayne Community Schools, Allen County, State of Indiana, has determined that it needs authority to levy an additional property tax levy to recover a levy shortfall, pursuant to Indiana Code 20-45-6-5, as follows:

The governing body of said school corporation is hereby resolved to proceed with a petition for excess levies to the Department of Local Government Finance.

A motion was made by John Peirce, seconded by Kevin Brown, that the recommendations concerning the Budget Adoption and Resolutions; Levy Neutrality and Resolution; Closing of Capital Projects in the CPF; and Property Tax Levy Shortfall Appeal and Resolution be approved. Roll Call: Ayes, unanimous; nays, none.

Application for Common School Fund Loan Dr. Robinson presented the following recommendation concerning the Application for Common School Fund Loan:

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of advancement from the Indiana Common School Fund for educational technology equipment for 2008 in the amount of \$1,950,000.

RELATED INFORMATION: Advancements from the Common School Fund provide funds for school districts to purchase educational technology. The Fort Wayne Community Schools (FWCS) will use these moneys to help fund the FWCS technology plan previously submitted to the state. Technology funds are currently insufficient to fund all the technology needs of the school corporation.

Funds are provided as a loan and are awarded to school corporations on the basis of assessed value (AV) per pupil, with low AV per pupil school corporations receiving funds before high AV per pupil corporations. FWCS therefore cannot be assured of receiving the requested advancement.

Should the application be successful, funds will be budgeted in the Debt Service Fund to repay this loan beginning in the year 2010. Interest on the loan is expected to be no more than four percent and is likely to be as low as one percent.

Common School Fund advancements differ from School Technology Advancement Account (STAA) loans, which FWCS receives on an annual basis. Unlike CSF advancements, STAA advancements are given to all applying school corporations, regardless of their assessed value per pupil ranking.

A motion was made by John Peirce, seconded by Stephen Corona, that the recommendation concerning the Application for Common School Fund Loan be approved. Roll Call: Ayes, unanimous; nays, none.

1028 Public Hearing and Resolution Dr. Robinson presented the following recommendation concerning the 1028 Public Hearing and Resolution:

RECOMMENDATION: It is recommended that the Board hold a public hearing and adopt the resolution authorizing the installation of classroom technology at various Fort Wayne Community Schools buildings upon receipt of a Common School Fund loan.

RELATED INFORMATION: IC 20-26-7-37 requires that a public hearing be conducted for all building projects costing \$1,000,000 or more. This hearing has been properly advertised on August 23 and August 30, 2008. The hearing is scheduled for this evening's meeting of the Board of School Trustees. Following the hearing, the Board should take appropriate action on the attached resolution.

The intent of this hearing is to allow Board members the opportunity to receive public input and to consider the attached resolution.

This was the appropriate time for members of the public to address the Board regarding the 1028 Public Hearing and Resolution. No one spoke.

A motion was made by Mitch Sheppard, seconded by Kevin Brown, to close the hearing. Roll Call: Ayes, unanimous; nays, none.

The public hearing on the 1028 Public Hearing and Resolution was closed.

RESOLUTION SEPTEMBER 8, 2008 COMMON SCHOOL FUND LOAN

The Board of School Trustees of Fort Wayne Community Schools Corporation, Allen County, Indiana, met in the Lester L. Grile Administrative Center on September 8, 2008, pursuant to call, with members present, to conduct a public hearing pursuant to I.C. 20-26-7-37 and to consider the adoption of a resolution regarding the installation of classroom technology at various Fort Wayne Community Schools buildings. Proper notice by publication and explanations of the potential value of the proposed projects to the school corporation and to the community having been given, and interested parties having been heard concerning the proposed project, the following resolution was presented:

BE IT RESOLVED: That the Board of School Trustees of Fort Wayne Community Schools, Allen County, Indiana, has determined that a need exists for an expenditure of funds for the following project:

Installation of classroom technology at various Fort Wayne Community Schools buildings.

BE IT FURTHER RESOLVED: That the proposed construction and renovation will be done on land presently owned by Fort Wayne Community Schools Corporation, the estimated costs of the proposed projects are \$1,950,000, and the estimated completion date of the proposed project is October 2009.

BE IT FURTHER RESOLVED: That the proposed source of funding for the proposed project will be the Common School Fund loan pending approval from the Indiana State Board of Education.

BE IT FURTHER RESOLVED: That the proposed project will require an estimated \$.0138 of the Debt Service tax rate during the year 2010.

Duly adopted by the members of the Board of School Trustees of the Fort Wayne Community Schools Corporation.

A motion was made by Mitch Sheppard, seconded by Kevin Brown, that the recommendation concerning the 1028 Public Hearing and Resolution be approved. Roll Call: Ayes, unanimous; nays, none.

READ 180 Reading Intervention Dr. Robinson presented the following recommendation concerning the READ 180 Reading Intervention:

RECOMMENDATION: It is recommended that the Board approve a contract with Scholastic in the amount of \$157,250 for a technology-based reading intervention which was piloted in an elementary school during the 2007-2008 school year. The middle school version of the program was piloted in 2005-2007 and expanded to all middle schools in 2007-2008. Purchasing laws do not require competitive bidding when there is only one source for a product. Scholastic is the sole source provider for READ 180 products. The contract will be funded through Title I grant money. The following schools will be using the program: Fairfield, Forest Park, Indian Village, Maplewood, and Northcrest.

RELATED INFORMATION: READ 180 is a research-based reading intervention for students in grades 4-12 who are reading below grade level. It aligns with the district literacy models and provides one-to-one technology-based tutoring. Results in FWCS have averaged reading gains of 1 to 3 years when the student completes the READ 180 program as it is designed. The program includes specific coaching in techniques to enhance the reading process and multiple opportunities for students to practice their skills with independent level texts and track their progress. Detailed reports are provided to the student, the parent, and the teacher. From the reports provided by the program, teachers can continue to personalize instructional activities to support each student.

Extensive preparation has occurred to ensure that the necessary technology support will be in place and that students most in need of reading remediation will be scheduled into the program.

A motion was made by Mitch Sheppard, seconded by Kevin Brown, that the recommendation concerning the READ 180 Reading Intervention be approved. Roll Call: Ayes, unanimous; nays, none.

Group Health Plan Renewal Dr. Robinson presented the following recommendation concerning the Group Health Plan Renewal:

RECOMMENDATION: It is recommended that the Board renew the contract for the self-funded health insurance program with Anthem Blue Cross and Blue Shield effective October 1, 2008 through September 30, 2009.

It is recommended that the Board renew the contract for the self-funded dental and vision insurance for the non-teaching staff with Anthem Blue Cross and Blue Shield effective October 1, 2008 through September 30, 2009.

It is further recommended that the Board renew the fully-funded dental and vision insurance for teachers through ISTA Insurance Trust and Delta Dental effective October 1, 2008 through September 30, 2009.

RELATED INFORMATION: Anthem has provided a renewal that includes 2.0% increase in administrative fees for medical and prescription; a 3.0 % increase in dental fees; and, no increase in vision fees. Reinsurance premiums are increasing by 15.3%. The overall projected effect will be a 9.4% increase in fixed fees of about \$169,421.

The renewal rate for the teachers' dental plan which covers both fixed fees and claims costs is an increase of 6.0% or \$90,003.

The rate for the teachers' vision plan which covers both fixed fees and claims cost is projected to remain the same.

The state is still experiencing medical trends at 13% each year with Rx at 16%, dental at 7%, and vision at 6%.

A motion was made by Stephen Corona, seconded by Mitch Sheppard, that the recommendation concerning the Group Health Plan Renewal be approved. Roll Call: Ayes, unanimous; nays, none.

Anthony Wayne Rotary Donation

Dr. Robinson presented the following recommendation concerning the Anthony Wayne Rotary Donation:

RECOMMENDATION: It is recommended that the Board approve the \$5000.00 donation given to Indian Village School by the Anthony Wayne Rotary.

RELATED INFORMATION: Eight gentlemen from the Anthony Wayne Rotary greeted students at Indian Village on the first day of school. They donated dozens of shoe boxes full of school supplies. They also donated \$5000.00 to the school. The school staff has decided to purchase Functional Skills support materials as well as classroom books which support the core curriculum

A motion was made by Kevin Brown, seconded by John Peirce, that the recommendation concerning the Anthony Wayne Rotary Donation be approved. Roll Call: Ayes, unanimous; nays, none.

Motion to combine vote

Dr. Robinson presented the following recommendations concerning the 2008-2009 Grant Application Non-English Speaking Program and 2008-2009 Grant Application Title III: Language Instruction for Limited English Proficient and Immigrant Students:

2008-2009 Grant Application Non-English Speaking Program **RECOMMENDATION**: It is recommended that the Board approve the application for and acceptance of the Non-English Speaking Program grant for 2008-2009 in the amount of \$290,198.94 from the Office of English Language Learning and Migrant Programs of the Indiana Department of Education.

RELATED INFORMATION: The Non-English Speaking Program grant is state funding allocated based on the number of limited English proficient (LEP) students in Fort Wayne Community Schools during the 2007-2008 school year. Funds from this grant will allow for the continuation of a range of services for the district's English Language Learners (ELL) program. The funds in this year's grant are specifically designated for personnel (interpreters/translators and an ELL teacher coach), instructional materials, professional development, and translation services.

This non-competitive grant written by Emily Schwartz Keirns, ELL coordinator, supports advancement intended and outlined in the FWCS District Goal I: *Achieve and Maintain Academic Excellence* and Goal II: *Engage Parents and the Community*.

2008-2009 Grant Application Title III: Language Instruction for Limited English Proficient and Immigrant Students **RECOMMENDATION**: It is recommended that the Board approve the application for and acceptance of the Title III: Language Instruction for Limited English Proficient and Immigrant Students for 2008-2009 in the amount of \$255,600.00 from the Office of English Language Learning and Migrant Programs of the Indiana Department of Education.

RELATED INFORMATION: The Title III grant is federal funding allocated by the Indiana Department of Education based on the number of limited English proficient (LEP) students in Fort Wayne Community Schools during the 2006-2007 school year. Funds from this grant will allow for the continuation of a range of services for the district's English Language Learners (ELL) program. The funds in this year's grant are specifically designated for personnel (interpreters/translators and an ELL teacher coach), instructional materials, professional development, and translation services.

This non-competitive grant written by Emily Schwartz Keirns, ELL coordinator, supports advancement intended and outlined in the FWCS District Goals I: *Achieve and Maintain Academic Excellence* and Goal II: *Engage Parents and the Community*.

A motion was made by John Peirce, seconded by Stephen Corona, that the recommendations concerning the 2008-2009 Grant Application Non-English Speaking Program and the 2008-2009 Grant Application Title III: Language Instruction for Limited English Proficient and Immigrant Students be approved. Best Buy Teach Award Grant Dr. Robinson presented the following recommendation concerning the Best Buy Teach Award Grant:

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of the Best Buy Teach Award grant from Best Buy in the amount of \$5000 for Towles Intermediate School.

RELATED INFORMATION: The objective of this grant request is to purchase laptops to allow students to visit/interact through the Ball State University Interactive Electronic Field Trip Program. Students will study ecology by visiting Grand Teton National Park, Jackson Hole, Wyoming; encounter migration while going whale watching off the coast of Baja, California; and experience the civil rights movement by speaking directly to the surviving members of the "Little Rock Nine" at Little Rock, Arkansas' Central High School.

This program supports advancement intended and outlined in Goal 1: *Achieve and Maintain Academic Excellence*.
