Approval of Minutes – August 25, 2003

A motion was made by Jon J. Olinger, seconded by Carol J. Coen, that the minutes of the regular meeting of the Board of School Trustees held August 25, 2003, be approved. Roll Call: Ayes, unanimous; nays, none.

Vouchers

Dr. Wendy Robinson, superintendent, presented the vouchers for the period ending August 27, 2003, with the recommendation the vouchers be approved. A motion was made by Jon J. Olinger, seconded by Robert A. Armstrong, that the vouchers appearing in the listing numbered 03-17 be approved without exception. Roll Call: Ayes, unanimous; nays, none.

Arrival of Board Member

Carl A. Johnson arrived 7:07 pm

Dr. Robinson presented the following recommendation concerning the Budget Adoption:

Budget Adoption

RECOMMENDATION: It is recommended that the Board approve the proposed FWCS 2004 appropriations (budgets), the 2004 levies, the three-year Capital Projects Fund plan for 2004 through 2006, and the Bus Replacement Plan for the years 2004 to 2013. It is further recommended that the Board approve a New Facility Appeal for North Side High School and a 2003 budget reduction for the Transportation Fund.

RELATED INFORMATION: A public presentation of the proposed budgets and tax rates was made at the August 11, 2003 regular Board meeting. The budgets were advertised on August 12 and again on

August 19. A hearing to allow the public to make comments on the advertised budgets, the three-year Capital Projects Plan, and the ten-year Bus Replacement Plan was held on August 25, 2003. Legislation allows for an increase in the base levy to provide for the operational cost of new facilities. The attached petition to appeal allows for an increase of \$398,171 to cover one addition representing 117,054 square feet of new space at North Side High School.

The 2003 Transportation Fund is being reduced by \$363,000 because of the favorable insurance renewal rate. This reduction will help support the 2004 Transportation Fund.

All legal requirements for advertisement and hearings have been met for all seven tax-rated funds, the Capital Projects Plan, and the Bus Replacement Plan.

A motion was made by Carol J. Coen, seconded by Robert A. Armstrong, that the recommendation concerning the Budget Adoption be approved. Roll Call: Ayes, unanimous; nays, none.

Purchase of Property -Nebraska School Dr. Robinson presented the following recommendation concerning the Purchase of Property - Nebraska School:

RELATED INFORMATION: The current school site is significantly below the state minimum acreage recommendation. Funds are within budget.

A motion was made by Carol J. Coen, seconded by Robert A. Armstrong, that the recommendation concerning the Purchase of Property - Nebraska School be approved. Roll Call: Ayes, unanimous; nays, none.

Child Nutrition Reauthorization / Resolution Dr. Robinson presented the following recommendation concerning the Child Nutrition Reauthorization/Resolution:

RECOMMENDATION: It is recommended that the Board approve the Child Nutrition Reauthorization/Resolution to make nutritionally balanced meals more accessible to children of Fort Wayne families whose income is between 130% and 185% of the poverty level.

RELATED INFORMATION: Approval of this resolution will support the efforts of the State School Food Service Association, The National Association of School Boards and many others, to provide free lunches to children who currently qualify for reduced price meals.

This effort on our Board's part will result in increased funding to our district program, simplify the application process and provide meals at no cost to children of families who struggle daily to make ends meet.

Eliminating the reduced price school meal program is an idea whose time has come. Well nourished children learn more effectively. Further, eliminating the reduced fee would provide consistency with other federal programs and improve access to the program.

This recommendation supports advancement intended and outlined in Strategy III, Safe and Caring Environment and Strategy VI, Meaningful Relationships with Families.

A motion was made by Carol J. Coen, seconded by Geoff Paddock, that the recommendation concerning the Child Nutrition Reauthorization/Resolution be approved. Roll Call: Ayes, unanimous; nays, none.

Property Tax Levy Shortfall Appeal Dr. Robinson presented the following recommendation concerning the Property Tax Levy Shortfall Appeal:

RECOMMENDATION: It is recommended that the Board approve a resolution to petition the Department of Local Government Finance to levy additional property tax levy of \$905,869 to recover a 2002 levy shortfall.

RELATED INFORMATION: Indiana Code 6-1.1-19-4.7 provides for an increase in the property tax levy whenever the assessed valuation figures that were provided to and used by the school corporation to determine the property tax rate did not accurately reflect appeals filed by property owners.

The short fall was determined when only 98.6 percent of the December property tax settlement was received on December 30, 2002. The county auditor has stated that the shortfall resulted from property tax reduction appeals and corrections on reassessed properties, with the total amount of the shortfall for Fort Wayne Community Schools \$1,352,884 covering the seven tax-rated funds. We are only allowed to appeal the shortfall in the General Fund and Transportation Fund.

The appeal process requires the Board of School Trustees to approve a resolution for a shortfall appeal. The School Property Tax Control Board makes an initial recommendation to the Department of Local Government Finance on the appeal, which has ultimate authority to decide the appeal.

A motion was made by Robert A. Armstrong, seconded by Carl A. Johnson, that the recommendation concerning the Property Tax Levy Shortfall Appeal be approved. Roll Call: Ayes, unanimous; nays, none.

Recommendation to Extend School Bus Bid Dr. Robinson presented the following recommendation concerning the Recommendation to Extend School Bus Bid:

RECOMMENDATION: It is recommended that an award be made to extend the school bus bid opened in October 2001.

Midwest Transit Equipment of Indiana, Inc., Indianapolis, IN \$1,874,008.00

For 20 ea 84-Passenger Buses

4 ea 48-Passenger Buses

8 ea 24-Passenger Buses

The bid includes a quantity discount of \$2,000 per unit with the purchase of 27 or more units. The bid also includes a fair market value trade-in allowance of \$403,000.00 for 32 used buses.

RELATED INFORMATION: New emission standards from the Environmental Protection Agency began October 1, 2002. New bus engines increased approximately \$1,800.00. This increase is in addition to a general price increase of three percent. The bid extension will provide cost savings by retaining the current unit costs and the existing engines.

FWCS has experienced fewer problems and less recalls with the current model which ultimately represents less maintenance costs.

The bid is part of the scheduled replacement of the bus fleet. Funding for these purchases will be from the Transportation Fund.

A motion was made by Kurt A. Walborn, seconded by Jon J. Olinger, that the recommendation concerning the Recommendation to Extend School Bus Bid be approved. Roll Call: Ayes, unanimous; navs, none.

Dr. Robinson presented the following recommendation concerning the Title III Grant:

Title III Grant

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of funds from the Indiana Department of Education for Title III: Language Instruction for Limited English Proficient and Immigrant Students in the amount of \$157, 930.00.

RELATED INFORMATION: Title III is an entitlement grant and a source of funding provided to schools under the Elementary and Secondary Education Act (ESEA). The allocation is based upon enrollment of Limited English Proficient (LEP) students in the district. The grant supplements the general fund and provides for the following:

- Additional classroom assistance for existing ESL programs
- Additional translation services for non-English speaking students and their families
- Additional evaluator positions to determine the degree of language development support needed by each qualifying student
- Professional development for ESL teachers, non-ESL teachers, administrators, and parents of ESL students.

The grant addresses the advancement intended and outlined in Strategy I, Personally Appropriate Education; and Strategy V, Staff Effectiveness, and is submitted by Joanne Schafer, Curriculum Coordinator.

A motion was made by Robert A. Armstrong, seconded by Carol J. Coen, that the recommendation concerning the Title III Grant be approved. Roll Call: Ayes, unanimous; nays, none.
