2012-13 Teacher of the Year	<p>RECOMMENDATION: It is recommended that the Board recognize North Side High School teacher Edward King for being named the district’s Teacher of the Year.</p> <p>RELATED INFORMATION: Ed King is a music teacher and band director at North Side High School, a post he has held for 39 years, taking the Marching Redskins to state countless times and turning out numerous other award-winning musicians. Mr. King was selected as Teacher of the Year because of his inspiring dedication to students over the past four decades and his passion for working with students of all musical abilities.</p> <p>When asked to describe his philosophy of teaching during his interview as finalist for Teacher of the Year, he replied without hesitation, “I build relationships first, then memories that will last a lifetime.” Because his music classes are what he remembers most about his high school experience, he strives to pass that on to his students.</p> <p>In her letter of recommendation for Mr. King, Superintendent Dr. Wendy Robinson said, “Mr. King believes that the better musician he is, the better teacher he can be, which means continuously researching music theory, listening to the latest music and learning from other musicians and teachers. Healthy Lunchtime	<p>RECOMMENDATION: It is recommended that the Board recognize Weisser Park Elementary student Alex Aylward for becoming the Healthy Lunchtime Challenge winner from Indiana.</p> <p>RELATED INFORMATION: Alex submitted his dish for the Healthy Lunchtime Challenge. The Healthy Lunchtime Challenge invited families to create an original lunchtime recipe that is healthy, affordable and delicious, and follows the nutritional guidelines. Alex’s recipe was vegetable quinoa (keen-wah) salad with chicken. In July, Alex and his family learned that the recipe had been chosen as one of 54 to be included in a cookbook. The cookbook was published by Epicurious and is free to download. “We know all the winners want to share their favorite recipes, and that’s why we created this free cookbook,” Editor-in-Chief Tanya Steel stated. Alex and one of his parents were invited to the first-ever “kids state dinner” at the White House with other recipe winners and First Lady Michelle Obama.
