The Board of School Trustees of the Fort Wayne Community Schools met in regular session in the Lester L. Grile Administrative Center on Monday, September 22, 2005, at 7:04 p.m. President Carol J. Coen called the meeting to order with the following members in attendance:

Approval of Minutes – August 22, 2005 A motion was made by Robert A. Armstrong, seconded by Stephen Corona, that the minutes of the regular meeting of the Board of School Trustees held August 22, 2005, be approved. Roll Call: Ayes, unanimous; nays, none.

Vouchers

Dr. Robinson presented the vouchers for the period ending August 31, 2005, with the recommendation the vouchers be approved. A motion was made by Robert A. Armstrong, seconded by Stephen Corona, that the vouchers appearing in the listing numbered 05-16 be approved without exception. Roll Call: Ayes, unanimous; nays, none.

Dr. Robinson presented the following recommendation concerning the Budget Adoption:

Budget Adoption

**RECOMMENDATION**: It is recommended that the Board approve the proposed Fort Wayne Community Schools 2006 appropriations (budgets), the 2006 levies, the three-year Capital Projects Fund Plan for 2006 through 2008, and the Bus Replacement Plan for the years 2006 to 2015.

**RELATED INFORMATION**: A public presentation of the proposed budgets and tax rates was made at the August 8, 2005 regular Board meeting. The budgets were advertised on August 9 and again on August 16. A hearing to allow the public to make comments on the advertised budgets, the three-year Capital Projects Plan, and the ten-year Bus Replacement Plan was held on August 22, 2005. All legal requirements for advertisement and hearings have been met for all nine tax-rated funds, the Capital Projects Plan, and the Bus Replacement Plan.

### RESOLUTION 9-12-05 TO ADOPT A PLAN FOR A CAPITAL PROJECTS FUND

This resolution is adopted by the Board of School Trustees of The Fort Wayne Community Schools, Allen County, Indiana.

WHEREAS a Capital Projects Fund has been established, and

WHEREAS a governing body is required under I.C. 21-2-15 to adopt a plan with respect to the Capital Projects Fund, and

WHEREAS the governing body held a public hearing on the plan on August 22, 2005 at 7:00 p.m. in the Grile Center,

THEREFORE BE IT RESOLVED by the governing body that the plan entitled Fort Wayne Community Schools Capital Projects Fund 2006, 2007 and 2008 of September 12, 2005 is hereby incorporated by reference into this resolution, and is adopted as the governing body's plan with respect to the Capital Projects Fund.

BE IT FURTHER RESOLVED that the governing body will submit a certified copy of this resolution (including the adopted plan) to the Department of Local Government Finance under I.C. 21-2-15-6.

#### RESOLUTION 9-12-05 TO ADOPT THE YEAR 2006 BUS REPLACEMENT PLAN

The Board of Trustees of Fort Wayne Community Schools of Allen County, Indiana, hereby adopt the following resolution:

WHEREAS, a School Bus Replacement Plan has been established; and

WHEREAS, the Board of Trustees is required under I.C. 21-2-11.5-3.1 to adopt a plan with respect to a School Bus Replacement Plan; and

WHEREAS, the Board of Trustees held a public hearing on the plan on the 22nd day of August, 2005, at Lester L. Grile Administrative Center,

THEREFORE, BE IT RESOLVED, by the Board of Trustees that the plan entitled School Bus Replacement Plan, for the years 2006 through 2015 is hereby incorporated by reference into this resolution and is adopted as the Board of Trustees' plan.

BE IT FURTHER RESOLVED that the Board of Trustees shall submit a certified copy of this resolution and adopted plan, as required by statute, to the Department of Local Government Finance for approval.

A motion was made by Robert A. Armstrong, seconded by Stephen Corona, that the recommendation concerning the Budget Adoption be approved. Roll Call: Ayes, unanimous; nays, none.

Dr. Robinson presented the following recommendation concerning the Levy Neutrality:

Levy Neutrality

**RECOMMENDATION**: It is recommended that the Board approve reductions in the Bus Replacement Fund and the Capital Projects Fund Plan to support the tax neutrality requirements of the Pension Bond.

**RELATED INFORMATION**: Public Law 199 requires districts that issue a pension bond to replace their retirement severance programs, to make the annual bond payment a tax neutral event for taxpayers. As a result, Fort Wayne Community Schools has chosen to reduce the levies in the Bus Replacement Fund and the Capital Projects Fund Plan. With this reduction the district will purchase five fewer buses and will reduce its Capital Projects Fund Plan.

#### RESOLUTION 9-12-05 PENSION BOND FUND LEVY NEUTRALITY

This resolution is adopted by the Board of School Trustees of The Fort Wayne Community Schools, Allen County, Indiana.

WHEREAS the Pension Bond Fund expected levy of \$3,883,671 needs to be tax neutral.

THEREFORE BE IT RESOLVED that the tax levies of Bus Replacement Fund and CPF will be reduced. It is expected that the tax levies will be reduced as follows:

A motion was made by Kurt A. Walborn, seconded by Robert A. Armstrong, that the recommendation concerning the Levy Neutrality be approved. Roll Call: Ayes, unanimous; nays, none.

Closing of Capital Projects in the CPF Plan Dr. Robinson presented the following recommendation concerning the Closing of Capital Projects in the CPF Plan:

**RECOMMENDATION**: It is recommended that certain 2002 through 2003 Capital Projects Fund (CPF) programs be closed, except for the payment of encumbrances. The balances will be used to fund future CPF projects. It is further recommended that the Board approve the attached resolution to reduce the attached list of CPF programs.

**RELATED INFORMATION**: CPF project appropriations expire either when they are spent or when the Board takes action to close the project. A project needs to be closed when the purpose for the appropriation has been achieved.

Unspent appropriations in projects that are completed and closed revert to the fund balance where they become available to be reappropriated for another project. The attached list of unspent appropriations will help fund the 2006 CPF plan.

# FORT WAYNE COMMUNITY SCHOOLS Fort Wayne, Indiana REDUCTION OF CERTAIN 2002 and 2003 CAPITAL PROJECTS (RESOLUTION)

WHEREAS there is a need to reduce certain 2002 through 2003 Capital Projects Fund (CPF) projects,

WHEREAS such a reduction is necessary prior to reappropriation of unspent funds,

BE IT THEREFORE RESOLVED by the Board of School Trustees of the Fort Wayne Community Schools in Allen County, Indiana that the Capital Projects on the attached page be closed.

A motion was made by Robert A. Armstrong, seconded by Kurt A. Walborn, that the recommendation concerning the Closing of Capital Projects in the CPF Plan be approved. Roll Call: Ayes, unanimous; nays, none.

Dr. Robinson presented the following recommendation concerning the 1028 Public Hearing and Resolution on Building Projects:

**RECOMMENDATION**: It is recommended that the Board hold a public hearing and adopt the resolution authorizing the building project for Geyer Middle School.

**RELATED INFORMATION**: IC 20-5-52 requires that a public hearing be conducted for all building projects costing \$1,000,000 or more. The project listed above scheduled for 2005 is projected to exceed \$1,000,000. This hearing has been properly advertised on August 26 and September 2, 2005. The hearing is scheduled for this evening's meeting of the Board of School Trustees. Following the hearing, the Board should take appropriate action on the attached resolution. The description for each of these projects is outlined in the attached resolution.

The intent of this hearing was to allow Board members the opportunity to receive public input and to consider the attached resolution. This was the appropriate time for members of the public to address the Board. No one spoke.

#### FORT WAYNE COMMUNITY SCHOOLS

Fort Wayne, Indiana

The Board of School Trustees of Fort Wayne Community Schools Corporation, Allen County, Indiana, met in the Lester L. Grile Administrative Center on September 12, 2005, pursuant to call, with members present, to conduct a public hearing pursuant to I.C. 20-5-52 and to consider the adoption of a resolution regarding the construction and renovation of school facilities. Proper notice by publication and explanations of the potential value of the proposed projects to the school corporation and to the community having been given, and interested parties having been heard concerning the proposed project, the following resolution was presented:

1028 Public Hearing and Resolution on Building Projects BE IT RESOLVED: That the Board of School Trustees of Fort Wayne Community Schools, Allen County, Indiana, has determined that a need exists for an expenditure of funds for new construction and renovation of the facilities of Fort Wayne Community Schools to include the following project:

Proposed Project at Geyer Middle School (\$1,500,000) This renovation project will include enlarging classrooms and other modifications to accommodate the changes needed for a Montessori school.

BE IT FURTHER RESOLVED: That the proposed construction and renovation will be done on land presently owned by Fort Wayne Community Schools Corporation, the estimated costs of the proposed projects are \$1,500,000, and the estimated completion date of the proposed project is August 2006.

BE IT FURTHER RESOLVED: That the proposed source of funding for the proposed project will be the Capital Projects Fund.

BE IT FURTHER RESOLVED: That the proposed project will require an estimated \$.02 of the Capital Projects Fund tax rate during the year 2006.

A motion was made by Stephen Corona, seconded by Robert A. Armstrong, that the recommendation concerning the 1028 Public Hearing and Resolution on Building Projects be approved. Roll Call: Ayes, unanimous; nays, none.

Dr. Robinson presented the following recommendation concerning the Property Tax Levy Shortfall Appeal:

Property Tax Levy Shortfall Appeal **RECOMMENDATION**: It is recommended that the Board approve a resolution to petition the Department of Local Government Finance to levy additional property tax levy of \$2,042,725 to recover a 2004 levy shortfall.

It is also recommended that the Board approve a resolution to petition the Department of Local Government Finance to levy additional property tax levy to recover a 2005 levy shortfall, if any.

**RELATED INFORMATION**: Indiana Code 6-1.1-19-4.7 provides for an increase in the property tax levy whenever the assessed valuation figures that were provided to and used by the school corporation to determine the property tax rate did not accurately reflect appeals filed by property owners. The short fall was determined when only 97.2 percent of the December property tax settlement was received on December 30, 2004. The county auditor has stated that the shortfall resulted from property tax reduction appeals and corrections on reassessed properties, with the total amount of the shortfall for Fort Wayne Community Schools \$3,218,772 covering the seven tax-rated funds. We are only allowed to appeal the shortfall in the General Fund and Transportation Fund.

It is unknown whether Fort Wayne Community Schools will have a shortfall for the 2005 levy. The State will allow us to appeal the 2005 shortfall in 2006 once the tax distribution is received on December 30, 2005. We have advertised the 2006 levy high enough to cover a potential shortfall. The actual amount will be adjusted by the Department of Local Government Finance when the budget is certified.

The appeal process requires the Board of School Trustees to approve a resolution for a shortfall appeal. The School Property Tax Control Board makes an initial recommendation to the Department of Local Government Finance on the appeal, which has ultimate authority to decide the appeal.

**RELATED INFORMATION**: The objective of this grant request is to purchase audio visual equipment to create additional cable access programming for the purpose of positive school-community relationships through the creation of student-produced television programs. Activities will include: *The Cardinal News Now* – a daily news show broadcast to all Northwood students, 139@Northwood – a monthly episodes lasting 30 minutes containing student produced vignettes, and *Cardinal Knowledge* – a monthly program produced by the advanced TV class.

The contact person for this competitive grant is Todd Roberts, communication technology teacher, at Northwood Middle School. This program supports advancement intended and outlined in Strategy 4: *We will function as a center of learning in the community*.

**RECOMMENDATION:** It is recommended that the Board approve the application for and acceptance of special education grants in the amount of \$8,829,060.00 from the Indiana Department of Education for the school year 2005-2006.

**RELATED INFORMATION:** These non-competitive grants offset the cost of special education services provided through the Fort Wayne Community Schools. The reauthorized PL 108-446, IDEIA 2004 requires that after the base payment allocations are made, additional funding is awarded to each district based on public and private school enrollment within the FWCS jurisdiction and number of children living in poverty (National School Lunch Act participants).

For 2005-2006, the local education agency receives a base payment amount of \$7,898,490.00 under PL 108-446, Part B. The local education agency also receives preschool special education funding in the amount of \$298,840.00 under PL108-446, section 619. Funds support salaries and fringe benefits of approximately one hundred and fifty employees.

Under the provisions of IDEA–1997, a sub grant in the amount of \$101,730.00 is awarded to promote innovation and program development. This sub grant is used to provide support for students with autism and behavior issues.

A Discretionary Grant from the Division of Exceptional Learners Discretionary Grant is awarded to FWCS in the amount of \$530,000.00. Funds are used to support salaries and fringe benefits for the K-2 Project in fifteen schools.

These funds are used in support of FWCS Strategy 1: We will insure high levels of learning for all students.
