RECOMMENDATION: It is recommended that the Board recognize the students who were awarded the Benefit to the Community regional award in this year's national eCYBERMISSION competition.

RELATED INFORMATION: This U.S. Army-sponsored program is a web-based science, technology, engineering and mathematics (STEM) competition for students in grades six through nine that allows them to compete for awards while working to solve problems in their communities.

The Fort Wayne Community Schools Physitrition Heroes team from Memorial Park Middle School was recognized by judges for benefiting the community in its investigation to improve the nutrition and motor skills of children in the community. The students were successful in their hypothesis that dedicating time to educate children on the necessity of exercise and nutrition would yield healthier results. For this each student was awarded a \$2,000 U.S. EE savings bond. Also this past spring, this team was selected as a national semifinalist in the Christopher Columbus Awards science contest for middle school students.

RELATED INFORMATION: As a 7th grade Language Arts teacher at Northwood Middle School, Michelle White stands apart from her peers in her ability to successfully reach all learners through varied engagement strategies.

Now entering her sixth year of teaching, Mrs. White firmly believes that every student can learn and that it is her responsibility to ensure they grow not only academically but also socially, morally and emotionally to become successful and well-adjusted adults. She uses individual conferencing to reach all types of learners, giving assignments with multiple components followed by feedback after each part is complete. She also uses cooperative learning, pairing students up in different ways so they can learn from each other. A highlight of the year for her advanced students is writing a book and having it published.

In addition to her dedication in the classroom, Mrs. White leads the Sisterhood in the Wood, an extra-curricular group for Northwood girls that provides experiences and leadership opportunities with an emphasis on community service. Mrs. White successfully obtained a grant to support this popular and important program. Last year she was the Academic Team coordinator and a coach for Northwood, leading one of their teams to a top ten finish in the state this past year.

In her letter of recommendation for Mrs. White, Superintendent Dr. Wendy Robinson said, "Michelle White is transforming her students' lives through her exceptional dedication and skill in engaging students, both in the classroom and through extra-curricular activities."
