RECOMMENDATION: It was recommended that the Board recognize Liam Campbell-Carpenter and Henri Spoelhof for being selected to participate in the Indiana Jazz Educators Association's All-State Jazz Ensemble, Rhythm for 2020-21.

RELATED INFORMATION: Students from across Indiana auditioned in May at Butler University to be considered as part of the All-State Jazz Ensemble. These two North Side students will perform at the Indy Jazz Fest on September 18, 2021.

Teacher of the Year Finalists for 2021-22

RECOMMENDATION: It was recommended that the Board recognize the District's 2021-22 Teacher of the Year finalists.

RELATED INFORMATION: Each year, Fort Wayne Community Schools requests nominations from principals for the Teacher of the Year recognition. In the spring of 2021, FWCS received 49 applications and narrowed them down to 9 finalists who were then interviewed by the committee and 2 were chosen as the 2020-21 FWCS Teacher of the Year winners.

Finalists were formally recognized, via a video, for their hard work and dedication to the students of the District.

Emily Hull, special area teacher, Whitney Young Early Learning Center Felisa Davis-Stein, Pre-K teacher, Bloomingdale Elementary School Kelly Roberts-Syster, 3rd grade teacher, Weisser Park Elementary School Craig Fails, teacher, Snider High School James Graham, Automotive Instructor, FWCS Career Academy Karen Stath-Tracy, 7/8 Science Teacher, Northwood Middle School Kaylyn Speed, 7th grade science teacher, Lane Middle School

Teacher of the Year 2021-22 **RECOMMENDATION:** It was recommended that the Board recognize Waynedale Elementary School teacher Nikki Fultz and Towles Intermediate School teacher Tia McFarthing as the District's 2021-22 Teacher of the Year winners.

RELATED INFORMATION: In the spring of 2021, FWCS received 49 submissions from principals for the Teacher of the Year honor. After careful consideration, the Teacher of the Year committee narrowed down the nominations to 9 amazing finalists. After interviewing each finalist, the committee chose two as the 2021-22 Teacher of the Year winners.

The 2021-22 FWCS Elementary Teacher of the Year is Nikki Fultz, a fourth-grade teacher at Waynedale Elementary School. Ms. Fultz has taught for 15 years and has been with Indian Village for the past 10.

According to Waynedale Principal Kristee Hoffman, "Nikki is an incredible resource for not only our school, but the district and community of Fort Wayne. We are all grateful and blessed to have here at Waynedale Elementary." According to one of Nikki's fellow teachers, "Nikki is very humble. She works behind the scenes without wanting any recognition for all that she takes on."

The 2021-22 FWCS Secondary Teacher of the Year is Tia McFarthing, 7th Grade Language Arts Facilitator at Towles New Tech Intermediate School. Ms. McFarthing has taught for 9 years and has been at Towles for 8 years.

According to Towles Principal Jennifer Witzegruter, Ms. McFarthing "seeks to nurture growth in students beyond academics. She helps them find their strengths and assists them in improving areas of weakness. Tia's efforts ensure students' overall wellness is viewed as important as academic success. She forms lasting relationships with students and has many students who return each year to visit and share their successes with her."

Ms. Fultz and Ms. McFarthing, were congratulated as being a part of the District.

State Teacher of the Year Finalist 2022 **RECOMMENDATION**: It was recommended that the Board recognize Northrop High School teacher Lisa Clegg as a top 10 finalist for the state of Indiana Teacher of the Year.

RELATED INFORMATION: Lisa Clegg was chosen as the 2020 FWCS Secondary Teacher of the Year. While it is customary for the District to nominate our winners to the state Teacher of the Year process in the year they have won, the state chose not to conduct the search last year due to the pandemic. When submissions opened this year, we were informed that we were able to submit both our 2020 and 2021 winners.

Ms. Clegg, an English Language Learners teacher at Northrop High School has taught for 9 years and has been at Northrop for 3 years.

We learned in July that both Lisa Clegg and Tia McFarthing were chosen as part of the top 25 teachers in the state. In August we learned that Ms. Clegg had been chosen as part of the top 10 and was asked to conduct an interview with the state. Ms. Clegg was congratulated for this wonderful recognition of her efforts with her students.

The 2022 Indiana Teacher of the Year will be announced in October and the winner will also represent Indiana at the national level.

RELATED INFORMATION: The REACH Grant will fund school-based, year-round, after-school programs for Bloomingdale and Arlington elementary school students in partnership with the Boys and Girls Club of Fort Wayne. This program will have a focus on STEM and STEAM with College and Career program priority.

This grant is renewable for up to three years.

The completed REACH Grant application is available for public review, beginning on September 17, 2021, at the Grile Administrative Center.
