Roll Call

The Board of School Trustees of the Fort Wayne Community Schools met in regular session in the Lester L. Grile Administrative Center on Monday, September 13, 2004, at 7:04 p.m. President Carol J. Coen called the meeting to order with the following members in attendance:

Approval of Minutes – August 23, 2004 A motion was made by Kurt A. Walborn, seconded by Robert A. Armstrong, that the minutes of the regular meeting of the Board of School Trustees held August 23, 2004, be approved. Roll Call: Ayes, unanimous; nays, none.

Vouchers

Dr. Robinson presented the vouchers for the period ending September 1, 2004, with the recommendation the vouchers be approved. A motion was made by Robert A. Armstrong, seconded by Geoff Paddock, that the vouchers appearing in the listing numbered 04-16 be approved without exception. Roll Call: Ayes, unanimous; nays, none.

Dr. Robinson presented the following recommendation concerning the Budget Adoption:

Budget Adoption

RECOMMENDATION: It is recommended that the Board approve the proposed Fort Wayne Community Schools 2005 appropriations (budgets), the 2005 levies, the three-year Capital Projects Fund Plan for 2005 through 2007, and the Bus Replacement Plan for the years 2005 to 2014.

RELATED INFORMATION: A public presentation of the proposed budgets and tax rates was made at the August 9, 2005 regular Board meeting. The budgets were advertised on August 10 and again on August 17. A hearing to allow the public to make comments on the advertised budgets, the three-year Capital Projects Plan, and the ten-year Bus Replacement Plan was held on August 23, 2004. All legal requirements for advertisement and hearings have been met for all nine tax-rated funds, the Capital Projects Plan, and the Bus Replacement Plan.

Kathy Friend gave a brief overview of the budget.

RESOLUTION 9-13-04 TO ADOPT A PLAN FOR A CAPITAL PROJECTS FUND

This resolution is adopted by the Board of School Trustees of The Fort Wayne Community Schools, Allen County, Indiana.

WHEREAS a Capital Projects Fund has been established, and

WHEREAS a governing body is required under I.C. 21-2-15 to adopt a plan with respect to the Capital Projects Fund, and

WHEREAS the governing body held a public hearing on the plan on August 23, 2004 at 7:00 p.m. in the Grile Center.

THEREFORE BE IT RESOLVED by the governing body that the plan entitled Fort Wayne Community Schools Capital Projects Fund 2005, 2006 and 2007 of September 13, 2004 is hereby incorporated by reference into this resolution, and is adopted as the governing body's plan with respect to the Capital Projects Fund.

BE IT FURTHER RESOLVED that the governing body will submit a certified copy of this resolution (including the adopted plan) to the Department of Local Government Finance under I.C. 21-2-15-6.

RESOLUTION 9-13-04 TO ADOPT THE YEAR 2005 BUS REPLACEMENT PLAN

The Board of Trustees of Fort Wayne Community Schools of Allen County, Indiana, hereby adopts the following resolution:

WHEREAS, a School Bus Replacement Plan has been established; and

WHEREAS, the Board of Trustees is required under I.C. 21-2-11.5-3.1 to adopt a plan with respect to a School Bus Replacement Plan; and

WHEREAS, the Board of Trustees held a public hearing on the plan on the 23rd day of August, 2004, at Lester L. Grile Administrative Center,

THEREFORE, BE IT RESOLVED, by the Board of Trustees that the plan entitled School Bus Replacement Plan, for the years 2005 through 2014 is hereby incorporated by reference into this resolution and is adopted as the Board of Trustees' plan.

BE IT FURTHER RESOLVED, that the Board of Trustees shall submit a certified copy of this resolution and adopted plan, as required by statute, to the Department of Local Government Finance for approval.

A motion was made by Carl A. Johnson, seconded by Stephen Corona, that the recommendation concerning the Budget Adoption be approved. Roll Call: Ayes, unanimous; nays, none.

Pension Bond Budget and Levy Neutrality Dr. Robinson presented the following recommendation concerning the Pension Bond Budget and Levy Neutrality:

RECOMMENDATION: It is recommended that the Board allow the Pension Bond Fund appropriation of \$40,040,000 to remain in effect until fully spent. It is further recommended that the Board approve reductions in the Bus Replacement Fund and the Capital Projects Fund Plan to support the tax neutrality requirements of the Pension Bond.

RELATED INFORMATION: The proceeds of the bond have been received and deposits have been made to accounts for qualifying employees. As expected, the bond proceeds exceeded the deposits made due to employees who had left Fort Wayne Community Schools before the distribution. Those proceeds will remain in the Pension Bond Fund to be used for 403(b) match contributions until the funds are exhausted.

Public Law 199 requires that those districts that issue a pension bond to replace their retirement severance programs, must make the annual bond payment a tax neutral event to taxpayers. As a result, Fort Wayne Community Schools has chosen to reduce the levies in the Bus Replacement Fund and the Capital Projects Fund Plan. With this reduction the district will purchase five fewer buses and will reduce its Capital Projects Fund Plan.

RESOLUTION 9-13-04 PENSION FUND BOND

This resolution is adopted by the Board of School Trustees of The Fort Wayne Community Schools, Allen County, Indiana.

WHEREAS the Pension Bond Fund appropriation of \$40,040,000 will not be fully spent as of December 31, 2004.

THEREFORE BE IT RESOLVED that the appropriation will remain in the Pension Bond Fund until fully spent.

RESOLUTION 9-13-04 PENSION BOND FUND LEVY NEUTRALITY

This resolution is adopted by the Board of School Trustees of The Fort Wayne Community Schools, Allen County, Indiana.

WHEREAS the Pension Bond Fund expected levy of \$3,883,587 needs to be tax neutral.

THEREFORE BE IT RESOLVED that the tax levies of Bus Replacement Fund and CPF will be reduced. It is expected that the tax levies will be reduced as follows:

Bus Replacement \$431,000 CPF \$3,452,587

A motion was made by Kurt A. Walborn, seconded by Carl A. Johnson, that the recommendation concerning the Pension Bond Budget and Levy Neutrality be approved. Roll Call: Ayes, unanimous; nays, none.

Amendment to the 2004 Capital Projects Fund Plan Dr. Robinson presented the following recommendation concerning the Amendment to the 2004 Capital Projects Fund Plan:

RECOMMENDATION: It is recommended that the 2004 Capital Projects Fund Plan be amended to include the adjustments identified on the attached list and that the Board hold a hearing and adopt the attached resolution to modify the 2004 Capital Projects Fund Plan. It is further recommended that the Board rescind the April 26, 2004 amendment to the Capital Projects Fund Plan.

RELATED INFORMATION: The State of Indiana requires the Board to hold a hearing and pass a resolution authorizing any changes in the Capital Projects Fund Plan. Needed funding will come from reassigning revenue for the following proposed changes:

Multi-Building Project – These projects have now been identified. The monies are being moved into the individual projects listed below.

Kekionga Building Systems Replacement – This project is being increased to include replacement of boilers, unit ventilators, and temperature controls. Window wall replacement and ADA modifications will also be completed. Air conditioning will be bid as an alternate so that discussions can continue on this topic.

South Side Natatorium – Fort Wayne Community Schools will be able to add a project to construct an enclosure over the second-floor exterior deck to house the new dehumidification equipment. Rescind 2004 Capital Projects Fund Plan Amendment - The Board previously approved an amendment to the Capital Projects Fund Plan in order to allow the district to participate in the National School Fitness Foundation program. That program is now defunct and the funds will not be necessary.

HEARING:

As published in the local newspapers on August 30, and September 6, 2004, this meeting was the official hearing for the modification of the 2004 Capital Projects Fund Plan. This was the appropriate time for anyone interested in this resolution to address the Board. There were no comments from the public.

FORT WAYNE COMMUNITY SCHOOLS Fort Wayne, Indiana 2004 CAPITAL PROJECTS FUND AMENDMENT (RESOLUTION)

WHEREAS there is a need to make adjustments in 2004 capital projects,

WHEREAS an amendment to the 2004 Capital Projects Fund was advertised in accordance with applicable laws and the required hearing was held by the Board of School Trustees on September 13, 2004,

BE IT THEREFORE RESOLVED, by the Board of School Trustees of the Fort Wayne Community Schools in Allen County, Indiana that the 2004 Capital Projects Plan, first adopted by the Board on September 8, 2003, be amended as follows:

1028 Public Hearing and Resolution on Building Projects Dr. Robinson presented the following recommendation concerning the 1028 Public Hearing and Resolution on Building Projects:

RECOMMENDATION: It is recommended that the Board hold a public hearing and adopt the resolution authorizing the building project for Kekionga Middle School

RELATED INFORMATION: IC 20-5-52 requires that a public hearing be conducted for all building projects costing \$1,000,000 or more. The project listed above scheduled for 2004 is projected to exceed \$1,000,000. This hearing has been properly advertised on August 30 and September 6, 2004. The hearing is scheduled for this evening's meeting of the Board of School Trustees. Following the hearing, the Board should take appropriate action on the attached resolution. The description for each of these projects is outlined in the attached resolution.

The intent of the hearing was to allow Board members the opportunity to receive public input and to consider the attached resolution. This was the appropriate time for members of the public to address the Board. There were no comments from the public.

FORT WAYNE COMMUNITY SCHOOLS Fort Wayne, Indiana

The Board of School Trustees of Fort Wayne Community Schools Corporation, Allen County, Indiana, met in the Lester L. Grile Administrative Center on September 13, 2004, pursuant to call, with members present, to conduct a public hearing pursuant to I.C. 20-5-52 and to consider the adoption of a resolution regarding the construction and renovation of school facilities. Proper notice by publication and explanations of the potential value of the proposed projects to the school corporation and to the community having been given, and interested parties having been heard concerning the proposed project, the following resolution was presented:

BE IT RESOLVED: That the Board of School Trustees of Fort Wayne Community Schools, Allen County, Indiana, has determined that a need exists for an expenditure of funds for new construction and renovation of the facilities of Fort Wayne Community Schools to include the following project:

Proposed Project at Kekionga Middle School (\$2,967,402)

This is a mechanical renovation project that will include replacing unit ventilators, mechanical piping, air handling equipment, and plumbing fixtures. This project will also replace the school's windows and address any masonry restoration.

BE IT FURTHER RESOLVED: That the proposed construction and renovation will be done on land presently owned by Fort Wayne Community Schools Corporation, the estimated costs of the proposed project are \$2,967,402, and the estimated completion date of the proposed project is October 2005.

BE IT FURTHER RESOLVED: That the proposed source of funding for the proposed project will be the Capital Projects Fund.

BE IT FURTHER RESOLVED: That the proposed project will require an estimated \$.04 of the Capital Projects Fund tax rate during the year 2004.
