Roll Call The Board of School Trustees of the Fort Wayne Community Schools met in regular session in the Lester L. Approval of Minutes – September 8, 2008 A motion was made by John Peirce, seconded by Jon J. Olinger, that the minutes of the regular meeting of the Board of School Trustees held September 8, 2008, be approved. Roll Call: Ayes, unanimous; nays, none.

Dr. Wendy Robinson, superintendent, presented the following information and recommendations concerning awards and recognitions:

2009 Teacher of the Year **RECOMMENDATION:** It is recommended that the Board recognize Lakeside Middle School teacher Denise Oaks for being named the district’s Teacher of the Year and one of the 10 finalists for the state Teacher of the Year honor.

RELATED INFORMATION: As an 8th grade language arts and reading teacher at Lakeside Middle School, Denise Oaks has been an integral contributor to the successful improvement in student achievement at Lakeside, which made AYP last year. She helped accomplish this not only through her own outstanding classroom teaching, but also as a leader and support to other teachers.

Mrs. Oaks believes that each student is capable of learning and behaving within the proper classroom atmosphere and that it is her job to “make it happen” for each student. She makes it a priority to remember that every single face in her classroom comes with his or her own story, and she seeks to build a relationship with them and create a safe haven in her classroom.

Over the past several years, Mrs. Oaks worked closely with former Lakeside principal Carlton Mable to prepare the plan for Language Arts classes for the first and last 20 days of school. She did so by analyzing data and researching methodology for maximum success. She worked closely with Cultural Arts teachers to prepare a strong plan to ensure students are getting regular reading and writing practice across the curriculum. Last year, Mrs. Oaks went to a Special Education classroom once per week during her planning period to help them become better readers, writers and also to model lessons and teaching strategies for their teacher. This teacher is now implementing many of the strategies that she suggested.

In her letter of recommendation for Mrs. Oaks, Superintendent Dr. Wendy Robinson said, “She gives her students more than hope – she helps them believe that they can be successful, and therefore achieve results that will help them the rest of their lives.”

RELATED INFORMATION: Cash deficits in funds of the corporation are not allowed at the end of the fiscal year. It is anticipated several funds will have deficits due to a delay in the distribution of property taxes from Allen County. State statute allows temporary transfers between funds if certain requirements are met. The Treasurer will make all transfers necessary and report the loans to the Board.

Dr. Robinson presented the following recommendations concerning the Indiana Arts Commission Education Arts Program Grant, the IPFW Northeast Indiana Area Health Education Center Grant and the Reading is Fundamental Mini-Grants for Various Schools:

RECOMMENDATION: It is recommended that the Board approve the application and acceptance of the Indiana Arts Commission (IAC) Education Arts Program Grant totaling \$5,000.

RELATED INFORMATION: This new program was developed to help enrich the Arts curriculum, increase individual student engagement and interest, and continue to foster the long-term commitment to the Arts in schools.

Bloomington Elementary is partnering with the Fort Wayne Ballet (FWB). The approval of this grant will provide additional funds to purchase student books and the materials to create a large-scale art project that will be used by FWB in their spring presentation of *A Midsummer Night's Dream*.

This program supports FWCS district Goal I: *Achieve and Maintain Academic Excellence* and Goal II: *Engage Parents and the Community*.

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of the IPFW Northeast Indiana Area Health Education Center grant from Purdue University in the amount of \$7,140 for Miami Middle School.

RELATED INFORMATION: The objective of this non-competitive grant request is create an ASPIRE (Assisting Students in Pursuing and Reaping Excellence) club. Students will have weekly meetings with activities focusing in integrated science, technology, engineering, and mathematics (STEM) and/or health careers. Other activities will include family fun nights, IPFW Multicultural Day, College Visit Day, science fair competitions, etc.

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of Reading is Fundamental Mini-Grants funded by the Indiana Department of Education in the total amount of \$11,800.00.

RELATED INFORMATION: Five (5) elementary schools – Bloomingdale, Fairfield, Irwin, Study, and Weisser Park are requesting to participate.

The goal of the Reading is Fundamental Mini-Grants project is to promote recreational reading and home libraries for children who are at-risk. These mini-grants are designed to provide free paperback books to students, foster reading at home, and motivate students to develop a life-long love of reading.

Requested funds will be used for the implementation of programs that (1) enhance parent-student-school relationship by helping to promote a literate environment in the home; (2) support independent reading; (3) promote school-community partnerships; (4) give the students a sense of ownership; and (5) provide three distributions of personal books for individual students.

This competitive program supports advancement intended and outlined in Goal I: *Achieve and Maintain Academic Excellence.*
