RECOMMENDATION: It is recommended that the Board recognize Adams Elementary School Second-Grade Teacher Linda Shafer as the district's Teacher of the Year.

RELATED INFORMATION: Linda Shafer has been a second-grade teacher at Adams Elementary School for four years, having joined the school when major reforms were initiated. As a school where nearly all the students come from low-income households, there are many challenges and opportunities to help students succeed. Ms. Shafer has embraced those opportunities, becoming an integral contributor to improvements at Adams not only through her own outstanding classroom teaching, but also as a leader and supporter of other teachers. Ms. Shafer recently formed a foundation called Sparks of Promise, which will provide funding for enrichment opportunities for FWCS students who show high ability but need more support outside of school to reach their full potential. Sparks of Promise will begin with four fourth-graders who will participate in six six-week programs, including exposure to the ballet, STEM programs and other activities.

In her letter of recommendation for Linda Shafer, Superintendent Dr. Wendy Robinson said, "Students in Linda Shafer's second-grade classroom know their teacher believes in their success. She has seen her students make incredible gains and accomplishments because she told them they could do it. I am honored to have her on staff."

Amendment No. 5**

Paragraph 3A of the CONTRACT OF EMPLOYMENT between FORT WAYNE COMMUNITY SCHOOLS ("FWCS") and DR. WENDY Y. ROBINSON ("Superintendent"), dated November 23, 2009, is amended to read:

"3. Compensation and Benefits.

A. Base Salary/Performance Bonus. FWCS shall pay the Superintendent an annual base salary of \$210,164, beginning July 1, 2014, in twenty-six (26) equal installments. The parties may adjust the Superintendent's annual base salary, to be effective for the following contract year, and establish a one-time, lump-sum performance bonus payment, within ninety (90) days after the end of any contract year, by mutual written consent as an amendment to this Agreement. Absent such mutual agreement, the Superintendent's annual base salary shall remain unchanged for the next contract year. Any performance bonus payment for the school year 2014-15 and thereafter shall be based on the Superintendent Evaluation Plan adopted June 11, 2012, as amended. In addition, FWCS shall pay the Superintendent a one-time, lump-sum performance bonus payment, based on the Superintendent's performance during the 2013-14 school year, in the gross amount of \$12,489.75, subject to standard federal and state withholdings, on or before October 15, 2014."

IN WITNESS WHEREOF, FWCS, by its duly constituted officers and Board members, and the Superintendent, have executed this Amendment No. 5, effective the 22nd day of September, 2014.

2015 Budget
Report

Chief Financial Officer Kathy Friend presented a report that described the year 2015 budgets for the General Fund and the eight tax supported funds: Racial Balance, Capital Projects, Transportation, Bus Replacement, Debt Service, Referendum Debt, Pension Bond, and Museum of Art. The public budget hearings will be held on October 13, 2014. Board action is scheduled for these budgets on October 27, 2014.

Comments	<p>Board members thanked Kathy and her team for their work in educating the public on the finances of the district. Board members also thanked Kathy and the administrative team for working with legislators and keeping them updated of the needs of the district.</p> <p>Board member Steve Corona and other Board members expressed appreciation for the celebration to recognize district teachers. Mr. Corona was reminded of a teacher who made a difference in his life and is appreciative of the dedication of teachers.</p> <p>Board member Lisa Olinger expressed concern for Francis Mustapha, a retired FWCS biology teacher who has devoted his time after retirement to building the Madina Village School in Sierra Leone. The recent Ebola outbreak in Africa includes Sierra Leone and she wishes Mr. Mustapha safety in his work there.</p> <p>Superintendent Robinson reminded Board members of the Executive Session for training on Wednesday, September 23 at 10:30 a.m. at IPFW.</p> <p>Board member Julie Hollingsworth commented that it was good to meet with teachers, their families and members of the administration before the Board meeting in recognition of the important work that teachers do. Ms. Hollingsworth shared that the Indiana Education Insight reported that Indiana's revenue is up and Superintendent Glenda Ritz submitted ideas for the budget to include free textbooks for families and a 2-3% increase for teachers. Ms. Hollingsworth commented that an important item on her agenda is to have teacher salary schedules increased over the next year.</p>
