Dr. Thomas Fowler-Finn, superintendent, presented the following information and recommendations concerning awards and recognitions:

Recognition -
John Weicker

RECOMMENDATION: It is recommended that the Board recognize John Weicker, Director of Security, for receiving honors from the Fort Wayne Police Department.

RELATED INFORMATION: The Fort Wayne Police Department recently honored John Weicker, FWCS Director of Security, with a Citizen Service Citation for “repeatedly demonstrating support for the safety and welfare of our community.” He was recognized for his work over “many years, with countless officers, to enhance the safety of all students, faculty, and staff of the Fort Wayne Community School system.” Mr. Weicker was also instrumental in organizing the Allen County School Safety Commission, made up of representatives of public and private schools and city, county, and state safety officials. As the group’s first chairperson, Mr. Weicker directed such initiatives as a county-wide standard of posting numbers over all school entrances to assist first responders; and in bringing the Pierce Responder System to Fort Wayne – a computer program that allows safety officials to have immediate access to vital school information in times of emergencies.

RELATED INFORMATION: The Staff Spotlight program is the district’s method of recognizing employees for outstanding work and commitment to excellence. Tonight we honor Betty Plattner, who has been at Levan Scott Elementary School for the past 28 years. As a teacher’s assistant there, she continues to go above and beyond the call of duty every day – including initiating and organizing monthly instructional collaborations for all the teacher’s assistants at the school. A video highlighting her accomplishments was shown.

This program addresses advancement intended and outlined in Strategy V, Ensuring Staff Effectiveness; and Strategy VIII, Communicating that FWCS is an Excellent School System.

RELATED INFORMATION: At its August 26, 2002 meeting, the Board of School Trustees approved the 2003-2005 Capital Projects Plan. This plan includes physical plant improvements at various schools and support facilities, as well as the Northrop stadium, window projects at Lane and Weisser Park, and mechanical capital projects for the following buildings: Abbett, Forest Park, Maplewood, and Scott Academy.

Area administrators, principals, and Business Division personnel participate in the selection of architects for the major building projects. Facilities administrators select architects and engineers for the remaining projects based on the individual strengths of each of the firms. A total of eight local engineering and architectural firms are included in this recommendation.

The physical plant improvement project budgets are estimated because final amounts are not yet determined. Indiana law requires that projects over \$100,000 make use of a registered architect or a professional engineer for developing plans and specifications.

Project architects/engineers need to be appointed now to allow sufficient time for planning and bidding of projects to ensure completion during the summer of 2003.

A motion was made by Carol J. Coen, seconded by Jon J. Olinger, that the recommendation concerning the appointment of Project Architects for 2003 CPF Construction Projects be approved. Roll Call: Ayes, unanimous; nays, none.

Project Architect for North Side Renovation and Addition Project

Dr. Fowler-Finn presented the following recommendation regarding the appointment of Project Architect for North Side Renovation and Addition Project:

RECOMMENDATION: It is recommended that the Board approve the appointment of the firm SchenkelShultz as project architect for the North Side High School Renovation and Addition Project. The contract for architectural services for this project is \$1,998,000.00.

RELATED INFORMATION: SchenkelShultz was hired to do a second feasibility study for North Side High School. Because of their performance on the feasibility study and their extensive school experience, SchenkelShultz was selected to serve as architect for the project. Design work including construction documents and contract administration during the construction phase are part of the SchenkelShultz contract. The North Side Renovation and Addition Project includes renovating the existing facility, constructing new spaces, and developing the site.

Long-Term
Disability
Renewal

Dr. Fowler-Finn presented the following recommendation concerning Long-Term Disability Renewal:

RECOMMENDATION: It is recommended that the Board renew ReliaStar Life Insurance Company as the long-term disability carrier for a three-year term, effective October 1, 2002 through September 30, 2005.

RELATED INFORMATION: ReliaStar has provided Fort Wayne Community Schools' long-term disability coverage since September 1998. They have offered to renew the FWCS plan at a rate of \$.26 per \$100.00 of coverage with a three-year rate guarantee. This is a reduction of \$.03 per \$100 from the previous year.

Quotes were solicited from five other companies. One company declined to quote. ReliaStar provided the best quote along with the three-year guarantee.
