Relocation of One Special Education, PreK Classroom from Buschor HEAR Preschool to Washington Center School in School Year 2010-11

Dr. Robinson presented the following recommendation concerning the Relocation of One Special Education, PreK Classroom from Buschor HEAR Preschool to Washington Center School Year 2010-11:

RECOMMENDATION: It is recommended that the Board acknowledge and support the relocation of one Special Education, PreK Classroom from Buschor HEAR Preschool to Washington Center Elementary School beginning School Year 2010-11.

RELATED INFORMATION: During school year 2009-2010, Buschor HEAR Preschool had three classrooms with approximately 30 students per preschool session, for a total of approximately 60 students. The building was also used for walk-in therapies for occupational therapy and speech therapy. This student population was too big for the size of Buschor. Due to this overcrowding, it was recommended to the Elementary Area Office to look at moving one of the classrooms. It was decided that Washington Center Elementary School would provide placement for the new classroom which began in school year 2010-2011.

2013-14 Grant Application Title III: Language Instruction for Limited English Proficient and Immigrant Students

Dr. Robinson presented the following recommendation concerning the 2013-14 Grant Application Title III: Language Instruction for Limited English Proficient and Immigrant Students:

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of the Title III: Language Instruction for Limited English Proficient and Immigrant Students for 2013-14 in the amount of \$370,328.19 from the Office of English Learning and Migrant Programs of the Indiana Department of Education.

RELATED INFORMATION: The Title III grant is federal funding allocated annually by the Indiana Department of Education based on the number of limited English proficient (LEP) students in Fort Wayne Community Schools during the 2012-13 school year. Funds from this grant will allow for the continuation of a range of supplemental services for the district's English Language Learners (ELL) program. The funds in this year's grant are specifically designated for supplemental instructional materials and professional development.

This non-competitive grant written by Emily Schwartz Keirns, ELL coordinator, supports advancement intended and outlined in the FWCS District Goals I: *Achieve and Maintain Academic Excellence* and Goal II: *Engage Parents and the Community*.

The proposed Amendment No. 4 increases the Superintendent's base salary to \$192,150 effective July 1, 2013. The proposed Amendment No. 4 also authorizes the payment of a 2012-13 lump-sum incentive payment in the amount of \$9,000 on or before October 15, 2013.

Amendment No. 4

Paragraph 3A of the CONTRACT OF EMPLOYMENT between FORT WAYNE COMMUNITY SCHOOLS ("FWCS") and DR. WENDY Y. ROBINSON ("Superintendent"), dated November 23, 2009, is amended to read:

"3. Compensation and Benefits.

A. Base Salary/Performance Bonus. FWCS shall pay the Superintendent an annual base salary of \$192,150, beginning July 1, 2013, in twenty-six (26) equal installments. The parties may adjust the Superintendent's annual base salary, to be effective for the following contract year, and establish a one-time, lump-sum performance bonus payment, within ninety (90) days after the end of any contract year, by mutual written consent as an amendment to this Agreement. Absent such mutual agreement, the Superintendent's annual base salary shall remain unchanged for the next contract year. Any performance bonus payment for the school year 2013-14 and thereafter shall be based on the Superintendent Evaluation Plan adopted June 11, 2012, as amended. In addition, FWCS shall pay the Superintendent a one-time, lump-sum performance bonus payment, based on the Superintendent's performance during the 2012-13 school year, in the gross amount of \$9,000, subject to standard federal and state withholdings, on or before October 15, 2013."

IN WITNESS WHEREOF, FWCS, by its duly constituted officers and Board members, and the Superintendent, have executed this Amendment No. 4, effective the 23rd day of September, 2013.

Board attorney Tim McCaulay answered questions from Board members and provided information on the process for computation of the Superintendent's evaluation.

Board member Lisa Olinger commented that for the past three years we have not received from the State the data needed to complete the Superintendent's evaluation in a timely manner. We need to find a way to hold her accountable with information that is readily available to us.

Board member Stephen Corona agreed with Ms. Olinger that we can't rely on a third party for data. We need to create our own matrix or have a different timeline.

Board member Becky Hill commented that we have a bright leader and we are thankful she is here.
