#### OFFICIAL PROCEEDINGS

Roll Call

The Board of School Trustees of the Fort Wayne Community Schools met in regular session in the Lester L. Grile Administrative Center on Monday, September 24, 2007, at 6:05 p.m. Vice President Mark GiaQuinta called the meeting to order with the Pledge of Allegiance and the following members in attendance:

Approval of Minutes – September 10, 2007 A motion was made by Mitch Sheppard, seconded by Kevin Brown, that the minutes of the regular meeting of the Board of School Trustees held September 10, 2007, be approved. Roll Call: Ayes, unanimous; nays, none.

Vouchers

Dr. Robinson presented the vouchers for the period ending September 12, 2007, with the recommendation the vouchers be approved. A motion was made by Carol J. Coen, seconded by Kevin Brown, that the vouchers appearing in the listing numbered 07-18 be approved without exception. Roll Call: Ayes, unanimous; nays, none.

Dr. Robinson presented the following recommendation concerning the Board Compensation:

Board Compensation

**RECOMMENDATION**: It is recommended that the Board modify Board Policy 0144.1, Compensation. The second paragraph of the policy will be amended to delete: "*The maximum compensation, including basic and per diem compensation, shall not exceed five thousand dollars* (\$5,000) per Board member for any calendar year."

**RELATED INFORMATION**: Board compensation is set by law at a maximum of \$2000 basic annual compensation and a per diem tied to that for the Indianapolis School Commissioners. FWCS existing Board Policy has a \$5000 maximum cap, but there are more meetings planned this year than have occurred historically, and the cap will be insufficient to pay the per diem for all meetings without a change.

Policy 0144.1, Compensation (strikethrough sentence to be deleted)

Members of the Board shall be reimbursed for all approved expenses incurred in attending any meetings or in making any trips on official business for the School Corporation.

Effective January 1, 1990, members of the Board of School Trustees shall be eligible for compensation as provided for by statute (IC 20-3-11-2c) and as established by the Board of School Trustees (Board minutes January 8, 1990, page 3; and January 22, 1990, page 1). The basic annual compensation is \$2,000 payable monthly for services rendered (IC 20-5-3-6). In addition, a per diem rate shall be consistent with but not to exceed the rate approved for members of the Board of School Commissioners of the city of Indianapolis, Indiana, pursuant to the provision of IC 20-3-11-2(c). The per diem is allowed for attendance at each regular or special Board meeting, executive session or committee

meeting. The rate shall be governed by and shall change in accordance with the per diem rates adopted pursuant to IC 20-3-11-2(c) as in effect from time to time. The maximum compensation, including basic and per diem compensation, shall not exceed five thousand dollars (\$5,000) per Board member for any calendar year.

A motion was made by Kevin Brown, seconded by Pamela Martin-Diaz, that the recommendation concerning the Board Compensation be approved. Roll Call: Ayes, unanimous; nays, none.

Approval of Employee Salary Increases Dr. Robinson presented the following recommendation concerning the Approval of Employee Salary Increases:

**RECOMMENDATION**: It is recommended that the Board ratify revisions to the collective bargaining agreements and approve the 4% salary increase for calendar year 2008, the 2% salary increase for calendar year 2009, and the increase of .25% in the 401(a) match for Nurses Association, AFSCME Local 561 and Fort Wayne Classified Association. In addition, AFSCME has agreed to a one year contract extension.

**RELATED INFORMATION**: Nurses Association, AFSCME Local 561 and Fort Wayne Classified Association have agreed to amend their agreements to provide for the raise. In addition, the Nurses Association and the Fort Wayne Classified Association may re-open up to two (2) additional articles for bargaining.

A motion was made by Kevin Brown, seconded by Carol J. Coen, that the recommendation concerning the Approval of Employee Salary Increases be approved. Roll Call: Ayes, unanimous; nays, none.

Retro Pay from 2006 & 2007, and Salary Increase for Bus Drivers Dr. Robinson presented the following recommendation concerning the Retro Pay from 2006 & 2007, and Salary Increase for Bus Drivers:

**RECOMMENDATION**: It is recommended that the Board approve a salary increase for bus drivers at the rate of one and one-half percent (1.5%) salary increase for the 2006 calendar year and one percent (1%) salary increase for the 2007 calendar year. These retro salary increases will be applicable only for current employees. It is further recommended that the Board approve a four percent (4%) salary increase effective with the 2008 calendar year and a two percent (2%) salary increase effective with the 2009 calendar year, and an additional .25% for the district match to the 401(a) retirement accounts. These increases do not apply to the 50 cent lift certification premium.

**RELATED INFORMATION**: The contract with Teamsters Local #414 expired in December of 2005 and is no longer in effect. Teamster officials have said that they are not interested in additional negotiations, and they are under no legal obligation to negotiate. We therefore do not anticipate resolution of pay issues any time soon. The pay increases recommended are those granted to other employee groups based on the increases negotiated with the Fort Wayne Education Association (FWEA), and the district wants to recognize the work of this employee group by providing the increases they would have had since their contract expired.

**Speakers** 

Bus drivers Cecilia Curry and Yvonne Myers spoke to the Board about wanting the administration to bring the contract to the Board for a vote.

Brian Lytle and Walter Lytle, representing the Teamsters Local 414 asked the Board to vote upon the contract that was tentatively agreed to by the drivers. Both Brian and Walter indicated that the Teamsters will not return to the table to negotiate – they will go to court.

Board member Mark GiaQuinta commented about the history of the negotiations and that the Teamsters and FWCS need to go back to the table to settle differences. Because of an outburst from the audience, Mr. GiaQuinta called a short recess (less than a minute) then reconvened.

Board member Carol J. Coen commented that because no one would return to the table for negotiations, she would support the recommendation to give bus drivers back pay and future raises.

Dr. Robinson said that FWCS would go back to the table to negotiate anytime the Teamsters are ready.

A motion was made by Mitch Sheppard, seconded by Carol J. Coen, that the recommendation concerning the Retro Pay from 2006 & 2007, and Salary Increase for Bus Drivers be approved. Roll Call: Ayes, unanimous; nays, none.

Purchase of Property – Irwin Elementary School Dr. Robinson presented the following recommendation concerning the Purchase of Property – Irwin Elementary School:

**RECOMMENDATION**: It is recommended that the Board authorize the purchase of the following property located near Irwin School:

**RELATED INFORMATION**: The current school site is significantly below the state minimum acreage recommendation. Funds are within budget. Purchases of properties in this block will allow flexibility for the school to expand parking lots or playing fields or to accommodate the potential replacement of the building. The purchase price is the average of two appraisals.

A motion was made by Kevin Brown, seconded by Carol J. Coen, that the recommendation concerning the Purchase of Property – Irwin Elementary School be approved. Roll Call: Ayes, unanimous; nays, none.

Board Member Arrived

Board member Jon J. Olinger arrived at 6:44 p.m.

Dr. Robinson presented the following recommendation concerning the Bid Recommendation for Xerographic Paper, P/B #10000:

Bid Recommendation for Xerographic Paper, P/B #10000

**RECOMMENDATION**: It is recommended that an award be made to the lowest responsible and responsive bidder meeting specifications and quality standards.

Xpedx Fort Wayne, IN \$259,866.80

**RELATED INFORMATION**: This bid is for a supply of copy paper to be stocked in the warehouse. The largest portion of the bid is for 9680 cases of 8.5" x 11" white paper. All schools and central administrative units are served by this supply.

Invitations to Bid were sent to eight prospective bidders with three responding. Of these three, Bye-Mo'r, Incorporated, Kingsbury, IN did not meet bid specifications. Companies not responding with a bid were:

The prices of the recommended bidder reflect a six percent increase when compared to the last bid opened in October 2006.

A motion was made by Kevin Brown, seconded by Jon J. Olinger, that the recommendation concerning the Bid Recommendation for Xerographic Paper, P/B #10000 be approved. Roll Call: Ayes, unanimous; nays, none.

Resolution to Refinance 2003 North Side Bonds Dr. Robinson presented the following recommendation concerning the Resolution to Refinance 2003 North Side Bonds:

**RECOMMENDATION**: It is recommended that the Board approve a resolution to refinance the 2003 bonds of the North Side renovation project. It is further recommended that City Securities and Barnes & Thornburg are retained to serve respectively as underwriter and bond counsel.

**RELATED INFORMATION**: By refinancing a portion of the 2003 bonds, it is estimated that the district will save about \$460,000. The savings will be placed in a construction fund with the intent of providing additional funding for the 2008 Lakeside Middle School project.

# RESOLUTIONS OF BOARD OF SCHOOL TRUSTEES APPROVING AN AMENDMENT TO LEASE AND TAKING OTHER ACTIONS REGARDING FIRST MORTGAGE REFUNDING BONDS

WHEREAS, for the purpose of procuring funds to pay the cost of acquiring certain real estate, renovating, expanding and equipping the existing North Side High School, the North Side High School Building Corporation (the "Corporation") previously issued its First Mortgage Bonds, Series 2003 (the "2003 Bonds"), in the original aggregate principal amount of Forty-Nine Million Seven Hundred Fifty Thousand Dollars (\$49,750,000), pursuant to a Trust Indenture, dated as of February 15, 2003 (the "Original Indenture"), between the Corporation and The Bank of New York Trust Company, N.A. (successor to Bank One Trust Company, National Association), as trustee (the "Trustee"); and

WHEREAS, in connection with the issuance of the 2003 Bonds, the Corporation and the Fort Wayne Community Schools, Allen County, Indiana (the "School Corporation"), entered into a Lease, dated as of May 17, 2002 (the "Original Lease"), as amended from time to time, of [all/a portion of] the existing North Side High School and the real estate upon which such facilities are located all as described in the Original Lease (the "Leased Premises"); and

WHEREAS, Indiana Code 5-1-5, as amended, authorizes the refunding of all or a portion of the 2003 Bonds prior to such time as such 2003 Bonds are subject to redemption in order to effect a savings; and

WHEREAS, Section 4.01 of the Original Indenture provides the Corporation may redeem all or any part of the 2003 Bonds maturing on or after January 15, 2014, on any date not earlier than July 15, 2013, at a price equal to the aggregate principal amount, plus interest accrued to the date fixed for redemption, and without any redemption premium; and

WHEREAS, in accordance with Indiana Code 5-1-5, the Corporation desires to provide for the issuance of bonds to refund all or any portion of the 2003 Bonds, which are maturing on January 15, 2008, through and including January 15, 2018, and are currently outstanding in the aggregate principal amount of Forty-Five Million Six Hundred Sixty Thousand Dollars (\$45,660,000) (the "Refunded Bonds"), to effect a savings to the Corporation; and

WHEREAS, the Corporation intends to execute and issue its First Mortgage Refunding Bonds (with such additional series designation as determined at the time of issuance) in an aggregate principal amount not to exceed Twenty-Nine Million Nine Hundred Fifty Thousand Dollars (\$29,950,000)(the "Refunding Bonds"), in the form and subject to the terms provided in the First Supplemental Trust Indenture, dated as of the first or the fifteenth day of a month yet to be determined (the "First Supplemental Indenture")(the Original Indenture, as supplemented and amended by the First Supplemental Indenture, the "Indenture"), by and between the Corporation and the Trustee, in order to provide funds, together with funds of the Corporation on hand, to (a) advance refund all of the Refunded Bonds by depositing into an irrevocable escrow account an amount of funds and noncallable Government Obligations the principal of and interest on which when due will be sufficient to (i) pay all of the principal of and interest on the Refunded Bonds through the redemption date when due, and (ii) pay on the redemption date all of the principal of the Refunded Bonds maturing after the redemption date, (b) pay the costs of issuance of the Refunding Bonds including all the incidental expenses necessary to be incurred in connection with the issuance of the Refunding Bonds or on account thereof, and (c) reimburse the School Corporation for costs previously incurred by the School Corporation in connection with improvements made at the Leased Premises (clause (c) the "Prior Improvements"); and

WHEREAS, Indiana Code § 5-1-5-15 provides that, in connection with the issuance of refunding bonds, an issuing body and the lessee of any building, financed with the proceeds or obligations being refunded may enter into an amendment modifying or amending the provisions of such lease in one or more of the following respects: (i) to provide for a reduction in the amount of lease rental payable by the lessee; (ii) to provide for extensions or reductions of the time set forth in the lease before the option of the lessee to purchase may be exercised to such times as may be agreed upon by the issuing body and the lessee; or (iii) to provide that the lease rental payable by the lessee or lessees after redemption of the bonds being refunded may be payable to the trustee under a trust indenture securing such refunding bonds; and

WHEREAS, in accordance with Indiana Code § 5-1-5-15, the Board of School Trustees of the School Corporation (the "Board") now desires (i) to enter into an amendment to the Original Lease, as previously amended, if necessary, with the Corporation for the purpose of modifying or amending the provisions of the Original Lease, as previously amended, in one or more of the following respects: (a) to provide for a reduction in the amount of lease rental payable by the School Corporation; (b) to provide for extensions or reductions of the time set forth in the Original Lease, as previously amended, before the option of the School Corporation to purchase may be exercised to such times as may be agreed upon by the Corporation and the School Corporation; or (c) to provide that the lease rental payable by the lessee or lessees after redemption of the bonds being refunded may be payable to the trustee under a trust indenture securing such refunding bonds; (ii) approve the issuance of the Refunding Bonds, and (iii) authorize certain actions in connection therewith.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SCHOOL TRUSTEES OF THE FORT WAYNE COMMUNITY SCHOOLS, ALLEN COUNTY, INDIANA, AS FOLLOWS:

<u>SECTION 1</u>. The First Amendment to Lease Agreement between the Corporation, as lessor, and the School Corporation, as lessee (the "First Amendment to Lease"), in the form and substance acceptable to the President or any other officer of the Board, be, and hereby is, approved.

The President or any other officer of the Board be, and hereby is, authorized and directed to execute and deliver the First Amendment to Lease, with such changes to the form thereof as such officer deems necessary or advisable, in the name and on behalf of the School Corporation, and the Secretary or any other officer of the Board be, and hereby is, authorized and directed to attest such execution, and any such execution and delivery and any such attestation heretofore effected be, and hereby are, ratified and approved.

SECTION 2. The Continuing Disclosure Contract, dated as of the date the Refunding Bonds are issued (the "Undertaking"), executed by the School Corporation, in the form and substance acceptable to the President or any other officer of the Board be, and hereby is, approved.

If necessary, the President or any other officer of the Board be, and hereby is, authorized and directed to execute and deliver the Undertaking, with such changes to the form thereof as such officer deems necessary or advisable, in the name and on behalf of the School Corporation, and the Secretary or any other officer of the Board be, and hereby is, authorized and directed to attest such execution, and any such execution and delivery and any such attestation heretofore effected be, and hereby are, ratified and approved.

SECTION 3. The Preliminary Official Statement, in the form and substance acceptable to the President or any other officer of the Board (the "Preliminary Official Statement") be, and hereby is approved, with such changes as are approved by the President of the Board. The President is hereby authorized and directed, in the name and on behalf of the Board, to place the Preliminary Official Statement into final form as the Final Official Statement of the Corporation. The President is authorized to sign the Final Official Statement and by such signature approve its execution.

SECTION 4. The Board finds that the providing for the financing, refinancing, constructing and equipping of such school facilities by the Corporation and the leasing of same to the School Corporation is in the public interest of the citizens of the School Corporation, and all of the foregoing is a proper public purpose for which this Board agrees to cooperate with the Corporation.

<u>SECTION 5</u>. The issuance, sale and delivery by the Corporation of the Refunding Bonds under the Indenture in the aggregate principal amount not to exceed \$29,950,000, is hereby approved, so long as the issue and sale of the Refunding Bonds has been approved by the Superintendent of the School Corporation and generates cash able to reimburse the School Corporation for the Prior Improvements equal to at least \$460,000.

<u>SECTION 6</u>. Upon the redemption or retirement of the all Bonds issued under the Indenture, the School Corporation will accept from the Corporation title to such school facilities, free and clear of any and all liens and encumbrances thereon.

SECTION 7. The Bond Purchase Agreement, in the form and substance acceptable to the President or any other officer of the Board (the "Bond Purchase Agreement"), by and among the Corporation, the School Corporation and City Securities Corporation, as underwriter, be, and hereby is, approved. The President or any other officer of the School Corporation be, and hereby is, authorized and directed to execute and deliver the Bond Purchase Agreement, with such changes thereto as such officer deems necessary or advisable, in the name and on behalf of the School Corporation, and the Secretary or any officer of the School Corporation be, and hereby is, authorized and directed to attest such execution and delivery and any such execution and/or attestation heretofore effected be, and hereby are, ratified and approved.

<u>SECTION 8</u>. In connection with the issuance of the Refunding Bonds, the Board hereby hires (a) City Securities Corporation to serve as the underwriter for the Refunding Bonds, and (d) Barnes & Thornburg LLP to serve as bond counsel for the Corporation and the School Corporation, and authorizes the Superintendent of the School Corporation and other employees or officers of the School Corporation, as designated by the Superintendent, to work with all of the foregoing on matters as they deem necessary or desirable to effectuate these resolutions.

<u>SECTION 9</u>. Any officer of the School Corporation be, and hereby is, authorized and directed to execute and deliver such documents and take such other actions as such officer deems necessary or desirable to effect the foregoing resolutions, and any such documents heretofore executed and delivered and any such other actions heretofore taken be, and hereby are, ratified and approved.

School Technology Advancement Account Application

Dr. Robinson presented the following recommendation concerning the School Technology Advancement Account Application:

**RECOMMENDATION**: It is recommended that the Board approve the application for and the receipt of an advancement from the School Technology Advancement Account in the amount of \$637,500 for the 2007-2008 school year.

**RELATED INFORMATION**: The School Technology Advancement Account provides funds annually for school systems to purchase computer technology for student instruction. The Fort Wayne Community Schools uses these moneys to fund learning and technology plans of schools.

The request of \$637,500 is based on a guideline provided by the state of \$500 for each 25 students. Funds are provided in the form of a loan with a very low interest rate. The last loan under this program had an interest rate of 1 percent. Funds would be budgeted in the Debt Service Fund to repay this loan beginning in 2009.

A motion was made by Carol J. Coen, seconded by Kevin Brown, that the recommendation concerning the School Technology Advancement Account Application be approved. Roll Call: Ayes, unanimous; nays, none.

Non-English Speaking Program 2007-2008 Grant Application Dr. Robinson presented the following recommendation concerning the Non-English Speaking Program 2007-2008 Grant Application:

**RECOMMENDATION**: It is recommended that the Board approve the application for and acceptance of the Non-English Speaking Program grant for 2007-2008 in the amount of \$274,879.98 from the Division of Language Minority and Migrant Programs of the Indiana Department of Education.

**RELATED INFORMATION**: The Non-English Speaking Program grant is state funding based on the number of limited English proficient (LEP) students in Fort Wayne Community Schools during the 2006-2007 school year. Funds from this grant will allow for the continuation of a range of services for the district's English as a Second Language (ESL) program. The funds in this year's grant are specifically designated for teaching personnel, professional development, and translation services.

This non-competitive grant written by Emily Schwartz Keirns, ESL coordinator, supports advancement intended and outlined in the FWCS Strategic Plan, Strategy 1: We will ensure high levels of learning for all students, and Strategy 3: We will function as a professional learning community.

A motion was made by Kevin Brown, seconded by Jon J. Olinger, that the recommendation concerning the Non-English Speaking Program 2007-2008 Grant Application be approved. Roll Call: Ayes, unanimous; nays, none.

Dr. Robinson presented the following recommendation concerning the Title III: Language Instruction for Limited English Proficient and Immigrant Students 2007-2008 Grant Application:

**RECOMMENDATION**: It is recommended that the Board approve the application for and acceptance of the Title III: Language Instruction for Limited English Proficient and Immigrant Students grant for 2007-2008 in the amount of \$351,847.00 from the Division of Language Minority and Migrant Programs of the Indiana Department of Education.

Title III: Language Instruction for Limited English Proficient and Immigrant Students 2007-2008 Grant Application

**RELATED INFORMATION**: The Title III grant is federal funding allocated by the Indiana Department of Education based on the number of limited English proficient (LEP) students in Fort Wayne Community Schools during the 2005-2006 school year. Funds from this grant will allow for the continuation of a range of services for the district's English as a Second Language (ESL) program. The funds in this year's grant are specifically designated for personnel (ESL liaisons, ESL evaluators, and interpreters) and instructional materials.

This non-competitive grant written by Emily Schwartz Keirns, ESL coordinator, supports advancement intended and outlined in the FWCS Strategic Plan, Strategy 1: We will ensure high levels of learning for all students, and Strategy 4c: FWCS effectively communicates with staff, parents, community, and business leaders.

A motion was made by Jon J. Olinger, seconded by Carol J. Coen, that the recommendation concerning the Title III: Language Instruction for Limited English Proficient and Immigrant Students 2007-2008 Grant Application be approved. Roll Call: Ayes, unanimous; nays, none.
