Roll Call

The Board of School Trustees of the Fort Wayne Community Schools met in regular session in the Lester L. Grile Administrative Center on Monday, September 26, 2005, at 7:04 p.m. President Carol J. Coen called the meeting to order with the following members in attendance:

Approval of Minutes – September 12, 2005 A motion was made by Robert A. Armstrong, seconded by Kurt A. Walborn, that the minutes of the regular meeting of the Board of School Trustees held September 12, 2005, be approved. Roll Call: Ayes, Carol J. Coen, Robert A. Armstrong, Carl A. Johnson, Geoff Paddock and Kurt A. Walborn; nays, none; abstention, Jon J. Olinger.

Dr. Wendy Robinson, superintendent, presented the following information and recommendations concerning awards and recognitions:

FWCS Teacher of the Year – Theresa Lamping, Whitney Young Early Childhood Center

RECOMMENDATION: It is recommended that the Board recognize Teresa Lamping as Teacher of the Year for Fort Wayne Community Schools and a semifinalist for Indiana State Teacher of the Year.

RELATED INFORMATION: Teresa Lamping has been a teacher in FWCS since 1985. She is a preschool special education teacher at Whitney Young Early Childhood Center. At Young, she has been instrumental in implementing an inclusion process which allows preschool special-needs students to learn with their general-education preschool peers. The program, called "Give Them Wings," focuses on helping every student reach his or her developmentally appropriate goals through social, language, motor and cognitive skills.

Mrs. Lamping was named a semifinalist in the Indiana Teacher of the Year program and will be recognized with other teachers across the state on November 2 in Indianapolis.

A video presentation was shown highlighting her accomplishments followed by a special presentation from the superintendent.

IHSAA Role Model Recognition – Rodney Dedeaux and Russell Dedeaux, South Side High School **RECOMMENDATION**: It is recommended that the Board recognize twin brothers Rodney and Russell Dedeaux for their selection as Indiana High School Athletic Association Role Models.

RELATED INFORMATION: Rodney and Russell Dedeaux are seniors at South Side High School. The football players are among 114 student athletes from across the state selected to encourage their peers not to smoke or drink alcohol. The student athletes were nominated by their athletic director based on academic performance, community involvement and athletic success. Their images will be on posters and other promotional materials.

The Dedeaux brothers are active in the community and excel academically – Russell has a 3.7 gradepoint average and Rodney has a 3.5.

Food Service Center Project Dr. Robinson presented the following recommendation concerning the Food Service Center Project:

RECOMMENDATION: It is recommended that the Board approve a construction contract with Michael Kinder & Sons, Inc. for \$8,310,500 to construct a new Food Service Center. Michael Kinder & Sons, Inc.

RELATED INFORMATION: The current Food Service Center is located in the Catalpa Street service complex. It lies in a flood plain and currently does not meet food handling recommendations. Property owned by FWCS on Ludwig Road will be used to construct the new complex. The construction includes; warehousing of dry goods, packing materials, fruits and vegetables, as well as frozen foods. The building will house food preparation, packaging, shipping, and receiving areas. The Food and Nutrition Department will move from the Grile Administrative Center to the new building. Construction will incorporate the latest food safety and refrigeration recommendations as set forth by the governing agencies.

The project is being financed by a bond issue. This contract is within the budget set for the project. Completion is expected by August 4, 2006.

A motion was made by Jon J. Olinger, seconded by Kurt A. Walborn, that the recommendation concerning the Food Service Center Project be approved. Roll Call: Ayes, unanimous; nays, none.

Food Service Center Appropriation Dr. Robinson presented the following recommendation concerning the Food Service Center Appropriation:

RECOMMENDATION: It is recommended that the Board approve an appropriation in the amount of \$1,050,000 for the Food Service Center project. The appropriation includes the proceeds received for the existing center and any investment earnings thereon.

RELATED INFORMATION: Fort Wayne Community Schools Food Service Center Building Corporation entered into a lease with Fort Wayne Community Schools to finance the construction of a new food service center and to acquire the existing food service center. A portion of the Fort Wayne Community Schools Food Service Center Building Corporation bond issue is designated as the purchase price of the existing center. The price has been set at \$950,000. Those funds will be deposited into an account at Fort Wayne Community Schools and used to fund a portion of the construction costs. The remainder of the bond proceeds will be deposited with the bond trustee.

A motion was made by Carl A. Johnson, seconded by Geoff Paddock, that the recommendation concerning the Food Service Center Appropriation be approved. Roll Call: Ayes, unanimous; nays, none.

Long-Term Disability

Dr. Robinson presented the following recommendation concerning the Long-Term Disability:

RECOMMENDATION: It is recommended that the Board approve Reliance Standard Insurance Company as the long-term disability carrier for a three-year term, effective October 1, 2005 through September 30, 2008.

RELATED INFORMATION: A Request for Proposal was distributed in August resulting in competitive bids from three brokers that included quotes from more than 15 carriers. The lowest quote was provided by Reliance Standard through the Hylant Group.

Reliance Standard is domiciled in Illinois with headquarters in Philadelphia. They are rated "A-" by A.M. Best & Company, "A" by Fitch, and, "A" by Standard & Poors. Their bid was based on the schedules and policy provisions from the current contract. The three-year rate of \$.17 per \$100 of insured coverage represents a savings of 34.6% over the existing rate.

A number of the quotes provided were lower than the existing rate of \$.26 per \$100 of coverage including one from ReliaStar, the current provider, who quoted a rate of \$.175 per \$100 with a two-year rate guarantee.

The lower rate, length of the guarantee, and expanded administrative services offered by Reliance Standard through the Hylant Group are considered the best all-around package for both the district and its employees.

A motion was made by Robert A. Armstrong, seconded by Kurt A. Walborn, that the recommendation concerning the Long-Term Disability be approved. Roll Call: Ayes, unanimous; nays, none.

Employee Health Insurance Dr. Robinson presented the following recommendation concerning the Employee Health Insurance:

RECOMMENDATION: It is recommended that the Board renew the contract for the self-funded health insurance program with Anthem Blue Cross and Blue Shield effective October 1, 2005 through September 30, 2006.

It is further recommended that FWCS move the vision portion of the health plan for non-teaching staff only, to Anthem Blue Vision effective December 1, 2005.

RELATED INFORMATION: Anthem provided a renewal quote with a 13.6% increase in the fixed administrative fees and reinsurance premium.

Until the 2004/05 plan year, Anthem administered the vision portion of the group health plan for non-teaching staff through Vision Service Plan (VSP). A direct contract was established with VSP for the 2004/05 plan year due to the fact that Anthem ceased this connection with the establishment of its own vision network. For the 2005/06 plan year, Anthem has offered a rate that is 18% lower than the current VSP rate with a 3-year rate guarantee. In addition, their network has expanded over the past year to more than 70 local providers that include several large vendors such as Lenscrafters and Heartland Vision. To enable a smooth transition of services, the December 1, 2005, effective date is being recommended.

The teacher health insurance benefits were approved as part of contract ratification and will remain status quo with VSP remaining as their vision network.

RECOMMENDATION: It is recommended that the Board accept the field trip proposal for Northrop High School to compete in the "Rock the Boat with Festivals at Sea" with instrumentals and choirs across the nation April 3-8, 2006 (spring break) on Carnival Cruise Lines.

RELATED INFORMATION: The nationally acclaimed "Festivals at Sea" is again available on board all Carnival Cruise sailings for 2006. The performing groups will have the opportunity to enhance their cruise experience with an adjudicated performance and clinic on board the ship. The program will provide a nationally known instrumental, vocal, or dance adjudicator to clinic each group performance while providing written and taped evaluations for ratings based on a national standard. All festival programs also include commemorative awards for each festival performing group. There will be sixty (60) students participating with one (1) adult chaperone per eight (8) students.

Northrop teachers, Barry Ashton, Tom Maupin, and Jeanette Walsh, are responsible for the planning of this program. Barbara Ahlersmeyer is the principal.

Dr. Robinson presented the following recommendation concerning the Community Partners Program Grant – Whitney Young Early Childhood Center:

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of the Community Partners Program Grant from the Knight Foundation in the amount of \$405,000.00 for the Whitney Young Early Childhood Center (WYECC).

RELATED INFORMATION: This project, which is being funded by the John S. and James L. Knight Foundation, will focus on developing collaborative relationships between the staff of WYECC and early childhood educators/providers from community based programs in the southeast section of Fort Wayne by engaging them in multiple opportunities to explore the Reggio Emilia approach to early childhood education together.

The grades involved will be Pre-K and Kindergarten which consist of approximately 270 students. Staff and students from a minimum of five community based programs will participate in and be impacted by the grant activities.

WYECC Principal Diana Parker wrote this competitive grant which addresses Strategy 1: We will ensure high levels of learning for all students, and Strategy 4: We will function as a center of learning in the community, of the Strategic Plan.

A motion was made by Geoff Paddock, seconded by Robert A. Armstrong, that the recommendation concerning the Community Partners Program Grant – Whitney Young Early Childhood Center be approved. Roll Call: Ayes, unanimous; nays, none.

Title II Grants Dr. Robinson presented the following recommendation concerning the Title II Grants:

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of funds from the Indiana Department of Education for Title II, Part A and Title II, Part D grants in the amounts of \$1,498,713 and \$97,002 respectively.

RELATED INFORMATION: Title II funding is provided to schools under the Elementary and Secondary Education Act (ESEA). The allocation is based on enrollments for both public and private schools in the FWCS attendance area. An amount of \$78,830 has been allocated to serve identified private schools for Title II, Part A and \$20,472 has been allocated to serve identified private schools for Title II, Part D.

Title II is an entitlement grant provided to supplement the general fund. Monies from Title II, Part A will be used to reduce class size and provide teacher training in core academic subjects. Monies from Title II, Part D will be used to provide professional development and materials to enhance the use of instructional technology. Both portions of the grant are used for teachers of all grade levels.

These noncompetitive grants, Title II, Part A and Part D, are coordinated by Carol Kettler of School Improvement Services. These address advancement intended and outlined in Strategy 1, *We will ensure high levels of learning for all students*.

A motion was made by Robert A. Armstrong, seconded by Geoff Paddock, that the recommendation concerning the Title II Grants be approved. Roll Call: Ayes, unanimous; nays, none.

Title V Grant

Dr. Robinson presented the following recommendation concerning the Title V Grant:

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of funds from the Indiana Department of Education for Title V Innovative Programs in the amount of \$693,398.

RELATED INFORMATION: Title V funding is provided to schools under the Elementary and Secondary Education Act (ESEA). The allocation is based on enrollments for both public and private schools in the FWCS attendance area. An amount of \$144,073 has been allocated to serve identified private schools.

Title V is an entitlement grant provided to supplement the general fund. Monies from Title V will be used to support Reading Recovery and provide teacher training in the district instructional models in the core academic subjects.

This noncompetitive grant is coordinated by Carol Kettler of School Improvement Services. It addresses advancement intended and outlined in Strategy 1, *We will ensure high levels of learning for all students*.

A motion was made by Jon J. Olinger, seconded by Geoff Paddock, that the recommendation concerning the Title V Grant be approved. Roll Call: Ayes, unanimous; nays, none.

Bio-Diesel Fuel Grant

Dr. Robinson presented the following recommendation concerning the Bio-Diesel Fuel Grant:

RECOMMENDATION: It is recommended that the board approve the application for and the acceptance of a grant from the Indiana Lieutenant Governor's Office in the amount of \$50,000 to help fund the use of bio-diesel fuel in the FWCS school buses.

RELATED INFORMATION: Bio-diesel fuel consists of a mixture of 80% diesel fuel and 20% fuel derived from soy bean oil. The emissions are much less toxic than traditional diesel fuel. There are no mechanical changes necessary to the buses or the fuel storage tanks.

The two-year grant is intended to offset the difference in cost between regular fuel, and the cleaner burning bio-diesel. During the past two years the difference in price between the two has varied from 15 cents more per gallon to 4 cents less per gallon for the bio-diesel fuel. It is estimated that this difference in cost over the two-year period will average about 5 cents more per gallon, which would add about \$59,000 to our diesel fuel, leaving FWCS with only \$9,000 in additional fuel cost. Some studies report that using bio-diesel results in lower maintenance costs and better mileage ratings in vehicle fleets, thereby reducing the bottom line cost for using the fuel.

Fourteen school corporations and several transit systems, including CitiLink, have already converted to bio-diesel

A motion was made by Robert A. Armstrong, seconded by Geoff Paddock, that the recommendation concerning the Bio-Diesel Fuel Grant be approved. Roll Call: Ayes, Carol J. Coen, Robert A. Armstrong, Geoff Paddock, Kurt Walborn and Carl Johnson; nays, Jon J. Olinger. The motion passed.

American Association of University Women Trust Grant – Washington Elementary Dr. Robinson presented the following recommendation concerning the American Association of University Women Trust Grant – Washington Elementary:

RECOMMENDATION: It is recommended that the Board approve the application for and the acceptance of the American Association of University Women Trust grant in the amount of \$1,600 for Washington Elementary School.

RELATED INFORMATION: Funds from this grant will allow the school to purchase two sets of Suzuki Choir Chimes. This will provide students with opportunities to read music, learn assignment of tone bell positions, take care of instruments, learn self control/discipline, and perform music with instruments.

This competitive grant was written by Carolyn Campbell, music teacher at Washington, and addresses Strategy 1 of the Strategic Plan: We will ensure high levels of learning for all students.

A motion was made by Robert A. Armstrong, seconded by Kurt A. Walborn, that the recommendation concerning the American Association of University Women Trust Grant – Washington Elementary be approved. Roll Call: Ayes, unanimous; nays, none.

Allen County Education Partnership/ITT Industries Grant - Northrop High School Dr. Robinson presented the following recommendation concerning the Allen County Education Partnership/ITT Industries Grant – Northrop High School:

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of an Excellence in Education program grant from Allen County Education Partnership/ITT Industries in the amount of \$8,000.00 for Northrop High School.

RELATED INFORMATION: The purpose of this grant will be to introduce "inquiry" processes into *Integrated Chemistry-Physics 1 & 2* classrooms, at Northrop. "Inquiry" may be referred to as teaching and learning strategies that enable scientific concepts to be mastered through investigations. More than a simple hands-on approach it is meant to challenge and motivate students to learn science by using scientific "inquiry" to help them discover and overcome basic obstacles in learning.

Using specifically designed "inquiry" lessons, each student will identify and reinforce his/her own predominant learning style to develop scientific abilities as well as an understanding of science concepts. The program will involve the use of computers, voice recorders, digital cameras and other technological devices in classrooms of 25-30 students. Ninth grade *Integrated Chemistry Physics 1 & 2* classes, which include mainstreamed special education students, will be involved.
