RECOMMENDATION: It is recommended that the Board recognize Sweetwater for providing financial support to FWCS marching bands so they can participate in the annual Three Rivers Festival Parade.

RELATED INFORMATION: Several years ago, FWCS marching bands could not participate in the Three Rivers Festival Parade due to budget constraints. This was very disappointing to students, staff and our community. Starting in 2008, Sweetwater has made it possible for bands to participate in this popular community attraction by providing financial support. FWCS schools received \$5,000 in 2008, \$4,000 in 2009 and \$3,000 in 2010 from Sweetwater for its marching bands.
