RELATED INFORMATION: At its September 11, 2006 meeting, the Board of School Trustees approved the 2007-2009 Capital Projects Plan. RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of a grant in the amount of \$7,100.00 from the Allen County Education Partnership/ITT Industries Excellence in Education Award Program for Holland Elementary School.

RELATED INFORMATION: If awarded, monies would be used for a project entitled *Finding Your Way in the World of Technology – Using Global Positioning System (GPS) as a Tool and for Recreation*. Fourth and fifth grade students will be given an opportunity to learn about GPS, including how and why it works, and the uses of GPS in industry and for personal use. Students will also learn about geocaching – a recreational activity in which participants hide items (the cache), record the coordinates, and other participants set out to find the cache using GPS equipment.

This competitive grant written by Holland Principal Michael Caywood, and 5th grade Teacher/Thinking Skills Coach Sue Eikenberry supports advancement intended and outlined in Strategy 1: *We will ensure high levels of learning for all students.*
