OFFICIAL PROCEEDINGS

Roll Call

The Board of School Trustees of the Fort Wayne Community Schools met in regular session in the Lester L. Grile Administrative Center on Monday, October 11, 2004, at 7:05 p.m. President Carol J. Coen called the meeting to order with the following members in attendance:

Approval of Minutes – September 27, 2004 A motion was made by Jon J. Olinger, seconded by Robert A. Armstrong, that the minutes of the regular meeting of the Board of School Trustees held September 27, 2004, be approved. Roll Call: Ayes, unanimous; nays, none.

Dr. Wendy Robinson, superintendent, presented the following information and recommendations concerning awards and recognitions:

Staff Spotlight – Adrienne Shroyer, Guidance Counselor, Lane Middle School **RECOMMENDATION**: It is recommended that the Board recognize Adrienne Shroyer, a guidance counselor at Lane Middle School, for her contributions to the children and families of Fort Wayne Community Schools.

RELATED INFORMATION: The Staff Spotlight program is the district's method of recognizing employees for outstanding work and commitment to excellence.

We honored Adrienne Shroyer, who has been with FWCS for three years. As a guidance counselor, she is committed to building positive relationships with the students, staff and parents at Lane. A video highlighting her accomplishments was shown.

Vouchers

Dr. Robinson presented the vouchers for the period ending September 29, 2004, with the recommendation the vouchers be approved. A motion was made by Robert A. Armstrong, seconded by Kurt A. Walborn, that the vouchers appearing in the listing numbered 04-18 be approved without exception. Roll Call: Ayes, unanimous; nays, none.

Dr. Robinson presented the following recommendation concerning the Health Insurance:

Health Insurance

RECOMMENDATION: It is recommended that the Board renew the contract for the self-funded health insurance program with Anthem Blue Cross and Blue Shield effective October 1, 2004 through September 30, 2005. It is further recommended that FWCS retain VSP as a separate provider for the vision portion of the health plan.

RELATED INFORMATION: Anthem is no longer administering the VSP program so a direct contract will be established with VSP for the vision portion of the plan.

Anthem provided a renewal quote with an 8.6% increase in the fixed administrative fees.

The teacher health insurance benefits were approved as part of contract ratification and will remain status quo.

A motion was made by Geoff Paddock, seconded by Robert A. Armstrong, that the recommendation concerning the Health Insurance be approved. Roll Call: Ayes, unanimous; nays, none.

Gifted and Talented Grant Dr. Robinson presented the following recommendation concerning the Gifted and Talented Grant:

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of a Gifted and Talented Grant for 2004-2005 from the Indiana Department of Education in the amount of \$71,366.

RELATED INFORMATION: The state of Indiana provides non-competitive funds for districts to address the learning needs of high ability students. Funds for 2004-2005 will be used.

- To provide an appropriate education for identified high ability students, and
- To provide a special assignment facilitator to train teachers on the characteristics and educational needs of high ability students, and on strategies for educating such students within the classroom.

Currently, gifted and talented services are delivered through the efforts of classroom teachers and supported by Thinking Skills Coaches in every building. The overall program is coordinated by Connie Collins and Terri Rodgers in Curriculum Services.

The grant addresses advancement intended and outlined in Strategy 1, We will ensure high levels of learning for all students.

A motion was made by Jon J. Olinger, seconded by Kurt A. Walborn, that the recommendation concerning the Gifted and Talented Grant be approved. Roll Call: Ayes, unanimous; nays, none.

Title V Grant Dr. Robinson presented the following recommendation concerning the Title V Grant:

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of funds from the Indiana Department of Education for Title V Innovative Programs in the amount of \$809,282.

RELATED INFORMATION: Title V funding is provided to schools under the Elementary and Secondary Education Act (ESEA). The allocation is based on enrollments for both public and private schools in the FWCS attendance area. An amount of \$165,795 has been allocated to serve identified private schools.

Title V is an entitlement grant provided to supplement the general fund. Monies from Title V will be used to support Reading Recovery and provide teacher training in the district instructional models in the core academic subjects.

The grant is coordinated by Carol Kettler of Curriculum Services.

A motion was made by Robert A. Armstrong, seconded by Stephen Corona, that the recommendation concerning the Title V Grant be approved. Roll Call: Ayes, unanimous; nays, none.

Title II Grants

Dr. Robinson presented the following recommendation concerning the Title II Grants:

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of funds from the Indiana Department of Education for Title II, Part A and Title II, Part D grants in the amounts of \$1,250,937 and \$138,516 respectively.

RELATED INFORMATION: Title II funding is provided to schools under the Elementary and Secondary Education Act (ESEA). The allocation is based on enrollments for both public and private schools in the FWCS attendance area. An amount of \$67,750 has been allocated to serve identified private schools for Title II, Part A and \$26,170 has been allocated to serve identified private schools for Title II, Part D.

Title II is an entitlement grant provided to supplement the general fund. Monies from Title II, Part A will be used to reduce class size and provide teacher training in core academic subjects. Monies from Title II, Part D will be used to provide professional development and materials to enhance the use of instructional technology. Both portions of the grant are used for teachers of all grade levels.

Title II, Part A and Part D are coordinated by Carol Kettler of Curriculum Services.

A motion was made by Jon J. Olinger, seconded by Robert A. Armstrong, that the recommendation concerning the Title II Grants be approved. Roll Call: Ayes, unanimous; nays, none.

Dr. Robinson presented the following recommendation concerning the Stewart B. McKinney - Vento Homeless Assistance Grant:

Stewart B. McKinney -Vento Homeless Assistance Grant

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of a grant for \$28,000 through the McKinney -Vento Act Indiana Department of Education. These funds will be used to support the Fort Wayne Community Schools Homeless Assistance Program.

RELATED INFORMATION: Federal funding through the McKinney-Vento Act is one component of a program which would enable Fort Wayne Community Schools to provide assistance to students residing in shelters to continue their education. During the 2003-2004 school year approximately 300 FWCS students were assisted through the program from 12 shelters and facilities in the community.

The funds are distributed as grants by the Indiana Department of Education for local education agencies to establish educational programs which promote the identification, enrollment, attendance, and success of homeless children and youth in school and preschool. The request of \$28,000 will be used to provide tutorial, remediation, instructional materials and supplies, and other related services to Fort Wayne Community School's homeless children and their families.

This competitive grant was prepared by Jerry White, director of Student Services. The funds are used in support of Strategy 2, We will provide a positive culture for students and staff.

A motion was made by Geoff Paddock, seconded by Robert A. Armstrong, that the recommendation concerning the Stewart B. McKinney - Vento Homeless Assistance Grant be approved. Roll Call: Ayes, unanimous; nays, none.
