Dr. Wendy Robinson, superintendent, presented the following information and recommendations concerning awards and recognitions:

Theraplay Playground at Holland Elementary School Holland Elementary School is raising funds to build the Theraplay Center, which will provide the school's physically handicapped students access to playground equipment that offers both an opportunity to play outdoors and assist in physical therapy. The Theraplay Center will cost \$125,000, and \$82,500 has already been raised. This three minute video describes the project and highlights students who will benefit from it.

Holland's principal, Mike Caywood, was in attendance and spoke to the Board about the generosity of a past student's great aunt giving Holland a \$25,000 matching grant, and Sodexo's \$50,000 grant, as well as individual gifts.

RELATED INFORMATION: A public presentation of the proposed budgets and tax rates was made at the September 13, 2010 regular Board meeting. The budgets were advertised on August 30, and again on September 6, 2010. A hearing to allow the public to make comments on the advertised budgets was held on September 27, 2010. All legal requirements for advertisement and hearings have been met for all eight funds.

Levy Neutrality **RECOMMENDATION:** It is recommended that the Board approve reductions to the 2011 budgets of the Bus Replacement Fund, the Transportation Fund, and the Capital Projects Fund Plan to support the tax neutrality requirements of the Pension Bond.

RELATED INFORMATION: Public Law 199 requires that those districts, who issue a pension bond to replace their retirement severance programs, must make the annual bond payment a tax neutral event to taxpayers. As a result, Fort Wayne Community Schools has chosen to reduce the levies in the Bus Replacement Fund, the Transportation Fund, and the Capital Projects Fund Plan. With this reduction the district will purchase ten fewer buses and will reduce its Transportation Fund budget and the Capital Projects Fund Plan.

Goals for Expenditure Categories **RECOMMENDATION:** It is recommended that the Board approve a resolution to set expenditure category goals for the 2010-2011 school year. The goal is to strive to improve upon the current percentages between the expenditures for the student instructional categories and the other expenditure categories.

RELATED INFORMATION: Beginning with the 2007-2008 school year, school districts are required to establish goals for each category of expenditures that will increase the school corporation's allocation of taxpayer resources directly to student instruction and learning, in light of the unique circumstances present in the school corporation. The Department of Education reported the following percentages:

FWCS student instructional expenditures as a percent of the total were just .1 percent higher than the previous year. However, FWCS is 12.6 percentage points greater than the state average.

Board member Pamela Martin-Diaz commented about another United Way and Learn United women's initiative for area volunteers to read at early childhood centers.

Board members Pamela Martin-Diaz and Mark GiaQuinta commented on the remarkable area high school band competitions.

Board member Becky Hill commented on Grandparents Day at Bunche and Towles and the large number of grandparents that participated.

Board President Mark GiaQuinta congratulated Jennifer Hufer from Harris Elementary and Amy Strine from Croninger Elementary for being named to the *Journal Gazette*'s Teacher Honor Roll. President GiaQuinta also remarked that both the *Journal Gazette* and *News Sentinel* did a great job explaining AYP.
