Dr. Wendy Robinson, superintendent, presented the following information and recommendations concerning awards and recognitions:

Clean School Awards – Gold Standard Winners **RECOMMENDATION:** It is recommended that the Board recognize FWCS schools with the highest-ranking scores on inspections of building maintenance and cleanliness for the 2007-2008 school year.

RELATED INFORMATION: Ensuring high standards of cleanliness and maintenance of FWCS buildings and grounds is a top priority for the Maintenance and Operations Department. RELATED INFORMATION: Each year the Indiana State Teachers Association selects two minority members for the Outstanding Minority Award. Winners are nominated by association members and selected by the Minority Affairs Committee. The winners will be honored at the association's Fall Representative Assembly on Oct. 25 in Indianapolis. Alanna Oatts, one of this year's winners, was the FWCS Teacher of the Year and a top ten state finalist in 2008.

RECOMMENDATION: It is recommended that the Board recognize Nebraska Elementary School and Lane Middle School for being selected as 2008-09 "Pocket of Excellence" schools by the Indiana Department of Education. It is also recommended that the Board approve the acceptance of the Indiana State Improvement Grant in the amount of \$25,000 for each school.

RELATED INFORMATION: "Pocket of Excellence" schools were chosen by the Indiana Department of Education based upon progress that they have achieved over the past five years. Selection criteria included school leadership, use of evidence-based instructional strategies, school behavior plans that reduce suspension and expulsion, student achievement data showing an upward trend in test scores, including scores for students with special needs, and a demonstrated commitment to strengthening family, school and community partnerships. Nebraska and Lane were among only 16 schools in Indiana honored with this award. Both schools will receive new federal grants to continue their work in raising achievement for all students. In addition, both schools have been awarded a \$25,000 grant to assist with professional development, expenses related to demonstration of their successes at different schools, and materials to support student achievement.

RECOMMENDATION: It is recommended that the Board recognize students who were named semi-finalist and commended students in the National Merit Scholarship and National Achievement competitions and the student who earned a perfect score on the ACT exam.

RELATED INFORMATION: Each year, the College Entrance Examination Board recognizes exceptional students from the more than one million students who take the Preliminary SAT/National Merit Scholarship Qualifying Test in their junior year. Students were also selected based on academic performance.

One FWCS student was named National Merit Semi-Finalist, and three FWCS students were named National Merit Commended.

The National Achievement Scholarship Program is an academic competition for African-American students. One FWCS student was recognized as a Semi-Finalist and one student was named Outstanding Participant.

The ACT is a college entrance exam consisting of tests in English, mathematics, reading and science. Each test is scored on a scale of 1-36, and a student's composite score is the average of the four test scores. One FWCS student was one of only four college-bound students in Indiana and 162 nationwide to earn a perfect score of 36.

Dr. Robinson presented the following recommendation concerning the Allen County Education Partnership / ITT Excellence in Education Award:

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of the Allen County Education Partnership grants in partnership with ITT Communications Systems for the "Excellence in Education Award" program in the total amount of \$16,000 for Franke Park Elementary School (Franke Park) and Towles Intermediate School (Towles).

RELATED INFORMATION: Franke Park's \$8,000 award will be used to get Kindergarten students excited about science and math by working with their 4th grade buddies to create multimedia projects. Students would complete experiments to find their own answers by conducting research using modern technology purchased through this grant. Completed projects can then be shared with the child's family. The contact people for this competitive grant are Franke Park's principal, James Emmerson, and kindergarten teacher, Donna Ashcroft.

Towles' \$8,000 award will be used to purchase six to eight laptop computers to help facilitate the Ball State Electronic Fieldtrip Program. The program's focus will be kids using technology to learn standards based curriculum through interactive web-fieldtrips. The contact people for this competitive grant are Towles' principal, Tammy Lake, and 4-6 multi-aged teacher, Mark McCrory.

These programs support advancement intended and outlined in Strategy 1: *We will ensure high levels of learning for all students.*
