The Board of School Trustees of the Fort Wayne Community Schools met in regular session in the Lester L. Grile Administrative Center on Monday, October 22, 2007, at 6:03 p.m. President Stephen Corona called the meeting to order with the Pledge of Allegiance and the following members in attendance:

Approval of Minutes – October 8, 2007

A motion was made by Mitch Sheppard, seconded by Kevin Brown, that the minutes of the regular meeting of the Board of School Trustees held October 8, 2007, be approved. Roll Call: Ayes, unanimous; nays, none.

Dr. Wendy Robinson, superintendent, presented the following information and recommendations concerning awards and recognitions:

International Spanish Academies Program – Lindley Elementary School **RECOMMENDATION**: It is recommended that the Board recognize Lindley Elementary School for being accepted into the International Spanish Academies Program.

**RELATED INFORMATION**: Lindley Elementary School has been invited to join the International Spanish Academies Program, a prestigious program partnering schools with the Ministry of Education and Science in Spain. The program is made up of top-performing Spanish Immersion schools throughout the United States and Canada.

Lindley was recommended for the honor by the Indiana Department of Education earlier this year. After having an on-site inspection by a representative of the Spanish government and completing a detailed report of its program, the school is being recognized for its effort to help children to become bilingual in English and Spanish.

Lindley is one of only three public Spanish Immersion schools in Indiana and the only one in northern Indiana. It is unique in that Lindley is in an urban school district serving a racially and socioeconomically diverse population and has no academic restrictions on who can attend.

The official incorporation of Lindley into the International Spanish Academies will take place during the annual seminar Nov. 28-30 in Los Angeles. Principal Gerald Arthur will attend the conference and meet educators from other ISA schools.

**RECOMMENDATION**: It is recommended that the Board appoint the following members to the FWCS Common Wage Committee:

Michael Stetler, representing industry Darrell Jaggers, a taxpayer in the FWCS district

**RELATED INFORMATION**: Each year FWCS conducts a Common Wage hearing to determine the most common wage for each class of work. The common wage determines the minimum wage to be paid on upcoming FWCS construction projects.

By statute, there are five members of the Common Wage Committee. Three appointments are external, including one representing labor, one named by the Governor, and one appointed by the County. Two members are appointed by FWCS, one representing industry and one taxpayer in our district.

The Common Wage hearing is set for November 13 at 11 a.m. in the board room at the Grile Administrative Building.

## Title II, Part A Grant

Dr. Robinson presented the following recommendation concerning the Title II, Part A Grant:

**RECOMMENDATION**: It is recommended that the Board approve the application for and acceptance of funds from the Indiana Department of Education for Title II, Part A grant in the amount of \$2,002,762.00.

**RELATED INFORMATION**: Title II funding is provided to schools under the Elementary and Secondary Education Act (ESEA). The allocation is based on enrollments for both public and private schools in the FWCS attendance area. An amount of \$158,248.00 has been allocated to serve identified private schools for Title II, Part A.

Title II is an entitlement grant provided to supplement the general fund. Monies from Title II, Part A will be used to reduce class size and provide teacher training in core academic subjects. The grant is used for teachers of all grade levels.

This noncompetitive grant is coordinated by Linda Roman of Professional Development and addresses advancement intended and outlined in Strategy 1: We will ensure high levels of learning for all students.

A motion was made by Carol J. Coen, seconded by Kevin Brown, that the recommendation concerning the Title II, Part A Grant be approved. Roll Call: Ayes, unanimous; nays, none.

## Title IV Safe and Drug Free Grant

Dr. Robinson presented the following recommendation concerning the Title IV Safe and Drug Free Grant:

**RECOMMENTATION**: It is recommended that the Board approve the application for and acceptance of the Title IV Safe and Drug Free Schools and Communities Grant from the Indiana Department of Education in the amount of \$192,975.30 of which \$30,288.90 will go to non-public schools.

**RELATED INFORMATION**: Title IV funding is provided to schools under the Elementary and Secondary Education Act (ESEA). The allocation is based on enrollments for both public and non-public schools in the FWCS attendance area.

This Title IV grant is an entitlement grant provided to supplement the general fund. Monies from Title IV will be used to provide an interactive program that instructs students about thinking patterns and how thinking errors can lead to irresponsible behavior. Lifeline, Inc. (Center for Responsible Thinking), a non-profit organization, will work with students that have been assigned to an alternative program from Fort Wayne Community Schools.

Charles Green, Director Academic Support, is the coordinator of this non-competitive grant. Funds are used in support of FWCS Strategy 2: We will provide a positive culture for students and staff.

A motion was made by Kevin Brown, seconded by Mitch Sheppard, that the recommendation concerning the Title IV Safe and Drug Free Grant be approved. Roll Call: Ayes, unanimous; nays, none.

#### Title V Grant

Dr. Robinson presented the following recommendation concerning the Title V Grant:

**RECOMMENDATION**: It is recommended that the Board approve the application for and acceptance of funds from the Indiana Department of Education Title V Innovative Programs in the amount of \$67,087.00

**RELATED INFORMATION**: Title V funding is provided to schools under the Elementary and Secondary Education Act (ESEA). The allocation is based on enrollment for both public and private schools in the FWCS attendance area. An amount of \$14,787.36 has been allocated to serve identified private schools.

Title V is an entitlement grant provided to supplement the general fund. Monies from Title V will be used to support research-based interventions in the FWCS Pyramid of Interventions.

This noncompetitive grant is coordinated by Schauna Findlay Director of Curriculum Services. It addresses advancement intended and outlined in Strategy 1: We will ensure high levels of learning for all students.

A motion was made by Jon J. Olinger, seconded by Carol J. Coen, that the recommendation concerning the Title V Grant be approved. Roll Call: Ayes, unanimous; nays, none.
