Roll Call

The Board of School Trustees of the Fort Wayne Community Schools met in regular session in the Lester L. Grile Administrative Center on Monday, October 23, 2006, at 7:07 p.m. President Geoff Paddock called the meeting to order with the following members in attendance:

Approval of Minutes – October 9, 2006

A motion was made by Stephen Corona, seconded by Jon J. Olinger, that the minutes of the regular meeting of the Board of School Trustees held October 9, 2006, be approved. Roll Call: Ayes, unanimous; nays, none.

Vouchers

Dr. Robinson presented the vouchers for the period ending October 11, 2006, with the recommendation the vouchers be approved. A motion was made by Robert A. Armstrong, seconded by Kurt A. Walborn, that the vouchers appearing in the listing numbered 06-20 be approved without exception. Roll Call: Ayes, unanimous; nays, none.

Dr. Robinson presented the following recommendation concerning the Purchase of Properties – South Side High School:

Purchase of Properties – South Side High School

RECOMMENDATION: It is recommended that the Board authorize the purchase of the following properties located near South Side High School:

RELATED INFORMATION: The current school site is significantly below the state minimum acreage recommendation. Funds are within budget. Purchases of properties in this block will allow flexibility for the school to expand parking lots or playing fields. The purchase prices are the average of two appraisals.

A motion was made by Carol J. Coen, seconded by Kurt A. Walborn, that the recommendation concerning the Purchase of Properties – South Side High School be approved. Roll Call: Ayes, unanimous; nays, none.

Ratification of Fort Wayne Classified Association Contract Dr. Robinson presented the following recommendation concerning the Ratification of Fort Wayne Classified Association Contract:

RECOMMENDATION: It is recommended that the Board ratify revisions to the collective bargaining agreement between Fort Wayne Classified Association and Fort Wayne Community Schools.

RELATED INFORMATION: On Monday, October 9, 2006, Fort Wayne Community Schools and Fort Wayne Classified Association reached a tentative agreement to the collective bargaining agreement. The recommended changes are as follows:

- Article XV, C4 Update insurance premiums
- Article XVII, 4 Amending language to state, "Substitute and temporary drivers who hold a CDL shall receive 90% of the starting wage of the Food Service wage scale for temporary periods"
- Article XXI Term of Contract: 5 years (2007-2011)

- Wages - 2007 – 1%

2008 – Wage Re-opener 2009 – Wage Re-opener 2010 – Wage Re-opener 2011 – Wage Re-opener

A motion was made by Robert A. Armstrong, seconded by Carol J. Coen, that the recommendation concerning the Ratification of Fort Wayne Classified Association Contract be approved. Roll Call: Ayes, unanimous; nays, none.

Title IV Safe and Drug Free Grant Dr. Robinson presented the following recommendation concerning the Title IV Safe and Drug Free Grant:

RECOMMENTATION: It is recommended that the Board approve the application for and acceptance of the Title IV Safe and Drug Free Schools and Communities Grant from the Indiana Department of Education in the amount of \$140,022 of which \$20,245 will go to non-public schools.

RELATED INFORMATION: Title IV funding is provided to schools under the Elementary and Secondary Education Act (ESEA). The allocation is based on enrollments for both public and non-public schools in the FWCS attendance area.

This Title IV grant is an entitlement grant provided to supplement the general fund. Monies from Title IV will be used to provide an interactive program that instructs students about thinking patterns and how thinking errors can lead to irresponsible behavior. Lifeline, Inc. (Center for Responsible Thinking), a non-profit organization, will work with students that have been assigned to an alternative program from Fort Wayne Community Schools.

Dr. Charles Green, Director Academic Support, is the coordinator of this non-competitive grant. Funds are used in support of FWCS Strategy 2: We will provide a positive culture for students and staff.

A motion was made by Kweku Akan, seconded by Robert A. Armstrong, that the recommendation concerning the Title IV Safe and Drug Free Grant be approved. Roll Call: Ayes, unanimous; nays, none.

Title II, Part A Grant

Dr. Robinson presented the following recommendation concerning the Title II, Part A Grant:

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of funds from the Indiana Department of Education for Title II, Part A grant in the amount of \$1,498,713.

RELATED INFORMATION: Title II funding is provided to schools under the Elementary and Secondary Education Act (ESEA). The allocation is based on enrollments for both public and private schools in the FWCS attendance area. An amount of \$80,577 has been allocated to serve identified private schools for Title II, Part A.

Title II is an entitlement grant provided to supplement the general fund. Monies from Title II, Part A will be used to reduce class size and provide teacher training in core academic subjects. The grant is used for teachers of all grade levels.

This noncompetitive grant is coordinated by Carol Kettler of School Improvement Systems. These address advancement intended and outlined in Strategy 1: We will ensure high levels of learning for all students.

A motion was made by Robert A. Armstrong, seconded by Jon J. Olinger, that the recommendation concerning the Title II, Part A Grant be approved. Roll Call: Ayes, unanimous; nays, none.

Title V Grant

Dr. Robinson presented the following recommendation concerning the Title V Grant:

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of funds from the Indiana Department of Education for Title V Innovative Programs in the amount of \$573,937.

RELATED INFORMATION: Title V funding is provided to schools under the Elelmentary and Secondary Education Act (ESEA). The allocation is based on enrollments for both public and private schools in the FWCS attendance area. An amount of \$122,842 has been allocated to serve identified private schools.

Title V is an entitlement grant provided to supplement the general fund. Monies from Title V will be used to support Reading Recovery and a school nurse.

This noncompetitive grant is coordinated by Carol Kettler of School Improvement Systems. It addresses advancement intended and outlined in Strategy 1: We will ensure high levels of learning for all students.

A motion was made by Robert A. Armstrong, seconded by Jon J. Olinger, that the recommendation concerning the Title V Grant be approved. Roll Call: Ayes, unanimous; nays, none.

Stewart B. McKinney -Vento Homeless Assistance Grant

Dr. Robinson presented the following recommendation concerning the Stewart B. McKinney - Vento Homeless Assistance Grant:

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of a grant for \$30,000 through the Indiana Department of Education McKinney -Vento Act. These funds will be used to support the Fort Wayne Community Schools Homeless Assistance Program.

RELATED INFORMATION: Federal funding through the McKinney-Vento Act is one component of a program which would enable Fort Wayne Community Schools to provide assistance for students residing in shelters to continue their education. During the 2005-2006 school year approximately 325 students were assisted through the program from 11 shelters and facilities in the community.

The funds are distributed as grants by the Indiana Department of Education for local education agencies to establish educational programs which promote the identification, enrollment, attendance, and success of homeless children and youth in school and preschool. The request of \$30,000 will be used to provide support, remediation, instructional materials and supplies, and other related services to Fort Wayne Community School's homeless children and their families.

This competitive grant was prepared by Jerry White, director of Student Services, and supports FWCS Strategic Plan, Strategy 2: We will provide a positive culture for students and staff.

A motion was made by Jon J. Olinger, seconded by Robert A. Armstrong, that the recommendation concerning the Stewart B. McKinney - Vento Homeless Assistance Grant be approved. Roll Call: Ayes, unanimous; nays, none.

Stewart B. McKinney -Vento Transportation Grant

Dr. Robinson presented the following recommendation concerning the Stewart B. McKinney - Vento Transportation Grant:

RECOMMENDATION: It is recommended that the Board approve the application for the McKinney-Vento transportation grant that would provide transportation for homeless children and youth to their school of origin.

RELATED INFORMATION: Through the McKinney-Vento Homeless Assistance Act of 1987, as amended by the No Child Left Behind Act of 2001, federal funds are available to each state to support programs that meet the needs of homeless children and youth. The Indiana Department of Education has identified transportation funding as a critical need for the state's school corporations. As a result, grants will be made available to school corporations for the provision of transportation services to homeless children and youth to their schools of origin.

Grant will be available in the amount of \$10,000 which is based on student enrollment. First preference will be given to school corporations that do NOT receive other McKinney-Vento funding. Awards will be made based on need as demonstrated by the number of homeless students, and on a first-come, first-served basis for the period of October 1, 2006, to September 30, 2007.

This is a competitive grant and supports FWCS Strategic Plan, Strategy 1: We will ensure high levels of learning for all students.

A motion was made by Kweku Akan, seconded by Jon J. Olinger, that the recommendation concerning the Stewart B. McKinney - Vento Transportation Grant be approved. Roll Call: Ayes, unanimous; nays, none.
