RESOLUTION OCTOBER 24, 2011 TO ADOPT THE YEAR 2012 BUS REPLACEMENT PLAN

This resolution is adopted by the Board of Trustees of Fort Wayne Community Schools of Allen County, Indiana:

WHEREAS, the Board of Trustees is required under I.C. 20-46-5-8 to adopt a plan with respect to a School Bus Replacement Plan; and

WHEREAS, the Board of Trustees held a public hearing on the plan on the 24th day of October 2011, at 6:00 pm in the Lester L. Grile Administrative Center,

THEREFORE, BE IT RESOLVED, by the Board of Trustees that the plan entitled School Bus Replacement Plan for the years 2012 through 2023 is hereby incorporated by reference into this resolution and is adopted as the Board of Trustees' Plan with respect to the School Bus Replacement Plan.

BE IT FURTHER RESOLVED, that the Board of Trustees shall submit a certified copy of this resolution (including the adopted plan and the Calculation Worksheet) to the Department of Local Government Finance as required by IC 20-46-5-8 for approval.

A motion was made by John Peirce, seconded by Jordan Lebamoff, that the recommendation concerning the 2012 Budget Adoption and Resolutions be approved. Roll Call: Ayes, unanimous; nays, none.

Levy Neutrality Dr. Robinson presented the following recommendation concerning the Levy Neutrality:

RECOMMENDATION: It is recommended that the Board approve reductions to the 2012 budgets of the Bus Replacement Fund, the Transportation Fund, and the Capital Projects Fund Plan to support the tax neutrality requirements of the Pension Bond.

RELATED INFORMATION: Public Law 199 requires that those districts, who issue a pension bond to replace their retirement severance programs, must make the annual bond payment a tax neutral event to taxpayers. As a result, Fort Wayne Community Schools has chosen to reduce the levies in the Bus Replacement Fund, the Transportation Fund, and the Capital Projects Fund Plan. With this reduction the district will purchase thirteen fewer buses and will reduce its Transportation Fund budget and the Capital Projects Fund Plan.

RESOLUTION OCTOBER 24, 2011 PENSION BOND FUND LEVY NEUTRALITY

This resolution is adopted by the Board of School Trustees of The Fort Wayne Community Schools, Allen County, Indiana.

WHEREAS the Pension Bond Fund expected levy of \$3,790,000 needs to be tax neutral.

THEREFORE BE IT RESOLVED that the tax levies of Bus Replacement Fund, the Transportation Fund, and Capital Projects Fund will be reduced. It is expected that the tax levies will be reduced as follows:

The Board further agrees that any levy greater than \$3,790,000 will be reduced from the Bus Replacement Fund.

Goals for Expenditure Categories

Dr. Robinson presented the following recommendation concerning the Goals for Expenditure Categories:

RECOMMENDATION: It is recommended that the Board approve a resolution to set expenditure category goals for the 2011-2012 school year. The goal is to strive to improve upon the current percentages between the expenditures for the student instructional categories and the other expenditure categories.

RELATED INFORMATION: Beginning with the 2007-2008 school year, school districts are required to establish goals for each category of expenditures that will increase the school corporation's allocation of taxpayer resources directly to student instruction and learning, in light of the unique circumstances present in the school corporation. The Department of Education reported the following percentages:

FWCS student instructional expenditures as a percent of the total were just .6 percent higher than the previous year. However, FWCS is 12.3 percentage points greater than the state average.

OCTOBER 24, 2011 RESOLUTION FOR GOALS FOR EXPENDITURE CATEGORIES

WHEREAS, the Fort Wayne Community Schools Board of Trustees, Allen County, has adopted a 2011 budget;

WHEREAS, P.L. 191-2006 states that beginning with the 2007-08 school year, each governing body shall establish goals for each category of expenditures that will increase the school corporation's allocation of taxpayer resources directly to student instruction and learning, in light of the unique circumstances present in the school corporation.

WHEREAS, The State Board of Education has approved the following definitions:

A. "Student Instructional Expenditures" are: (1) student academic achievement expenditures plus (2) student instructional support expenditures.

B. "Other Expenditure Categories" are: (3) overhead and operational expenditures plus (4) non-operational expenditures.

WHEREAS, Fort Wayne Community Schools believes that the educational preparation of all students be addressed in a manner that maximizes the individual student's potential.

NOW THEREFORE, BE IT RESOLVED, Fort Wayne Community Schools shall review on an annual basis each of these expenditure categories and how to improve student achievement. Fort Wayne Community Schools will strive to improve upon the current levels (percentages) between the expenditures for the student instructional expenditure categories and the other expenditure categories as described in IC 20-42.5 for the next fiscal year. However increasing the percentages in the student instructional expenditure categories and maintaining certain ratios between the "Student Instructional" and "Other Categories" may be negatively impacted by unique circumstances that the Fort Wayne Community Schools might experience such as, but not limited to:

- Loss or reduction of Federal & State Grants which require educational programs to be reduced or eliminated.
- Replacement of retiring teachers (top of the scale) with new teachers who have lower salaries than the retiring teachers.
- School construction related to the district's long-range facility plan.
- Federal Stimulus Grants may increase student instructional spending, but could be offset by instructional cuts needed in other funds.

A motion was made by Stephen Corona, seconded by Julie Hollingsworth, that the recommendation concerning the Goals for Expenditure Categories be approved. Roll Call: Ayes, unanimous; nays, none.

Board member John Peirce shared that it was a privilege to visit Anthis for Principal for the Day. He visited cosmetology, automotive center and the fire fighting academy.

Board member Julie Hollingsworth encouraged the public to get involved with the discussions regarding the FWCS facilities project and reminded them of public meeting dates on the topic: Tuesday, November 1 at 6:30 p.m. at Memorial Park Middle School; Tuesday, November 8 at 2 p.m. at Northrop High School; Wednesday, November 9 at 6:30 p.m. Harrison Hill Elementary School; and Thursday, November 10 at 6:30 p.m. at Snider High School. There is a link on the FWCS website with much information available.

Board member Becky Hill thanked Steve Jones at Price for a informative visit to the school. Becky also thanked Sodexo for the monthly newsletter with good information.

Board member Jordan Lebamoff gave a hats off to the teachers and staff at Weisser Park Elementary school for a successful Fall Festival. He also thanked the teachers for having real relationships with students.

President Mark GiaQuinta commented that he attended the Fall Region III ISBA dinner at Goeglein's last week. Mr. GiaQuinta also commented about the request made by the Indianapolis Public Schools (IPS) Superintendent to investigate the number of students who came back to IPS from charter schools after the official count date and Mr. GiaQuinta would like FWCS to track if this may be happening in FWCS. Mr. GiaQuinta also thanked educators who play a very important role in strengthening our democracy.
