Approval of Minutes – October 10, 2005

Dr. Wendy Robinson, superintendent, presented the following information and recommendations concerning awards and recognitions:

Staff Spotlight – Sharon Hardy, Alternative Learning Assistant, Shambaugh Elementary School **RECOMMENDATION**: It is recommended that the Board recognize Sharon Hardy, an alternative learning assistant at Shambaugh Elementary School, for her contributions to teachers, children and families of Fort Wayne Community Schools.

**RELATED INFORMATION**: The Staff Spotlight program is the district's method of recognizing employees for outstanding work and commitment to excellence.

We honored Sharon Hardy, an FWCS employee for eight years. She currently works at Shambaugh and is always available to assist students and teachers in any way she can. In addition to being an assistant, Ms. Hardy is an active band grandmother with the Big Orange Pride at Northrop. She is also a volunteer for FWCS Study Connection. A video highlighting her accomplishments was shown.

National Forensic League Honors – Northrop and South Side High Schools **RECOMMENDATION**: It is recommended that the Board recognize speech teams from Northrop and South Side High Schools for earning honors from the National Forensic League.

**RELATED INFORMATION**: The National Forensic League (NFL) recognizes speech teams throughout the nation in a variety of categories. This year, Northrop was awarded the Leading Chapter Award in the Northeast Indiana District. This award is based on student participation and is the highest honor the NFL can bestow upon a chapter. Northrop is one of 103 schools in the nation to receive the award this year. Northrop also placed in the top 5 percent of NFL chapters nationwide and qualified for the "200 Club." South Side's speech team qualified for the "300 Club."

**RELATED INFORMATION**: At its September 12, 2005 meeting, the Board of School Trustees approved the 2006-2008 Capital Projects Plan. This plan includes improvements at various schools and support facilities, as well as the renovation of Geyer Middle School for conversion to a Montessori school.

Area Administrators, Principals, and Business Division personnel participate in the selection of architects for the major building projects. Facilities administrators select architects and engineers for the remaining projects based on the individual strengths of each of the firms. A total of seven local engineering and architectural firms are included in this recommendation.

The physical plant improvement project budgets are estimated because final amounts are not yet determined. Bids will be taken for the projects and final amounts will be brought to the Board for final approval. This recommendation is to only approve the project architects. Indiana law requires that projects over \$100,000 make use of a registered architect or a professional engineer for developing plans and specifications.

Project architects/engineers need to be appointed now to allow sufficient time for planning and bidding of projects to ensure completion during the summer of 2006.

A motion was made by Jon J. Olinger, seconded by Robert A. Armstrong, that the recommendation concerning the Appointment of Project Architects for 2006 CPF Construction Projects be approved. Roll Call: Ayes, unanimous; nays, none.

Dr. Robinson presented the following recommendation concerning the Foellinger Foundation Grant – Summer Voyage Program:

**RECOMMENDATION**: It is recommended that the Board approve the application for and acceptance of a grant from the Foellinger Foundation in the amount of \$157,937 for the 2006 Summer Voyage program.

**RELATED INFORMATION**: Foellinger Foundation provides financial support to the Fort Wayne community for the purpose of strengthening families, particularly those children and families with the greatest economic need and the least opportunity. To participate in their competitive grant making process, Fort Wayne Community Schools has developed Summer Voyage, a four-week summer program for elementary students to build literacy skills. Based on students' reading level, approximately 510 children in grades K-3 will be able to attend the program offered at three elementary schools. Each grade level has a separate theme that will guide the literacy activities during the program.

Foellinger has supported FWCS Summer Clubhouse in previous years and community response has been very favorable. This focus of the grant has been narrowed to address our core business and help students maintain and develop their emergent literacy skills. Summer Voyage addresses advancement intended and outlined in Strategy 1: We will ensure high levels of learning for all students. The overall program is coordinated by Curriculum Services.

A motion was made by Jon J. Olinger, seconded by Robert A. Armstrong, that the recommendation concerning the Foellinger Foundation Grant – Summer Voyage Program be approved. Roll Call: Ayes, unanimous; nays, none.

### Gifted and Talented Grant

Dr. Robinson presented the following recommendation concerning the Gifted and Talented Grant:

**RECOMMENDATION**: It is recommended that the Board approve the application for and acceptance of a Gifted and Talented Grant for 2005-2006 from the Indiana Department of Education in the amount of \$71,366.

**RELATED INFORMATION**: The state of Indiana provides non-competitive funds for districts to address the learning needs of high ability students. Funds for 2005-2006 will be used:

To provide an appropriate education for identified high ability students through differentiated Levels of Service and program options; and

To provide a special assignment facilitator to train teachers on the characteristics and educational needs of high ability students and on strategies for educating such students within the classroom.

Currently, gifted and talented services are delivered through the efforts of classroom teachers and supported by Thinking Skills Coaches in every building. The overall program is coordinated by Connie Collins in Curriculum Services.

The grant addresses advancement intended and outlined in Strategy 1: We will ensure high levels of learning for all students.

A motion was made by Kurt A. Walborn, seconded by Carl A. Johnson, that the recommendation concerning the Gifted and Talented Grant be approved. Roll Call: Ayes, unanimous; nays, none.

Cable Fund Access Board Grant - Irwin Elementary School Dr. Robinson presented the following recommendation concerning the Cable Fund Access Board Grant – Irwin Elementary School:

**RECOMMENDATION**: It is recommended that the Board approve the application for and acceptance of the Cable Fund Access Board Grant (CFAB) from the City of Fort Wayne in the amount of \$12,800.69 for Irwin Elementary School.

**RELATED INFORMATION**: The objective of this grant request is to purchase equipment for WROC-TV, the Irwin television studio which produces student run newscasts and specialty programming. The contact person for this competitive grant is Andra Rose, media clerk, from Irwin Elementary School.

This program supports advancement intended and outlined in Strategy 1: We will ensure high levels of learning for all students.

A motion was made by Carl A. Johnson, seconded by Geoff Paddock, that the recommendation concerning the Cable Fund Access Board Grant – Irwin Elementary School be approved. Roll Call: Ayes, unanimous; nays, none.

Title IV Safe and Drug Free Grant Dr. Robinson presented the following recommendation concerning the Title IV Safe and Drug Free Grant:

**RECOMMENTATION**: It is recommended that the board approve the application for and acceptance of the Title IV Safe and Drug Free Schools and Communities Grant from the Indiana Department of Education in the amount of \$173,695 of which \$33,454 will go to non-public schools.

**RELATED INFORMATION**: Title IV funding is provided to schools under the Elementary and Secondary Education Act (ESEA). The allocation is based on enrollments for both public and non-public schools in the FWCS attendance area.

This Title IV grant is an entitlement grant provided to supplement the general fund. Monies from Title IV will be used to provide an interactive program that instructs students about thinking patterns and how thinking errors can lead to irresponsible behavior. Lifeline, Inc. (Center for Responsible Thinking), a non-profit organization, will work with students that have been assigned to an alternative program from Fort Wayne Community Schools. Parent nights will be held at L. C. Ward to discuss strategies being taught. Also, \$34,700 will be used to purchase or update security equipment for schools.

Judy Platz, Manager of Pupil Personnel, is the coordinator of this non-competitive grant. Funds are used in support of FWCS Strategy 2: We will provide a positive culture for students and staff.

A motion was made by Robert A. Armstrong, seconded by Jon J. Olinger, that the recommendation concerning the Title IV Safe and Drug Free Grant be approved. Roll Call: Ayes, unanimous; nays, none.
