RELATED INFORMATION: At its September 13, 2004 meeting, the Board of School Trustees approved the 2005-2007 Capital Projects Plan. This plan includes physical plant improvements at various schools and support facilities, as well as the South Side and Wayne stadiums, and capital projects for the South Side Natatorium and Kekionga Middle School.

Area administrators, principals, and Business Division personnel participate in the selection of architects for the major building projects. Facilities administrators select architects and engineers for the remaining projects based on the individual strengths of each of the firms. A total of five local engineering and architectural firms are included in this recommendation.

The physical plant improvement project budgets are estimated because final amounts are not yet determined. Indiana law requires that projects over \$100,000 make use of a registered architect or a professional engineer for developing plans and specifications.

Project architects/engineers need to be appointed now to allow sufficient time for planning and bidding of projects to ensure completion during the summer of 2005.

RELATED INFORMATION: Because of the size and complexity of the North Side Renovation and Addition Project, contract changes can be anticipated. Unforeseen conditions and the acceptance of alternates are normally the reason. Changes to the scope of work are approved only after FWCS personnel consult with the architect and construction manager. These change orders reflect additional work recommended on the project. Funds have been set aside from the bond to cover such occurrences.

Building Relationships for Success – to focus on the development and enhancement of relationships among parents, teachers, and students.

Enriching Parent and Youth Interactions through Reading – to enrich interactions between teachers, youth, and their parents.

This competitive program supports advancement intended and outlined in Strategy 1 - We will ensure high levels of learning for all students, and Strategy 4 – We will function as a center of learning in the community.

Dr. Robinson presented the following recommendation concerning the Panasonic *Kid Witness News* Program – Jefferson Middle School:

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of a grant of technology equipment from Panasonic for the *Kid Witness News* program at Jefferson Middle School.

RELATED INFORMATION: Panasonic provides video equipment to selected urban, public schools serving grades five through eight, to participate in the *Kid Witness News (KWN)* program. *KWN* is a hands-on video education program created to encourage students to develop communication and organizational skills through the use of video. The Panasonic video studio includes state of the art digital video equipment along with student instruction manuals and video training tape.

If awarded, Jefferson Middle School plans for students to use the video studio equipment for classroom projects, school productions, and the eighth grade Drama and Speech class. Also, students would share favorite books using the studio equipment during language arts classes and homeroom time. A final place of implementation would be through an after-school video club which would create productions for viewing by Jefferson students and other FWCS students via LTV-54.

This competitive grant application submitted by Media Specialist, Beth Starn and Principal, Mike Morris, supports Strategy I – We will ensure high levels of learning for all students.
