Dr. Wendy Robinson, superintendent, presented the following information and recommendations concerning awards and recognitions:

Four Star
School
Awards –
Croninger
and Irwin
Elementary
Schools

RECOMMENDATION: It is recommended that the Board recognize the students and staff of Croninger Elementary School and Irwin Elementary School for receiving the state Four Star School award.

RELATED INFORMATION: Croninger and Irwin Elementary Schools are among an elite group of schools receiving the state Four Star School award. This award is the highest state distinction and is based on student achievement on ISTEP+ assessments and overall attendance rates. Less than ten percent of all eligible public schools in the state received this award. To be designated as a Four Star School, a school must be fully accredited, meet Adequate Yearly Progress (AYP) for 2007 and perform in the top 25 percent of all the schools in each of the following four areas:

- student attendance rates,
- mathematics proficiency scores,
- English/language arts proficiency scores and
- the percent of students passing both English/language arts and mathematics.

The Croninger staff has continued to work diligently as a Professional Learning Community focusing on overall stringent implementation of scientific, research-based methods of instruction. Individual skill mastery of Indiana Academic State Standards continues to be the primary factor in order to achieve Four Star status three years in a row. The summer reading, writing and math program called Summer Journal, which is expected of all students, has also impacted Croninger's success. Attendance remains a high priority everyday at Croninger.

The Irwin staff has worked hard to establish a culture in which each person takes individual responsibility for one's self while developing and practicing a sense of collective responsibility for one another as part of their school community. The teaching staff, through the professional learning community model, examines student achievement data, classroom instructional practices, and research based interventions allowing them to better target instruction to the personal and precise needs of students. High levels of implementation of the district core models of instruction in Language Arts and Math in particular have shown success as evidenced by this award. Principal Jeff Cline would like to label the award a "345 star school" because everyone made it happen.

RELATED INFORMATION: Reasonable allowances and contingencies are included in base bids for most projects because of conditions or fees not specifically known at the time bids are taken. The use of these allowances and contingencies is authorized by the administration only after review by Facilities Department administrators and relevant architectural and engineering firm personnel. To avoid major delays in construction projects, change order decisions are generally required and made prior to an official board meeting. In the event a major change in project scope is needed, a recommendation is made to the Board for approval prior to proceeding with the project.

Appointment of Common Wage Committee

RELATED INFORMATION: Each year FWCS conducts a Common Wage hearing to determine the most common wage for each class of work. The common wage determines the minimum wage to be paid on upcoming FWCS construction projects.

By statute, there are five members of the Common Wage Committee. Three appointments are external, including one representing labor, one named by the Governor, and one appointed by the County. Two members are appointed by FWCS, one representing industry and one taxpayer in our district.

Best Buy Teach Award Grant – Fairfield Elementary School

Dr. Robinson presented the following recommendation concerning the Best Buy Teach Award Grant – Fairfield Elementary School:

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of the Best Buy Teach Award grant in the amount of \$4000.00 for Fairfield Elementary School.

RELATED INFORMATION: The Best Buy Teach Award program was created to recognize and reward schools that are using interactive technology in the classroom to engage students and make learning fun. The purpose of this non-competitive grant request is to receive additional technology to support Fairfield's integrated arts programs. Using a theme from their academic curriculum students will develop a performance tool using technology to share projects. Creating these projects will involve activities such as researching, photographing, recording, reading and singing using technology.

This program supports FWCS district Goal I: *Achieve and Maintain Academic Excellence*.

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of the Foellinger Foundation Youth and Family Development Grant in the amount of \$45,000+ over 5 years for Washington Elementary School.

RELATED INFORMATION: This Foellinger Foundation Youth and Family Development grant will enable staff to enhance parent involvement activities at Washington Elementary School. Activities will help to develop a positive home-school connection and get students excited about school as well as parents excited about working with their children. Parents will be involved in an educational setting with the opportunity to earn reading materials and educational activities that will excite them about learning.

Washington Elementary School will partner with Barnes and Noble for these activities. A family night at Barnes and Noble and parent dinners coupled with educational game nights will take place.

This program supports FWCS district Goal I: *Achieve and Maintain Academic Excellence* and Goal II: *Engage Parents and the Community*.
