**RECOMMENDATION:** It is recommended that the Board recognize Indian Village Elementary School for receiving the Outstanding/Successful School Award from the Indiana unit of the Association of Teacher Educators.

**RELATED INFORMATION:** Indian Village was one of three schools in the state to receive this annual award, given each year to schools that show exemplary practices in student-centered education, innovative programs and projects and professional development. Schools are nominated by universities. Taylor University nominated Indian Village.

The school was cited for its outstanding scores on the ISTEP+ test – the scores are among the highest in northeast Indiana – and its outstanding academic programs. Principal Stephany Bourne and three teachers traveled to Nashville, Indiana, on October 20, 2002 to receive the award.

Purchase of  
Natural Gas

Dr. Fowler-Finn presented the following recommendation regarding the Purchase of Natural Gas:

**RECOMMENDATION:** It is recommended that the Board authorize the Superintendent to enter into a contract for the purchase of natural gas when viable proposals become available.

**RELATED INFORMATION:** Effective April 1, 1998, FWCS has solicited proposals from suppliers of natural gas. This opportunity was started as a result of the deregulation of gas as a public utility. Based on regulations from the Indiana Utility Regulatory Commission, suppliers must be "qualified" by NIPSCO before they can provide natural gas to us.

The vendors have suggested that they can submit a lower proposal if they do not need to hold the price guaranteed to some future date, as would be required if we were to request bids and delay awarding a contract until after Board approval of bids. Our school attorney has advised that IC-36-1-9-16 allows for this type of contract award without a public bid when "[t]here exists a unique opportunity to obtain supplies or services at a substantial savings..."

A motion was made by Bettye J. Poignard, seconded by Jon J. Olinger, that the Purchase of Natural Gas be approved. Roll Call: Ayes, unanimous; nays, none.
