Approval of Minutes – October 27, 2008

Dr. Wendy Robinson, superintendent, presented the following information and recommendations concerning awards and recognitions:

Excellence in Teaching Award from Notre Dame Club of Fort Wayne **RECOMMENDATION**: It is recommended that the Board recognize St. Joseph Central Elementary School teacher Mary Yarnelle for receiving the Excellence in Teaching Award from the Notre Dame Club of Fort Wayne.

**RELATED INFORMATION**: Each year the Notre Dame Club of Fort Wayne honors two teachers – one from a Catholic school and one from all remaining schools in Northeast Indiana – for the Excellence in Teaching Award. The award is given to a teacher who inspires students by piquing their curiosity, fueling their imagination and giving life to their dreams. Cable Fund Access Board (CFAB) Non-Access Channel Originator Grant Dr. Robinson presented the following recommendations concerning the Cable Fund Access Board (CFAB) Non-Access Channel Originator Grant; the Title II, Part A Grant; and the Title IV Safe and Drug Free Schools and Communities Grant:

**RECOMMENDATION**: It is recommended that the Board approve the application for and acceptance of a Non-Access Originator grant from the Cable Fund Access Board (CFAB) in the amount of \$16,464.20 for North Side High School.

**RELATED INFORMATION**: Funds from this competitive grant will be used in the production of programming for the access channels of the Fort Wayne cable television system. The purchase of updated equipment will allow students in the Communication Processes and Technology Systems classes to continue producing the North Side High School weekly news program. The program is broadcast to all North Side classrooms as well as viewers of Cable Channel 54 on Fridays at 6:00 p.m. and Saturdays at 10:30 a.m. Students learn the art of video production while exposing the community to many positive attributes of North Side High School.

Technology Education Teacher Scott Brown wrote this grant which supports District Goal 1: *Achieve and Maintain Academic Excellence*.

Title II, Part A Grant **RECOMMENDATION**: It is recommended that the Board approve the application for and acceptance of funds from the Indiana Department of Education for Title II, Part A grant in the amount of \$1,978,294.

**RELATED INFORMATION**: Title II funding is provided to schools under the Elementary and Secondary Education Act (ESEA). The allocation is based on enrollments for both public and private schools in the FWCS attendance area. An amount of \$199,322 has been allocated to serve identified private schools for Title II, Part A.

Title II is an entitlement grant provided to supplement the general fund. Monies from Title II, Part A will be used to reduce class size and provide teacher training in core academic subjects. The grant is used for teachers of all grade levels.

This noncompetitive grant is coordinated by Linda Roman of Professional Development and addresses advancement intended and outlined in Goal 1: *Achieve and maintain academic excellence*.

Title IV Safe and Drug Free Schools and Communities Grant

**RECOMMENDATION**: It is recommended that the Board approve the application for and acceptance of the Title IV Safe and Drug Free Schools and Communities Grant from the Indiana Department of Education in the amount of \$175,179.

**RELATED INFORMATION**: Title IV funding is provided to schools under the Elementary and Secondary Education Act (ESEA). The allocation is based on enrollments for both public and non-public schools in the FWCS attendance area. An amount of \$26,649 has been allocated to non-public schools for Title IV.

This Title IV grant is an entitlement grant provided to supplement the general fund. Monies from Title IV will be used to provide an interactive program that instructs students about thinking patterns and how thinking errors can lead to irresponsible behavior.

Charles Green, Director Academic Support, is the coordinator of this non-competitive grant. Funds are used in support of FWCS Strategy 2: We will provide a positive culture for students and staff.

Olinger, that the recommendations concerning the Cable Fund Access Board (CFAB) Non-Access Channel Originator Grant; the Title II, Part A Grant; and the Title IV Safe and Drug Free Schools and Communities Grant be approved.
