Health Plan
Renewal

Dr. Robinson presented the following recommendation concerning the Group Health Plan Renewal:

RECOMMENDATION: It is recommended that the Board renew the administration contract with Anthem Blue Cross and Blue Shield effective January 1, 2014 through December 31, 2014.

RELATED INFORMATION: Anthem acts as a third party administrator for the FWCS Group Health Plan providing our employees with access to broad-based PPO providers and network discounts. In addition, they manage claims processing services and all aspects of the provider network, perform utilization and medical management functions, and provide enrollment support and customer service for our employees.

Administrative fees for medical, dental and vision are increasing 3% or about \$35,430. Reinsurance premiums are increasing 11% or about \$144,292. Administrative fees and reinsurance premiums are approximately 6% of the total expected cost of the health plan.
