Approval of Minutes – October 23, 2006

Dr. Wendy Robinson, superintendent, presented the following information and recommendations concerning awards and recognitions:

Franke Park Aquanaut Award **RECOMMENDATION**: It is recommended that the Board recognize two Franke Park Elementary School students for receiving a national award from NASA.

RELATED INFORMATION: Students from Franke Park Elementary School recently learned about aquanauts training aboard the Aquarius during a NASA Extreme Environment Mission Operation (NEEMO). They participated in a videoconference with an aquanaut during their mission. Afterwards, students created pictures based on the theme: "Look At Me, I'm an Aquanaut." Also students were required to write a paragraph explaining what they were doing as part of the Aquanaut program. The pictures and writings were submitted to NASA and judged along with entries from across the country.

Franke Park fourth grader Autumn Sheets and fifth grader Shaina Haneline were chosen by the crew of NASA's "NEEMO 9" as national winners of the contest!

Recommendation for Digital Copiers, RFP #9650

RECOMMENDATION: It is recommended that the Board approve contracts for the period January 2007 to June 2011 with the vendors providing the overall best and most responsive proposals for digital convenience and production copy machines on a cost-per-impression basis:

IKON Office Solutions, Fort Wayne, IN \$3,780,110.00 (Convenience copiers)
Adams Remco, Inc., Fort Wayne, IN (Savin) \$200,681.00 (Production copiers)

RELATED INFORMATION: The Request for Proposals (RFP) specified a fifty-four month lease contract on a cost-per-impression basis to replace 264 existing convenience digital copiers located throughout the district and 3 existing high-speed production copiers located in Printing Services. The contracts include the use of the copiers, maintenance, and all supplies except paper, at a cost of 1.183 cents per impression for the convenience copiers based on a total contract volume of 317 million impressions, and .559 cents per impression for the production copiers based on a total contract volume of 35.9 million impressions.

As an additional component of this replacement plan, every school and several administrative units will receive one of the multifunctional convenience units equipped with color capability at a cost of 6 cents per color impression.

The cost-per-impression for the convenience copiers reflects a 21% decrease when compared to the last RFP awarded in 2001, resulting in an annual savings of \$223,000. The cost-per-impression for the production copiers reflects an overall decrease of 44% when compared to the last contract awarded in 2003, resulting in an annual savings of \$35,000.

In addition, the Perry proposal did not provide copiers equipped with hard drives as a standard feature in order to perform forms storage.
