Dr. Robinson presented the following recommendation concerning the Group Health Plan Renewal:

Group Health Plan Renewal

**RECOMMENDATION:** It is recommended that the Board renew the administration contract with Anthem Blue Cross and Blue Shield effective January 1, 2017 through December 31, 2017.

**RELATED INFORMATION:** Anthem acts as a third party administrator for the FWCS Group Health Plan, providing employees with access to broad-based PPO providers and network discounts. In addition, they manage claims processing services and all aspects of the provider network, perform utilization and medical management functions, and provide enrollment support and customer service for our employees.

Administrative fees for medical, dental and vision are increasing 2.7% or about \$34,000. Reinsurance premiums are increasing 9.4% or about \$158,197. Administrative fees and reinsurance premiums are \$3,126,081 or approximately 6.4% of the total expected cost of the health plan, \$49,179,845.

This supports FWCS District Goal III: Operate Effectively with Integrity and Fiscal Responsibility.

Superintendent Wendy Robinson provided the Board with an update on the 2015-16 State Accountability/Assessment Plan and its impact on FWCS.

Comments

Board Member Steve Corona commented that he will be attending a conference at the Urban League tomorrow on ESSA. He encouraged other Board members to attend if they were invited.

Board Member Becky Hill commented that she visited North Side High School last week and she is overwhelmed with the dedication and passion that Principal West shows. Teachers and the diverse student population were engaged and eager to share with her what was happening in classrooms. Ms. Hill also shared that at Saturday's Showcase staff were excited to show off their buildings. This event is a Showcase for the world.

Board Member Julie Hollingsworth attended an event last Wednesday at the Career Academy Construction Trades building with more than 30 community members. It is a great new building that includes the new HVAC and plumbing programs.

Board Member Anne Duff complemented Shenita Piper on the College Readiness Program she presented during Showcase.

Superintendent Robinson shared with the Board that she and other FWCS staff members met with the Nebraska Neighborhood Association last week for preliminary conversations and to help clarify myths on alternative programs. Dr. Robinson also gave a shout out to Snider Football as they play Westfield this weekend for Semi-State. She also thanked all coaches for the countless hours they put in to help our youth.

Board President Mark GiaQuinta inquired about an issue at an FWCS girls basketball game where the opposing team recited a concerning chant. Mr. GiaQuinta would like for us to reach out to the Board of that district to inform them of this behavior.

The Board is currently working on Board Policies and Dr. Robinson's contract and evaluation. President GiaQuinta would like to finish up the Contract and Evaluation prior to Ms. Hill's last Board meeting in December.

As Mr. GiaQuinta will not be the President next year, he would like Board Members to communicate with him their thoughts on who should be Board President beginning in 2017. Julie Hollingsworth would be open to being in this position.
