Roll Call

The Board of School Trustees of the Fort Wayne Community Schools met in regular session in the Lester L. Grile Administrative Center on Monday, November 22, 2004, at 7:05 p.m. President Carol J. Coen called the meeting to order with the following members in attendance:

Approval of Minutes – November 8, 2004

A motion was made by Kurt A. Walborn, seconded by Jon J. Olinger, that the minutes of the regular meeting of the Board of School Trustees held November 8, 2004, be approved. Roll Call: Ayes, unanimous; nays, none.

Dr. Wendy Robinson, superintendent, presented the following information and recommendations concerning awards and recognitions:

Staff Spotlight – Caryl Collentine, teacher, Harrison Hill Elementary School **RECOMMENDATION**: It is recommended that the Board recognize Caryl Collentine, a special education teacher at Harrison Hill Elementary School, for her contributions to the children and families of Fort Wayne Community Schools.

RELATED INFORMATION: The Staff Spotlight program is the district's method of recognizing employees for outstanding work and commitment to excellence.

We honored Caryl Collentine, who has been with FWCS for 14 years. She is described as a teacher who is committed to ensuring her students have every opportunity to succeed academically and socially. A video highlighting her accomplishments was shown.

Vouchers

Dr. Robinson presented the vouchers for the period ending November 10, 2004, with the recommendation the vouchers be approved. A motion was made by Robert A. Armstrong, seconded by Geoff Paddock, that the vouchers appearing in the listing numbered 04-21 be approved without exception. Roll Call: Ayes, unanimous; nays, none.

Non-Union Salary Increase and Retirement Match Dr. Robinson presented the following recommendation concerning the Non-Union Salary Increase and Retirement Match:

RECOMMENDATION: It is recommended that the Board approve a two and one-half percent (2.5%) salary increase for the 2004/2005 school year for Salary Schedules I, II, and III, Meet & Confer groups and other non-union groups on fiscal-year agreements. Increases will be retroactive to the appropriate contracts and language agreements for each non-union group.

It is recommended that the Board approve a two and one-half percent (2.5%) salary increase effective January 1, 2005 for the remainder of the Meet & Confer and other non-union groups who are paid on a calendar-year schedule.

It is further recommended that the Board approve a revision in the district match to the 401(a) retirement accounts for all ISTRF and PERF eligible employees on Salary Schedules I, II, and III, Meet & Confer groups and other non-union groups. See the attached schedule.

It is also recommended that the Board grant the Superintendent latitude to make appropriate adjustments on policy agreement language to be submitted for approval at a later time.

RELATED INFORMATION: This pay increase is the same as agreed upon with the teachers. In addition, the change to the retirement match is similar to the one recently negotiated with teachers.

The administrative match will be a percentage of the base administrative salary determined by the number of years the individual administrator has worked for the district at the time the match is made. Other non-bargained employees who are PERF-eligible will have a match at .75% of their individual base step at the time the match is made.
