Dr. Wendy Robinson, superintendent, presented the following information and recommendations concerning awards and recognitions:

Indiana **RECOMMENDATION:** It is recommended that the Board recognize Lakeside Middle School and Academic Northwood Middle School for placing in the top 10 in the Indiana Academic Spell Bowl competition. Spell Bowl

RELATED INFORMATION: Students from Lakeside Middle School and Northwood Middle School competed with their peers from 248 middle schools across the state on Nov. 10 at Purdue University for the state Academic Spell Bowl. Only 30 middle schools in the state made the state competition, and FWCS was the only area district represented. Lakeside Middle School placed 3rd in Class 2. Earlier, the Lakeside team had won the FWCS Invitational at Memorial Park as well as the regional Class 2 competition.

Northwood Middle School students placed 9th in Class 1 at the state competition. They had placed second in the FWCS Invitational and placed first in the regional Class 1 competition.

Dr. Robinson presented the following recommendation concerning the Change Orders – 2007 Capital Projects Fund Construction Projects:

RECOMMENDATION: It is recommended that the Board approve the 11 change orders on the following page for the 2007 Capital Projects Fund Construction Projects.

RELATED INFORMATION: Reasonable allowances and contingencies are included in base bids for most projects because of conditions or fees not specifically known at the time bids are taken. The use of these allowances and contingencies is authorized by the administration only after review by Facilities Department administrators and relevant architectural and engineering firm personnel. To avoid major delays in construction projects, change order decisions are generally required and made prior to an official board meeting. In the event a major change in project scope is needed, a recommendation is made to the board for approval prior to proceeding with the project.

These change orders represent a net decrease of \$67,617.90, or -1.12 percent, on the construction contracts that total \$6,031,867.00

Dr. Robinson presented the following recommendation concerning the Allen County Education Partnership Grants:

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of the Allen County Education Partnership grants in partnership with ITT Industries Aerospace/Communications Division of Fort Wayne in the total amount of \$9,500 for Study Elementary School (Study) and Towles Intermediate School (Towles).

RELATED INFORMATION: Study's \$4,500 award will be used to create an understanding and to apply the basic laws of physics through the science of roller coasters. In addition to classroom instruction, activities by Science Central and IPFW will be performed for the 4th and 5th grade classes participating in the grant. The contact person for this competitive grant is Study's principal, Trudy Grafton.

Towles' \$5,000 award will be used to purchase two laptop computers to familiarize students with modern technology. The activities include technology based student websites and weekly webisodes for grades 4-6. The contact people for this competitive grant are Towles' principal, Tammy Lake, and 4-6 multi-aged teacher, Mark McCrory.

These programs support advancement intended and outlined in Strategy 1: *We will ensure high levels of learning for all students.*

RELATED INFORMATION: Funds from this competitive grant will be used in the production of programming for the access channels of the Fort Wayne cable television system. The purchase of updated equipment will allow students in the Communication Processes and Technology Systems classes to continue producing the North Side High School weekly news program. The program is broadcast to all North Side classrooms as well as viewers of Cable Channel 54 on Friday at 6:00 p.m.
