The Board of School Trustees of the Fort Wayne Community Schools met in regular session in the Lester L. Grile Administrative Center on Monday, December 8, 2008 at 6:02 p.m. President Mark GiaQuinta called the meeting to order with the Pledge of Allegiance and the following members in attendance:

Approval of Minutes – November 24, 2008 A motion was made by Mitch Sheppard, seconded by Jon J. Olinger, that the minutes of the regular meeting of the Board of School Trustees held November 24, 2008, be approved. Roll Call: Ayes, unanimous; nays, none.

Dr. Wendy Robinson, superintendent, presented the following information and recommendations concerning awards and recognitions:

All-State Jazz Band **RECOMMENDATION**: It is recommended that the Board recognize students who were named to the Indiana All-State Jazz Band this year.

RELATED INFORMATION: The Indiana All-State Jazz Band is a very prestigious honor, as there are many excellent jazz musicians in every school system throughout Indiana. To make the All-State team, students must tape an audition and be selected by a committee. This year, two FWCS students made the All-State Band. Tyler Scott from Snider was named to the band on drum set. A senior this year, he plans to attend the Berklee College School of Music next year to major in Music Performance and Studio Engineering. Phil Janz from Northrop made lead trombone. Phil, a junior, is the baritone section leader for the Big Orange Pride Marching Band, plays trombone in Jazz Band 1, Concert Band, Charisma Orchestra, and plays French horn in the orchestra.

Recognition Presentation to Jon J. Olinger

Board Member Jon J. Olinger's term ends on January 1, 2009. He has been on the Board for 12 years representing FWCS District 3. Board President Mark GiaQuinta presented Mr. Olinger with the "Distinguished Hoosier" award from Governor Mitch Daniels.

Vouchers

Dr. Robinson presented the vouchers for the period ending December 8, 2008, with the recommendation the vouchers be approved. A motion was made by John Peirce, seconded by Jon J. Olinger, that the vouchers appearing in the listing dated December 8, 2008, be approved without exception. Roll Call: Ayes, unanimous; nays, none.

Goals for Expenditure Categories Dr. Robinson presented the following recommendation concerning the Goals for Expenditure Categories:

RECOMMENDATION: It is recommended that the Board approve a resolution to set expenditure category goals for the 2008-2009 school year. The goal is to strive to improve upon the current percentages between the expenditures for the student instructional categories and the other expenditure categories.

RELATED INFORMATION: Beginning with the 2007-2008 school year, school districts are required to establish goals for each category of expenditures that will increase the school corporation's allocation of taxpayer resources directly to student instruction and learning, in light of the unique circumstances present in the school corporation. The Department of Education reported the following percentages:

FWCS student instructional expenditures as a percent of the total were just .1 percent lower that the previous year. However, FWCS is 8.9 percentage points greater than the state average.

DECEMBER 8, 2008 RESOLUTION FOR GOALS FOR EXPENDITURE CATEGORIES

WHEREAS, the Fort Wayne Community Schools Board of Trustees, Allen County, has adopted a 2009 budget;

WHEREAS, P.L. 191-2006 states that beginning with the 2007-08 school year, each governing body shall establish goals for each category of expenditures that will increase the school corporation's allocation of taxpayer resources directly to student instruction and learning, in light of the unique circumstances present in the school corporation.

WHEREAS, The State Board of Education has approved the following definitions:

- A. "Student Instructional Expenditures" are: (1) student academic achievement expenditures plus (2) student instructional support expenditures.
- B. "Other Expenditure Categories" are: (3) overhead and operational expenditures plus (4) non-operational expenditures.

WHEREAS, Fort Wayne Community Schools believes that the educational preparation of all students be addressed in a manner that maximizes the individual student's potential.

NOW THEREFORE, BE IT RESOLVED, Fort Wayne Community Schools shall review on an annual basis each of these expenditure categories and how to improve student achievement. Fort Wayne Community Schools will strive to improve upon the current levels (percentages) between the expenditures for the student instructional expenditure categories and the other expenditure categories as described in IC 20-42.5 for the next fiscal year. However increasing the percentages in the student instructional expenditure categories and maintaining certain ratios between the "Student Instructional" and "Other Categories" may be negatively impacted by unique circumstances that the Fort Wayne Community Schools might experience such as, but not limited to:

- Loss or reduction of Federal & State Grants which require educational programs to be reduced or eliminated.
- Replacement of retiring teachers (top of the scale) with new teachers who have lower salaries than the retiring teachers.
- School construction related to the district's long-range facility plan.

A motion was made by Jon J. Olinger, seconded by Mitch Sheppard, that the recommendation concerning the Goals for Expenditure Categories be approved. Roll Call: Ayes, unanimous; nays, none.

Recommendation to Extend School Bus Bid

Dr. Robinson presented the following recommendation concerning the Recommendation to Extend School Bus Bid:

RECOMMENDATION: It is recommended that an award be made to extend the school bus bid opened in October 2006.

Cardinal Bus Sales, LLC, Greenfield, IN Two 84-passenger buses Four 24-passenger buses with lifts \$477,980.00

The bid also includes a fair market value allowance of \$72,000.00 for trade-in buses.

RELATED INFORMATION: Indiana purchasing law allows for the extension of awarded bid contracts subject to the agreement of the vendor and the purchasing agency. FWCS included language in the 2006 bus bid specifications referring to this provision. By extending the 2006 bus bid, bus prices remain at the 2006 rate.

FWCS has experienced fewer problems and less recalls with the current brand and model which ultimately represents less maintenance costs.

The bid is part of the scheduled replacement of the bus fleet. Funding for these purchases will be from the Bus Replacement Fund.

A motion was made by Jon J. Olinger, seconded by Mitch Sheppard, that the recommendation concerning the Recommendation to Extend School Bus Bid be approved. Roll Call: Ayes, unanimous; nays, none.

Bid Recommendation for Special Purpose Buses, PB #BD100120 Dr. Robinson presented the following recommendation concerning the Bid Recommendation for Special Purpose Buses, PB #BD100120:

RECOMMENDATION: It is recommended that an award be made to the lowest responsible and responsive bidder meeting specifications and quality standards.

RELATED INFORMATION: The bid is part of the scheduled replacement of the bus fleet per Section 2 of the Bus Replacement Plan which addresses additional bus needs for 2009. Funding for these purchases will be from the Bus Replacement Fund.

Invitations to Bid were mailed to six prospective bidders with three responding.

RELATED INFORMATION: On Monday, November 18, 2008, Fort Wayne Community Schools and Fort Wayne Nurses Association reached a tentative agreement that included transitioning the Nurses contract from calendar year to fiscal year in 2009. In addition, the following contract article was also amended:

• Article XI – Registration – Nurses working Registration will be paid for three hours preparation at the regular hourly rate.

Blackhawk Middle School 2010 Field Trip – New York City and Europe Dr. Robinson presented the following recommendation concerning the Blackhawk Middle School 2010 Field Trip – New York City and Europe:

RECOMMENDATION: It is recommended that the Board approve the field trip request for Blackhawk Middle School to send approximately 40 students to New York City and Europe in June 2010.

RELATED INFORMATION: Blackhawk Middle School students will be participating in a 12-day tour sponsored by Education First (EF) Educational Tours. EF provides full-time tour directors in NYC and Europe. Students will travel to NYC, London, Amsterdam and Paris with visits to Ellis Island, Tower of London, Anne Frank House, the Louvre and other highlights included. This tour is aligned with 6th and 7th grade standards. Students will benefit by enhancing their understanding of the five themes of Social Studies: culture, economics, history, government, and geography.

The field trip will begin after June 9, 2010 (after school is dismissed). The students will be accompanied by Blackhawk Middle social studies teachers: Elise Olson, Rolunda Suttle, Erin Baumgartner, and Wendy Wichern.

Social studies teachers Elise Olson and Rolunda Suttle are responsible for the planning of this field trip. Tim Matthias is the principal.
