RECOMMENDATION: It is recommended that the Board recognize Derek Carpenter for winning the state championship in individual singles boys tennis.

RELATED INFORMATION: South Side senior Derek Carpenter recently won the state championship in individual singles boys tennis. Derek won 10 post-season matches to earn the state title. He finished his career with a 99-13 record, including 36-0 in the SAC. He played all 112 matches at #1 singles and made the state finals his last three years. In addition, Derek was named to first team all-state for the past three years and is the career wins leader for South Side High School.

Dr. Robinson presented the following recommendation concerning the Allen County Public Library Board Appointment:

RECOMMENDATION: It is recommended that the Board reappoint Alan McMahon to the Board of the Allen County Public Library.

RELATED INFORMATION: Mr. McMahon has been serving since December 1999. His new term will begin January 1, 2008, and end December 31, 2011. Fort Wayne Community Schools makes two appointments to the Library board. Dee Klocke fills the second position and her term will end December 31, 2010.

Dr. Robinson presented the following recommendation concerning the Ratification of Nurses Association Contract:

RECOMMENDATION: It is recommended that the Board ratify revisions to the collective bargaining agreement between Fort Wayne Nurses Association and Fort Wayne Community Schools.

RELATED INFORMATION: On November 19, 2007, Fort Wayne Community Schools and the Nurses Association reached a tentative agreement on an Article negotiated per Article XXIIA of the contract. The revision to the 2007-2011 contract is in **bold** as follows:

- Article XII: Duration of Work Year
 1. All employees not on a 46-work week schedule, shall be scheduled to work five (5) days before school opens **and one (1) day after school closes should the school year be extended beyond the official school year calendar**, in addition to the regular school year.

A motion was made by Carol J. Coen, seconded by Jon J. Olinger, that the recommendation concerning the Ratification of Nurses Association Contract be approved. Roll Call: Ayes, unanimous; nays, none.

Dr. Robinson presented the following recommendation concerning the Student Discipline Appeal:

RECOMMENDATION: It is recommended that the Board approve the recommendation of the Superintendent to deny an appeal in a student discipline case.

RELATED INFORMATION: A student has appealed an order of expulsion to the School Board. The Board heard the presentations of the parent and the school on December 6, 2007. It is recommended that the Board deny the appeal.

A motion was made by Mark GiaQuinta, seconded by Mitch Sheppard, that the recommendation concerning the Student Discipline Appeal be approved. Roll Call: Ayes, unanimous; nays, none.

Dr. Robinson presented the following recommendation concerning the Refugee Children School Impact Grant:

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of the Refugee Children School Impact Grant for 2007-2008 in the amount of \$32,000.00 from the Division of Language Minority and Migrant Programs of the Indiana Department of Education.

RELATED INFORMATION: Funds from this grant will allow for the continuation of a range of services for the district's refugee students who participate in the English as a Second Language (ESL) program. The grant supports a refugee remediation assistant to assist with the enrollment and placement of refugee students as well as ongoing academic support. The grant also supports professional development for staff and instructional materials for refugee students.

This non-competitive grant written by Emily Schwartz Keirns, ESL coordinator, supports advancement intended and outlined in the FWCS Strategic Plan, Strategy 1: *We will ensure high levels of learning for all students*

A motion was made by Carol J. Coen, seconded by Mitch Sheppard, that the recommendation concerning the Refugee Children School Impact Grant be approved. Roll Call: Ayes, unanimous; nays, none.
