RELATED INFORMATION: Reasonable allowances and contingencies are included in base bids for most projects because of conditions or fees not specifically known at the time bids are taken. The use of these allowances and contingencies is authorized by the administration only after review by Facilities Department administrators and relevant architectural and engineering firm personnel. To avoid major delays in construction projects, change order decisions are generally required and made prior to an official Board meeting. In the event a major change in project scope is needed, a recommendation is made to the Board for approval prior to proceeding with the project.

These change orders represent a net decrease of \$33,634.99, or -0.53 percent, on the construction contracts that total \$6,295,453.00.

RELATED INFORMATION: This bid is for 490 food items to be used in the school lunch program at the Food Service Center and the 11 cooking kitchens from January 15, 2007 through July 20, 2007. The bid includes such items as fruits and vegetables, meat, and staples such as flour, sugar, and salt. The specifications for this bid indicated that FWCS reserves the right to award bids such that no fewer than ten (10) items are supplied by any one vendor.

A comparison of prices by item is on file in the Purchasing Department and may be reviewed upon request.

Bids were mailed to twelve prospective bidders with five responding.

Overall, the prices of the recommended bidders reflect a less than one percent increase when compared to the last bid opened in May 2006.
