Group Health Plan Renewal Dr. Robinson presented the following recommendation concerning the Group Health Plan Renewal:

**RECOMMENDATION**: It is recommended that the Board renew the administration contract with Anthem Blue Cross and Blue Shield effective January 1, 2018 through December 31, 2018.

RELATED INFORMATION: Anthem acts as a third party administrator for the FWCS Group Health Plan, providing employees with access to broad-based PPO providers and network discounts. In addition, they manage claims processing services and all aspects of the provider network, perform utilization and medical management functions, and provide enrollment support and customer service for our employees.

Administrative fees for medical, dental and vision are increasing 3.5% or about \$44,683. Reinsurance premiums are increasing 16.03% or about \$292,443. Administrative fees and reinsurance premiums are \$3,436,292 or approximately 6.7% of the total expected cost of the health plan, \$51,162,314.

This supports FWCS District Goal III: Operate Effectively with Integrity and Fiscal Responsibility.

# EXTENSION OF CONTRACT OF EMPLOYMENT BETWEEN FORT WAYNE COMMUNITY SCHOOLS AND DR. WENDY Y. ROBINSON

This extension of contract of employment (hereinafter "Extension") is entered into by and between the Fort Wayne Community Schools, an Indiana consolidated school corporation, of Fort Wayne, Indiana, through its Governing Body acting in its official capacity pursuant to IC 20-26-5-4, (hereinafter "FWCS") and Dr. Wendy Y. Robinson of Fort Wayne, Indiana (hereinafter the "Superintendent") and collectively referred to herein as "Parties" which is intended to set forth the terms and conditions of the employment relationship between FWCS and the Superintendent.

WHEREAS, on the 21st day of December, 2016, FWCS and the Superintendent entered into a Contract of Employment Between Fort Wayne Community Schools and Dr. Wendy Y. Robinson (hereinafter "Agreement"); and,

WHEREAS, FWCS and the Superintendent have agreed to an extension of the term of employment of the Superintendent under the Agreement; and,

WHEREAS, FWCS and the Superintendent have agreed to embody the terms and conditions in this Extension for her employment.

NOW, THEREFORE, in consideration of the agreements hereinafter set forth and the terms of the Agreement, FWCS and the Superintendent agree as follows:

- 1. <u>Reaffirmation of Agreement</u>. All of the terms and obligations contained in the Agreement, as modified herein, shall remain in full force and effect. FWCS and the Superintendent hereby ratify, confirm and reaffirm the Agreement in its entirety except as expressly provided herein.
- 2. <u>Term of Employment</u>. The Superintendent's employment as Superintendent under the terms and conditions of the Agreement and this Extension, shall be deemed to have begun on July 1, 2016, and conclude on June 30, 2020, unless terminated prior to that date as provided for in the Agreement. The Agreement and this Extension may be renewed by mutual agreement in writing. The parties agree that there shall be no automatic renewals or extensions of the Agreement and this Extension, by operation of law or otherwise, beyond June 30, 2020. Any renewals and extensions of the Agreement and this Extension beyond June 30, 2020, must be in writing in a separate document and agreed to, and approved by, FWCS at a public meeting.
- 3. Compensation and Benefits. In addition to all other compensation and benefits provided to the Superintendent in the Agreement and this Extension, FWCS ratifies its obligation to deposit "additional deferred compensation" as set forth in Section 3(I) of the Agreement. FWCS shall deposit the sum of \$7,500.00 into a IRS Code Section 401(a) defined contribution plan ("Plan") on December 1, 2019, provided that the Superintendent remains employed as Superintendent on December 1, 2019. FWCS shall deposit the sum of \$7,500.00 into the Plan on or before July 15, 2020, provided that the Superintendent remains employed as Superintendent through the end of the term of the Agreement and this Extension.
- 4. Entire Agreement/Amendment. The Agreement and this Extension, together with the regular teacher's contract between the Parties, constitutes the entire agreement between the Parties and replaces and supersedes all prior understandings, agreements, contracts and addenda. To be valid, any amendment to the Agreement and this Extension must be in writing and have been approved by the Board at a public hearing. The Agreement and this Extension is intended by the parties to extinguish any and all obligations between them from any prior agreements or addenda to those agreements.

- 5. <u>Savings Clause</u>. If, during the term of the Agreement and this Extension, it is found that a specific clause of the Agreement or this Extension is illegal under Federal or State law, the remainder of the Agreement and this Extension, not affected by such a ruling, shall remain in force.
- 6. <u>Conflict Resolution</u>. The Board and the Superintendent agree that in the event a dispute should arise with respect to the interpretation of the terms of the Agreement or this Extension, they will submit the dispute to binding arbitration under the rules established by the American Arbitration Association. Nothing contained herein shall be deemed a forfeiture of any rights conferred to the Superintendent by virtue of her contract as a teacher in the State of Indiana.
- 7. <u>Recitals as Substantive Provisions</u>. The Parties intend that the Recitals to the Agreement and this Extension be incorporated herein as substantive provisions to the Agreement and this Extension.
- 8. <u>Applicable Law</u>. The laws of the State of Indiana shall govern the Agreement and this Extension.

Comments -Public Meeting on Proposed Extension of Superintendent Contract There were no public comments.

Board comments:

Steve Corona is pleased with the proposal to extend the superintendent's contract for one year and said that good superintendents are hard to find. The financial considerations are the same and the terms are reasonable. He has no problem supporting the extension.

Tom Smith said he has complete confidence in Dr. Robinson.

Julie Hollingsworth is pleased that Dr. Robinson is willing to extend her contract by one year. The Board will vote on this extension at a special meeting on December 18, at 5 p.m.

Glenna Jehl said she is a little conflicted about supporting a contract extension. The current contract was signed just a year ago and it is premature to extend it before evaluating how the next few years go. Glenna really admires and appreciates Dr. Robinson but she doesn't consider it to be too early to think about new leadership. She doesn't feel there is adequate stress on academic achievement and that has an impact on our community.

#### Comments

Steve Corona thanked Maria Norman for attending a fall conference for Latino women. The young women she spoke with were very touched by this opportunity.

Glenna Jehl spoke of the FWCS/Legislative Lunch that she attended recently. High School seniors were also in attendance and spoke with the legislators about their concerns regarding changes coming with Graduation Pathways. The students were amazing and gave very articulate explanations on why our legislators might want to pause before rushing forth with this new program.

Tom Smith received a guided tour this week of the Construction Trades building. He was greatly impressed and thanked the staff for allowing him to nose around and ask questions. Trade skills are in high demand and the school is doing a great job of training students and taking them out into the community to work with other companies.

Maria Norman also had an opportunity to tour the Construction Trades area as well as visit with students in the TV Studio, Graphic Design and Automotive Departments. It was good to see how the community was engaging with the trades that we offer at Anthis. Maria also thanked Steve for the opportunity to visit with young ladies at the Latino women event.

Julie Hollingsworth, Board President, appreciated the pamphlet from Sodexo which shared a lot of good and interesting information about their company. Julie also spoke of her concerns with the State Board of Education vote to move ahead with the Graduation Pathways in spite of the many concerns and opposition from educators throughout the state.

Next Meeting The next meeting will be a special Board meeting to vote on the extension of the superintendent's contract on Monday, December 18, 2017 at 5:00 p.m. in the Lester L. Grile Administrative Center.
