Board members commented that Kevin Brown's absence was a rare occurrence in his four years on the Board. Members wished Kevin a speedy recovery.

Dr. Wendy Robinson, superintendent, presented the following information and recommendations concerning awards and recognitions:

American Montessori Society Re-Accreditation for Bunche Montessori Early Childhood Center **RECOMMENDATION**: It is recommended that the Board recognize Bunche Montessori Early Childhood Center for its re-accreditation by the American Montessori Society.

RELATED INFORMATION: With 11,000 members, the American Montessori Society (AMS) is the largest Montessori organization in the world. Being accredited by the AMS is an affirmation that a school represents an authentic model of the educational philosophy and practices of Maria Montessori and demonstrates compliance with rigorous standards. Bunche Montessori Early Childhood Center is the only public Montessori school that is accredited. After visiting Bunche from December 5 – 8, the AMS Accreditation Team announced that the school has been re-accredited.

Appointment of Common Wage Committee

RELATED INFORMATION: Each year FWCS conducts a Common Wage hearing to determine the most common wage for each class of work. The common wage determines the minimum wage to be paid on upcoming FWCS construction projects.

By statute, there are five members of the Common Wage Committee. Three appointments are external, including one representing labor, one named by the Governor, and one appointed by the County. Two members are appointed by FWCS, one representing industry and one taxpayer in our district.

RELATED INFORMATION: At its October 11, 2010 meeting, the Board of School Trustees approved the 2011-2013 Capital Projects Plan. Project architects/engineers need to be appointed now to allow sufficient time for planning and bidding of the projects to ensure completion during the summer of 2011.

RELATED INFORMATION: Reasonable allowances and contingencies are included in base bids for most projects because of conditions or fees not specifically known at the time bids are taken. The use of these allowances and contingencies is authorized by the administration only after review by Facilities Department administrators and relevant architectural and engineering firm personnel. To avoid major delays in construction projects, change order decisions are generally required and made prior to an official Board meeting. In the event a major change in project scope is needed, a recommendation is made to the Board for approval prior to proceeding with the project.

Temporary Inter-fund Loan **RECOMMENDATION**: It is recommended that the Board approve all inter-fund loans necessary to eliminate deficits in certain funds of the corporation as of December 31, 2010.

RELATED INFORMATION: It is possible that property tax distributions from Allen County will be below budget for 2010. We won't know until the end of December when the final tax distribution is received. If property tax revenue is below expectations, temporary cash deficits may develop by December 31, 2010. State statute allows temporary transfers between funds if certain requirements are met. The treasurer will make all necessary transfers and report the loans to the Board in January 2011.

Student Management Dr. Robinson presented the following recommendation concerning the Student Management System:

RECOMMENDATION: It is recommended that the Board approve purchasing the Pinnacle Student Information System from GlobalScholar of Greely, Colorado for \$469,900.

RELATED INFORMATION: In the fall of 2009, FWCS Technology department began searching for a new student management system to replace the CIMS (Comprehensive Information Management for Schools) system that has been in operation since 1998. A public Request For Proposal was issued and eight vendors responded with proposals. GlobalScholar's Pinnacle system is the recommended system.

The initial purchase and implementation costs of \$469,900 were budgeted as a part of the Technology Infrastructure budget and will be paid using the Universal Service Fund reimbursement account. The subsequent annual maintenance fees of \$96,000 will be paid from the Technology Capital Projects Fund Maintenance account.

2011 Northrop Field Trip to Germany

Dr. Robinson presented the following recommendation concerning the 2011 Northrop Field Trip to Germany:

RECOMMENDATION: It is recommended that the Board approve the field trip proposal for Northrop High School German students to visit our sister-city Gera, Germany in June, 2011.

RELATED INFORMATION: Northrop High School has enjoyed a sister-school relationship with the Goethe Gymnasium in the Fort Wayne sister-city of Gera, Germany for 18 years. In June 2011, German language students would like to reciprocate the latest visit from Gera students. Eight to 15 Northrop students would be accompanied by their German teacher, Mr. Kris Kallmeyer, a veteran of six previous exchanges, along with several chaperoning parents.

Plans are to leave Indiana following graduation and return three weeks later. During the trip, students will stay in Gera with host families of students attending the Goethe Gymnasium. While there, students will attend classes and make excursions to Dresden, Eisennach, Leipzig, Weimar, and Buchenwald. There will be overnight excursions to Frankfurt and Berlin.

The opportunity to participate will be extended to all non-freshman students of German with strong preference given to those who will have completed two years of German by the departure date and have maintained a "B" average.

Language Teacher Kris Kallmeyer is responsible for the planning of this field trip which supports District Goal I: *Achieving and Maintaining Academic Excellence*. Barbara Ahlersmeyer is the principal.
