

2023 – 2024 North Valley Christian Academy High School Parking Permit Procedures

What is required?

The attached 2023-2024 parking permit application must be completed and the **\$75 parking permit fee** paid. (Cash, Check or FACTS charge accepted).

A copy of the student's driver's license, current insurance, and registration must be attached with the parking permit application.

Please double check the expiration date on your insurance and registration prior to submitting your application.

Failure to provide all correct documentation could result in the delay/denial of parking permit.

Who Is Eligible for a Parking Permit?

Senior students have first the opportunity to purchase permits.

Any remaining spots will be available to Junior students by means of a lottery.

Students will receive their parking permit and assigned spot once the completed application, required documents, and payment are received.

All Parking Lots are Off-Limits to Students During the School Day

Upon arriving on campus, students are to get out of their cars and report to the building area. Permission to return to the parking lot during school hours must be obtained from an administrator or front office.

Students must exit only through the front office if permitted to access the parking lot during school hours. This includes leaving campus for lunch (eligible Juniors and Seniors only). Violation of this policy will result in disciplinary action.

2.	Parking permits may be revoked after 10 unexcused absences to 1 st or 2 nd period class.	
3.	North Valley Christian Academy reserves the right to have any vehicle towed, at the owner's expense, if it is in violation of any parking regulation.	
4.	Under <u>NO</u> circumstance may a student sell, trade, or allow others to have or use their parking permit. This includes but is not limited to siblings and carpooling.

I realize that if I violate any rule governing the privilege of parking, I will face consequences that include, but are not limited, to those cited herein.
