Plan Descriptions

Throughout the 2020-21 school year Lincoln Unified has involved stakeholders in planning intended to address the challenges to students, families and schools, as a result of the pandemic and school closures. Parents provided input as to how the district could best support families and students. Our Parent Advisory group and DELAC both approved of summer learning opportunities being offered at individual school sites. Parents also expressed a strong desire for learning opportunities and materials that were not digitally based. The district consulted with site principals to determine the needs of each school site. Site administrators consulted with teachers and school staff to plan for a robust summer program. Additionally, site administrators and school staff were monitoring students and the need for additional credit recovery opportunities was identified. As the plan began to take shape elements being proposed were shared with stakeholders for additional feedback. This plan is the result of all stakeholder input and the work of the Superintendent's cabinet to address the identified needs and recommendations.

A description of how students will be identified and the needs of students will be assessed.

Throughout this last year the district has maintained the district assessment calendar continuing to use local measures such as DIBELS and MAP to monitor student progress. In addition to these measures teachers evaluate through formative assessment student progress and measure progress in our on-line adaptive programs, Dreambox and Lexia. Students were identified for additional support using the assessment results and based on the recommended guidelines with priority being given to English Learners, socioeconomically disadvantaged, homeless, foster youth and students who had failed to engage regularly during distance learning. The Summer Program has

student assessment embedded and these assessment results will be used to monitor student progress and to determine what additional supports may be needed for students into the next school year.

A description of how parents and guardians of students will be informed of the opportunities for supplemental instruction and support.

School staff communicated directly with parents and guardians to inform them of the opportunities for supplemental instruction and support. Students identified based on the established criteria were invited to participate in the programs being offered. This communication was made through mail, our Parent Square communication platform and by phone. Bilingual interpreters assisted with communication for families who speak Spanish.

A description of the LEA's plan to provide supplemental instruction and support.

The district is planning an expanded Summer Program for students. All TK-8 students will receive a backpack with summer learning activities and family engagement activities. Students in need of additional support will be invited to attend in-person summer programs being offered at most school sites. The in-person summer program for K-8 students will be four hours per day. Parents who are not comfortable with in-person learning may opt to have their student participate in a virtual program where a paraprofessional will check in regularly and provide additional support to students as they work through the materials and lessons in the backpack. Students in grades 9-12 will have the opportunity to participate in credit recovery five hours a day in-person and on-line using the Apex courses. The credit recovery program has also been expanded this year to accommodate the increased needs of our students. There will be two sessions offered and students who choose to participate will be able to complete courses both in-person or on-line. Students who may not have access to adequate internet for the on-line courses will be able to work in-person using the school wifi. We have also expanded the counseling services available during the Summer Program from what we have typically provided to support the social emotional needs of students. We plan to evaluate our 2021 Summer Program and will use this information to plan for extended learning during the Summer of 2022.

A description of how ELO Grant funds are being coordinated with other federal Elementary and Secondary School Emergency Relief Funds received by the LEA.

Lincoln Unified is coordinating the use of the Expanded Learning Grant and other federal ESSER funds by budgeting all funding sources across multiple categories to best meet the needs of the local district, staff, students and community. The Expanded Learning Grant funds are primarily budgeted towards extending instructional time, supports for credit deficient students and integrated student supports such as counseling and mental health services. The ESSER funds will primarily be budgeted towards school facility safety needs, personal protective equipment, COVID-19 testing costs, mental health services and counseling supports, instructional supports and professional development efforts.

Expanded Learning Opportunities Grant Plan Instructions: Introduction

The Expanded Learning Opportunities Grant Plan must be completed by school districts, county offices of education, or charter schools, collectively referred to as Local Educational Agencies (LEAs), that receive Expanded Learning Opportunities (ELO) Grant funds under California *Education Code (EC)* Section 43521(b). Instructions: Plan Requirements

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

For purposes of this requirement

- “Supplemental instruction” means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- “Support” means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students’ needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.
- “Students at risk of abuse, neglect, or exploitation” means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

EC Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the

supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (*EC* Section 43522[h]).

The seven supplemental instruction and support strategies are:

1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
 - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
 - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
 - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students' college eligibility.
6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students' social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

Fiscal Requirements

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.

- An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
