3. SCHOOL DISTRICT HIGHLIGHTS: Dr. Satterfield stated that he would include highlights in the Director's Report.

4. PRINCIPALS' REPORTS:

GRAND TOTALS

4.A. Trousdale County Elementary School - Ms. Badru reported increased enrollment with present K-5 enrollment up to 703 students. She stated that the school is doing the same health procedures that include cohorting, contact tracing, and the use of water filling stations. She stated that physical distancing is tough because of so many students in a classroom at one time but that teachers are trying to distance students as much as possible. Ms. Badru informed the

Board of the challenges she is experiencing due to having just a few substitute teachers and how she has had to innovate by combining classrooms just to keep schools open. She explained how keeping good seating charts helps limit the amount of student quarantines, stating that she is doing everything to keep her school open. Ms. Badru also explained how the school is utilizing video through Google Classroom to ensure a continuity of learning for students who are quarantined. Ms. Badru said that the school exceeded State proficiencies in three of eight categories 3rd, 4th, and 5th grade Reading. She highlighted 4th grade Reading that met the State absolute performance goal while utilizing a hybrid model for the entire school year. She stated that 2nd grade proficiencies were less than anticipated and provided room for growth. Ms. Badru featured the school's implementation of high-dose, low-ratio tutoring to address learning loss in Reading and Mathematics. She stated that almost all of the school's teachers attended the summer Reading 360 Literacy trainings which helps teachers utilize their high-quality curriculum that has already been in place for several years.

- 4.B. Jim Satterfield Middle School Mr. McCall reported that the school's present enrollment stands at 322 students including 33 new students. He stated that COVID health protocols have been adapted because of the return of all students to school; however, the school is physically distancing when possible, cohorting students, utilizing water filling stations, and electric hand dryers to help prevent the spread of COVID. Mr. McCall provided the school's distance learning procedures for students who may be quarantined noting that all students are provided Chromebooks, classroom videos, and live Google meetings that can be accessed by Google Classroom. Mr. McCall discussed 2020-21 school achievement results noting that the school exceeded the State in eight of twelve reporting categories. He highlighted the 8th grade's successes noting that ELA proficiency results were 7.5% higher than the State while 8th grade Mathematics results were 12% higher than State proficiencies. Mr. McCall noted that the middle school was first among Upper Cumberland districts in five of twelve reporting categories. He stated that the big grow for the school is academic growth. which is challenging because of high results in past years. Mr. McCall concluded by stating the goals of the district that focuses on learning acceleration and professional development around intellectual curriculum preparation.
- **4.C. Trousdale County High School** Ms. Dickerson stated that the school's enrollment is presently 420 with approximately 60 more students than the close of school in May. She informed the Board about the COVID precautions that the school is utilizing, noting that the students really like the water filling stations. She stated that protective masks are available for all students and that she was pleasantly surprised at the number of students who are presently wearing a protective mask. She said that she added another lunch period to allow for physical distancing for which they have seating charts to help prevent unnecessary quarantines. She is encouraging as much outdoor physical education as possible to help reduce the aerosol spread of COVID. Ms. Dickerson noted that students are happy to be back in school this year and she has noticed fewer discipline problems to date. She explained the school's procedures for using Google Classroom when students are quarantined and the familiarity that students have developed from the hybrid model last year, noting that the procedures in place are working well for students. Ms. Dickerson said she was presently surprised by the 2020-21 achievement results noting the combined effort of teachers, students, and their parents. She touted that the school was first in the Upper Cumberland in Math 1, US History, and second in Biology. She said the challenge for 2021-22 will be to move more students to the highest achievement level

(mastered) while reducing the number of non-proficient students (below) to proficiency (approaching). She described how the school will use the available data to develop the school's improvement plan that is due in September. Ms. Dickerson concluded by informing the Board how the school is using on-going professional developments such as the district's work with TNTP and NIET to ultimately improve learning outcomes for students.

4.D. Student School Board Representative – Phillip Zarichansky provided the Board with sports schedules noting that the school had its first pep rally today. He said that Friendship is only accepting online tickets for tomorrow's game and that the volleyball team will be hosting three home games next week. Phillip described the new "Senior Seminar" class that has been implemented at the school this year that is intended to best prepare students for post-secondary educational opportunities. He noted that being back fulltime is much welcomed by students noting that it is much easier to learn in person. However, Google Classroom is a good alternative for students who may be quarantined due to COVID exposures.

5.B. Academic and Goal Updates - Dr. Satterfield emphasized that the goal of the district is to keep schools open for in-person learning. In order to achieve the goal, it is imperative for 1) parents to keep sick children home, 2) when parents are in doubt about what to do, please contact the school's nurse before sending a child to school, 3) cohort students into smaller groups to prevent large scale quarantines, and 5) physical distance when possible. He highlighted present health practices that are being utilized at all schools that include: daily symptom screenings, contact tracing, quarantining, hand washing, physical distancing where possible, COVID testing of employees, and utilizing of water filling stations and electric hand dryers. He noted that everyone has a responsibility to help keep schools open for in-person learning. When students are quarantined, he explained that the district's blending learning plan is implemented to provide a continuity of student learning. He stated that all students in grades K-12 have a personal Chromebook and that all teachers have been trained to use Google Classroom that serves as the district's learning management system. Within Google Classroom, teachers will post classroom videos, conduct live Google meets, and students will obtain lessons and submit assignments though the Google learning management system. He

noted that our teachers and students have experience with the process due to the hybrid model that was used for the entire 2020-21 school year.

Dr. Satterfield discussed the district's planning to address learning loss due to learning interruptions caused by the COVID pandemic. A major initiative is high-dose, low-ratio math tutoring that will be held within the regular school day for students in grades 3-5 for a minimum of two years. He explained how the elementary school will utilize the same high-dose concept for K-5 reading intervention where the intervention team will be inserted into the regular classroom to provide small group reading intervention for all students. In addition to utilization of high-quality curriculum and materials, the district has entered into a contact with TNTP to provide year-long K-12 ELA and Mathematics supports that focus on curriculum preparation and student engagement.

Dr. Satterfield concluded by summing up the Principal's achievement data reports stating that Trousdale County tested 99.1% of its students, which is one of the highest participation rates in Tennessee. He stated that participation of all students was essential in order to evaluate student, school, and district performances necessary to inform academic programming to address learning loss going forward. He stated that although the district used a hybrid model for the entire 2020-21 school year, the district exceeded the State in 59% of all academic reporting categories. He stated that the work ahead is to decrease the amount of students that had fallen into the non-proficient categories of approaching and below for the 2021-22 school year.

5.C. Project Updates - Dr. Satterfield informed the Board that the contract with Romach to replace the middle school windows had been completed and that enough funds have been amended in ESSER 2.0 to pay for 100% of the window replacement project with federal relief funding. He said the elementary roof repair contract was still on-going due to the company's trying to add taxes to the project cost. He concluded by informing the Board that the home side of the bleacher replacement had been completed and that the company would be addressing the visitors side within the week. He stated that the stadium would be ADA and handicapped compliant upon completion.





 - 3. Shorts, shirts, divided skirts, dresses and culottes are allowed. Each must be hemmed and be at the top of the knee or longer.
 - 4. All trousers, pants or shorts must be worn at the waist totally covering undergarments at all times, including boxer shorts. Pants and trousers must be worn with both legs down (not one leg rolled up), and may not extend past the sole of the shoe. No holes, rips or tears shall exist on any garment.
 - 5. All coats (outerwear) shall not be worn inside the building during the school day.
 - 6. All clothing and accessories shall be free of the following: profanity; weapons; sexually suggestive phrases or images; racial or ethnical slurs / slogans; gang symbols or disruptive groups; alcohol, tobacco, drugs or advertisements for such products.
 - 7. Earrings (for pierced ears) are the only type of piercing jewelry that may be worn.
 - 8. All tattoos must be covered by appropriate clothing.
 - Safe and appropriate footwear must be worn at all times, shoe laces must be tied or tucked in shoes. Inappropriate footwear includes, but is not limited to, roller skates, skate shoes, cleated shoes and bedroom slippers.

Dress Code 6.310

10. No head coverings exceeding 2 ½ inches in width shall be worn inside the building (except for religious or medical reason). Bandanas may not be worn anywhere on one's person.

11. No curlers, picks, combs, or hair rakes in the hair.

12. No sunglasses or permanently tinted glasses (without prescription).

13. No dog collars, chains, wallet chains, safety pins, spike jewelry or fishhooks worn as jewelry, accessories or ornamentation.

14. No gloves in the building.

15. No pajamas, loungewear, dorm pants.

16. No fringed garments worn in shop areas which contain machinery.

17. No clothing that would impair the health and safety of the student during the normal school day.

18. Athletes, band members, cheerleaders may wear team issued apparel on game days.

19. Principals may alter the dress code not to exceed eight (8) days during a school year.

Further clarification / other requirements:

a. Form fitting leotard/spandex type clothing (including sports bras, camisoles, tank tops) is not allowed unless proper outer garments cover it. (Leggings, tights, skinny jeans, and jeggings) are not allowed unless the hips are covered by proper garments.

b. See through or mesh fabric clothing may only be worn over clothing meeting requirements.

c. Clothing not properly buttoned, zipped, fastened, or with inappropriate holes or tears shall not be worn.

d. Clothing and footwear traditionally designed as undergarments or sleepwear shall not be worn as outer garments.

RE: Recommendation for Teacher Dismissal

Date: August 10, 2021

This memo sets forth charges against Brooke Jenkins, a non-tenured teacher at Trousdale County High School, and recommends her dismissal as an employee of this school system. Ms. Jenkins is charged with insubordination and neglect of duty as defined by Tenn. Code Ann. § 49-5-501.

Specifically, these charges arise from the following events.

After written instruction from the Director of Schools that she could not resign her volleyball coaching position without resigning from her teaching position as well, followed by verbal instruction that she was to continue her coaching duties as assigned, Ms. Jenkins emailed the Director on August 1, 2021, the night before her teaching and coaching duties were scheduled to resume, that she wanted "...to make this unmistakably clear, I am ONLY retiring [sic] from coaching and I will not be coaching any sport in any season from this point forward.." The message demonstrates Ms. Jenkins' refusal to comply and carry out the specific assignments made by the Director of Schools and the Principal, each acting within their own jurisdiction, and for assignments that are reasonable and not discriminatory.

This occurred the week that Ms. Jenkins was suspended from her duties for two days, July 28 and 29, also for insubordination. She was disciplined by suspension after she defied COVID quarantine instructions given by the school nurse that she could either complete the entire period of her scheduled quarantine, *i.e.*, returning to work on day 24 (07/30); or she could return to work on day 20 (07/27) by wearing a full-time mask through day 24 (07/30). Ms. Jenkins indeed elected to return to work early, but she refused to wear the face covering as instructed upon her return day of July 27.

Ms. Jenkins has made it clear that both now and going forward, she does not intend to comply with reasonable directives made by and on behalf of the Director of Schools. This pattern of refusal to respect the assignments and directives given to her represent not only insubordination, but also neglect of duty in that she has failed to perform duties and responsibilities that reasonably can be expected of any teacher.

It is my opinion that Ms. Jenkins' defiance of directives constitutes charges that are sufficient to warrant her dismissal. I hereby request that in your next regular meeting on August 19, 2021, the board certify these charges in accordance with Tenn. Code Ann. § 49-5-511 and thereby authorize Ms. Jenkins' dismissal from employment in the Trousdale County School System.
