1. Payroll dates are subject to change in the event of an emergency.
2. In the event of an emergency snow day occurring on a scheduled payroll date, checks will be distributed on the next school day.
3. \*First pay-date for 10 month instructional and non-instructional contractual (non-hourly) employees.
4. \*\*Employees with annual contractual salaries will be paid the balance of their annual salary in a single check on Wednesday, June 26, 2024. According to Board of Education Policy #6800 Payroll Procedures-ALL paychecks will be mailed on the December 29, 2023 pay-date and ALL paychecks will need to be picked up and signed for on the September 8, 2023 pay-date.
5. TSA: these are the payroll dates that we deduct Tax Sheltered Annuities/403B's from. TSAs are deducted 20 times a year.
6. Dates in parentheses are the dates worked for hourly, overtime and substitutes that will be paid on that pay date.
