BUDGET HEARING Pursuant to ORS 294.453

A Budget Hearing was held on Friday, June 30, 2023, in the administrative office Board Room, located at 1419 NW Valley View Drive in Roseburg, and brought to order by Director Rodney Cotton at 6:00 p.m. pursuant to ORS 294.453. Director of Finance and Operations, Cheryl Northam, presented the proposed 2023-2024 Budget, noting that the Budget Committee approved a General Fund Budget amount of \$127,435,836 on May 17, 2023. The proposed Budget as approved by the committee was duly published in The News Review on June 22, 2023. This Budget Hearing provides a final opportunity for individuals to ask any questions regarding the Budget prior to consideration of adoption by the Douglas County School District 4 Board of Education. The document includes appropriations for expenditures in the 2023-24 Budget. Once approved, the Board hereby levies taxes provided for in the adopted budget at the rate of \$4.0327 per \$1,000 of assessed value for operations from all taxable property within the district.

PUBLIC PARTICIPATION: Director Cotton opened the floor for public input specific to the proposed Budget. Mr. Keith Cubic, Roseburg resident and current Chair of the District's Budget Committee, stated his recommendation that the Board support the committee's recommendation and adopt the 2023-24 Budget.

ADJOURNMENT: With no additional members of the public wishing to comment on the proposed Budget, Director Cotton adjourned the Budget Hearing at 6:04 p.m.

SPECIAL SESSION - SCHOOL BOARD MEETING

TIME/PLACE: A special meeting of the Douglas County School District No. 4 Board of Directors was convened on Friday, June 30, 2023, at 6:04 p.m. in the administrative office board room, 1419 NW Valley View Drive in Roseburg, Oregon, in person and available via Zoom link.

CALL TO ORDER / PLEDGE OF ALLEGIANCE: With Board Chair Howard Johnson experiencing lack of cell service at a remote location, Director Rodney Cotton called the regular meeting to order at 6:04 p.m. and asked Director Charles Lee to lead the Pledge of Allegiance.

ATTENDANCE: Board members attended in person with the exception of Chair Johnson who was apparently unable to obtain connectivity in the remote area where he was attending a wedding rehearsal, and Vice-Chair Larson was supporting her family at a play where her daughter had a lead role. Cabinet members were in attendance as well.

Superintendent Cordon welcomed everyone present in person, as well as those who were joining the meeting remotely.

RESOLUTION 22-23-15: ADOPTING THE BUDGET, MAKING APPROPRIATIONS & LEVYING AD VALOREM TAXES

Director of Finance and Operations, Cheryl Northam, shared that following the Budget Hearing earlier tonight, the Board will now consider adoption of the proposed budget for 2023-24 as approved by the Budget Committee

on May 17, 2023, make appropriations and levy ad valorem taxes. Mrs. Northam asked if there were any remaining questions concerning the proposed budget adoption, and there were none.

Director Charles Lee moved to Adopt the Budget, Make Appropriations and Levy Ad Valorem Taxes. Director Ann Krimetz seconded, and the Motion passed unanimously.

APPROVE CONSTRUCTION PROJECT FOR RESTROOM FACILITIES AT HUCREST ELEMENTARY SCHOOL

Director of Finance and Operations, Cheryl Northam, presented the request for approval of construction of restroom facilities at Hucrest Elementary School as outlined in her memo to the Board. She provided an illustration of the proposed student and staff bathroom space, explaining that there was no access currently available for students who are in that area of the hallway or on the playground. In addition, she pointed out that in 2023-24, the Developmental Learning Center (DLC) and Emerging-K classrooms will be established in the area. While ZCS Engineering was creating plans for another district site, they were asked to also create a plan for the restroom space pending bond or other funding opportunities. ESSER funds will be utilized for this project.

Director Ann Krimetz moved to approve the request for approval of the construction project for restroom facilities at Hucrest Elementary School. Director Charles Lee seconded, and the Motion passed unanimously. Director Lee noted that these additional facilities are vitally important for Hucrest, adding that you can't add those programs without having sufficient bathroom facilities. He confessed to "sticker shock" but acknowledged that is the way our world is.
