

Kennett Consolidated School District Act 24: Volunteer Affirmation Form

I, (print name) _____, would like to serve in the position of an unpaid volunteer for the Kennett Consolidated School District. Under penalty of law, I affirm that I have been a Pennsylvania resident during the entirety of the ten-year period prior to my signing this Volunteer Affirmation. I am aware that the Kennett Consolidated School District will be relying upon this Volunteer Affirmation for the purpose of complying with Pennsylvania's Child Protective Services Law ("CPSL"). I further affirm that I am not disqualified from service as a school volunteer by reason of having been convicted of any of the following offenses under Title 18 of the Pennsylvania Crimes Code or of an offense similar in nature under the laws or former laws of the United States or one of its territories or possessions, another state, the District of Columbia, the Commonwealth of Puerto Rico or a foreign nation, or under a former law of Pennsylvania:

Section 3123 (relating to involuntary deviate sexual intercourse)	Section 6301 (relating to corruption of minors)
Section 3124.1 (relating to sexual assault)	Section 6312 (relating to sexual abuse of children)
Section 3125 (relating to aggravated indecent assault)	A felony offense under the act of April 14, 1972 (P.L. 233, No. 64), known as The Controlled Substance, Drug, Device and Cosmetic Act, committed within the five-year period immediately preceding today's date
Section 3126 (relating to indecent assault)	The attempt, solicitation or conspiracy to commit any of the above offenses

A Kennett Consolidated School District volunteer who has been a resident of Pennsylvania during the entirety of the previous ten-year period does not need to submit an FBI Report of Federal Criminal History Record (fingerprinting) if this Volunteer Affirmation is completed.

- I have **NOT** been a resident of PA during the entirety of the previous 10- year period & will complete an FBI Report of Federal Criminal History

I hereby affirm that the information contained in this Volunteer Affirmation is correct. I further affirm that in the event that I am arrested for, or convicted of, an offense that would constitute grounds for denying my further participation as a school volunteer, or if I am named as a perpetrator of child abuse, I will provide the Kennett Consolidated School District with written notice no later than 72 hours after the arrest, conviction or notification that I have been listed as a perpetrator of child abuse in the statewide database.
