

## **Enterprise City Schools 2022-2023 Tuition Update**

The 2022-2023 Tuition payment system is live. Invoices were issued through My School Bucks and can be paid through the MSB website/app or cash, check, or card can be taken at the **Central Office located at 220 Hutchinson Street, Enterprise, AL.**

### **ECS Tuition Schedule**

#### Coffee and Dale County Students Outside the Enterprise City Limits

- Beginning with 2022-2023 school year, **\$500** for each of the first two students, **\$250** for each additional student.

#### Special Rates

- Students who live on Ft. Rucker will not be required to pay tuition
- Employees of Enterprise City Schools will pay 10% of the scheduled rate for their children.

\*All decisions regarding enrollment and withdrawal will continue to be made at the discretion of the superintendent or his designees. Tuition must be paid by **June 1st** each year and there will be no refunds once the student has been enrolled and classes have begun. Acceptance will depend upon academic progress, attendance rate, disciplinary records, and available space. Accepted students will be placed in the appropriate school based upon available space and transportation is not guaranteed.

New out of district students wishing to attend Enterprise City Schools during the 2022-2023 school year must complete an out of district enrollment form and pay the tuition in full before being enrolled. Deadline for new out of district applications is **June 15, 2022.**
