Chairman Christian called the meeting to order at 7:05 pm

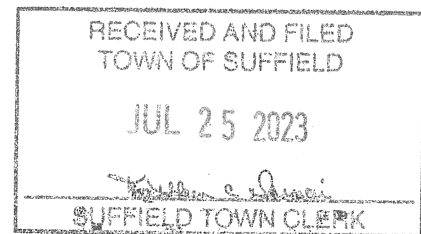
