• Fox Chapel Area High School junior **Alexandra Sroufe** and sophomore **Avanti Muvvala** were selected to receive 2022-2023 National Community Service Awards, presented by the United Nations Association of the USA (UNA-USA) and InnerView Technologies. The awards recognize student commitment and community service impact in support of the UN Global Goals. The program is open to students across the nation and is designed to connect student community service activities, skill development, and commitment to Sustainable Development Goals. In addition to the National Community Service Awards, both Alexandra and Avanti were awarded Zero Hero Awards which are given by the Kroger Co. to students for taking action to help create communities free of hunger and waste.

“The Sustainable Development Goals (SDGs) have been a directional beacon not only for UN member states, but also for their citizens, including, and perhaps especially – their young people,” says Rachel Bowen Pittman, Executive Director of the UNA-USA. “We are thrilled to be involved with a platform that not only helps to capture the impact that young people are having, but to recognize and to celebrate their achievements. Kudos to all those who have committed to staying the course and doing their part to help actualize the SDGs!”

Alexandra has more than 108 hours of volunteering and leading activities, and Avanti has more than 99 hours. At Fox Chapel Area High School, Alexandra and Avanti are the co-chairpersons of community outreach. They have both have been involved with the Gift of Life Marrow Registry, blood drives, local Earth Day cleanups, World Kindness Day events, Cookies for Kids with Cancer, the Greater Pittsburgh Community Food Bank, Fox Chapel Area School District telethon fundraisers, a drive for the Second Avenue Commons shelter, and Fox Chapel Parks Conservancy projects. Additionally, Alexandra led a collection drive for the people of Ukraine; volunteered at a diversity, equity, and inclusion ceiling tile event; and helped collect hygiene products for the Light of Life Rescue Mission. Avanti has also volunteered for the high school’s annual senior citizens luncheon.

According to Fox Chapel Area High School counselor and community outreach sponsor, **Rachel Machen**, both Alexandra and Avanti are passionate about helping people in their community.

“Alexandra and Avanti have taken great initiative when it comes to community outreach and getting our students involved in helping others,” says Mrs. Machen. “They are truly invested in helping our local and high school communities become better places for everyone.”

“What a fabulous group to lift up; these purposeful students are taking action to create a better tomorrow for their communities and the world,” says Kristine Sturgeon, CEO of InnerView Technologies. “High school students have a strong perspective on the most challenging issues and needs facing our communities. They have given us hope as we see a measured increase in breadth and depth of volunteerism by these local leaders and global citizens.”

• A team of Fox Chapel Area High School students was named the overall grand champion in the ‘Burgh Bash National Championships, hosted by the BotsIQ manufacturing workforce program. The team overcame great odds when, on the first day of the competition, their 15-pound BattleBot suffered a

mechanical failure. The team ended up going through the entire consolation bracket of the double-elimination tournament with a record of 9-0 and placed second in the battle portion of the event. Averaged with the team's outstanding engineering documentation scores, the team, nevertheless, was named the overall grand champion.

Junior **Eduardo Phelan-Vidal** was responsible for the research, documentation, primary design, and assembly of the BattleBot's frame, armor, and weapon systems in the three-dimensional modeling software. Senior **Adam Zimmerman** aided in design and commanded the mechanical construction of the complex aerospace titanium, nylon, and structural aluminum assemblies. Sophomore **Jackson Hagler** was in charge of the power system, battery, electrical design, and soldering, aided by freshman **Benjamin Sun**. Seniors **Aiden Dorneich** and **Kevin Quinn** were responsible for the propulsion and programmable control systems. During competition, Adam drove the robot with precise control and unmatched strategy, while Aiden controlled the offensive weapon.

The other members of the Fox Chapel Area High School robotics team are senior **Samuel Kuhns**; juniors **Ava McCaffrey**, **Aiden Purcell**, and **Lucy Rygelski**; sophomores **Riley Puklus**, **Graeson Santucci**, and **Keegan Scanlon**; and freshmen **Krisztian Salvador** and **Alanna Sloss**. The team's sponsor is teacher **Ryan Siniawski** and its industry partner is Pittsburgh-based Aerotech Inc., which provided mentorship and design consultations.

Mr. Siniawski says he is incredibly proud of his students for their dedication and overcoming great odds.

"Their hundreds of hours of work as a second-year design outlasted many teams with over a decade of revisions and experience under their belts," he says.

A total of 38 teams participated in the 'Burgh Bash National Championships, including teams from California and Kansas. The competition was held May 19 and 20, 2023, at Rosedale Technical College in Kennedy Township.

Prior to being named the overall grand champion at the 'Burgh Bash National Championships, the team participated in the BotsIQ State Finals Competition, held at PennWest California at the end of April, where they won second place in Engineering Documentation with a near-perfect score.

• Fox Chapel Area High School senior **Keonha Ye** was named a second-place winner in Pennsylvania in the fifth annual Just Drive public service announcement (PSA) video contest. Students representing 92 high schools from New Jersey and Pennsylvania created 30-second video PSAs highlighting the dangers of distracted driving as part of the contest. According to the Centers for Disease Control and Prevention (CDC), car crashes are a leading cause of preventable deaths for teens.

Keonha's video, "Driver's Test," encourages drivers to exercise the same responsible behavior they used to pass their driving test. First through third places were awarded in each state and Keonha's second place PSA earned Fox Chapel Area High School \$10,000. The Just Drive competition presents a creative opportunity for teens to promote safe driving practices, and the winning schools will put their prize money toward a post-prom, post-graduation, or safe driving program.

The contest was sponsored by NJM Insurance Group (NJM), in partnership with the Brain Injury Alliance of New Jersey (BIANJ) and Impact Teen Driver (ITD). The winning schools were awarded a total of \$60,000.

"Our partners at the Brain Injury Alliance of New Jersey and Impact Teen Drivers inspire students to promote a culture of safety within their schools," said Erica Rosso, NJM Consumer Safety Partnership and Program Supervisor. "Year over year this contest amplifies the power of teen voices. Their collaborative work to raise awareness and end distracted driving gives us promise that safer roads are achievable."

NJM announced the winners in special virtual showcases on Facebook and Instagram on April 26 and April 27, 2023. During the virtual presentation, the winning New Jersey and Pennsylvania submissions were showcased.

“The creative approaches students take in developing safe driving messages reminds us that teens are one of our greatest ambassadors in engaging, educating, and empowering others,” said Kelly Browning, Ph.D., executive director of Impact Teen Drivers.

- Fox Chapel Area High School senior **Arvind Seshan** was selected as a Regional Finalist for the 35th class of the Coca-Cola Scholars Program. Arvind is one of 250 students from across the nation, and one of only 10 from Pennsylvania, to be selected as a Regional Finalist.

Prior to being named a Regional Finalist, Arvind was named a Semifinalist for the 2023 class of the Coca-Cola Scholars Program. A total of 1,557 high school seniors from across the nation (and 100 from Pennsylvania) were chosen as Semifinalists from more than 91,000 applicants. Students are selected as Semifinalists based on their academic excellence, leadership, and service demonstrated in school and community activities.

Regional Finalists participated in the next phase of the selection process which included a 20-minute interview with a regional committee comprised of a Coca-Cola Scholars Foundation staff member and previous Coca-Cola Scholars Program scholarship recipients.

A joint effort of Coca-Cola Bottlers across the country and The Coca-Cola Company, the Coca-Cola Scholars Program is the largest corporate-sponsored, achievement-based scholarship program in the United States. With the addition of the 2023 class, the Coca-Cola Scholars Foundation will have provided more than \$81 million in scholarships over the course of 35 years.

- Fox Chapel Area High School senior **Arvind Seshan** was named a semifinalist in the 2023 U.S. Presidential Scholars Program. Arvind is one of nearly 630 outstanding high school seniors from across the nation, and one of only 16 from Pennsylvania, chosen as a semifinalist. The semifinalists were selected from approximately 5,000 candidates from nearly 3.6 million high school seniors graduating this year from across the U.S.

Inclusion in the Presidential Scholars Program, begun in 1964, is one of the nation’s highest honors bestowed upon graduating high school seniors. Students are first selected for the program based on their superior academic achievements. They are then further evaluated on their academic achievements, personal characteristics, leadership and service activities, and the quality and content of a submitted essay.

- A Fox Chapel Area High School and A.W. Beattie Career Center student placed first in the SkillsUSA Pennsylvania District 8 competition. Senior **Casey Forst** won a gold medal in the medical math competition. Casey is a student in Beattie’s Introduction to Pharmacy program and also qualified for the SkillsUSA state competition that was held April 12-14, 2023, in Hershey, Pennsylvania.

The SkillsUSA District 8 competition was held in January at Pittsburgh Technical College. The competition was open to students from 10 career and technical education centers from across the greater Pittsburgh area.

- A team of Fox Chapel Area High School students were named semifinalists in the 2023 Western Pennsylvania History Bowl tournament. The team of seniors **Elijah Conklin, Nathaniel Green, Arvind Seshan,** and **Prajval Sreenivas** and junior **Logan Dressman** placed third, making them semifinalists in the varsity division. The team qualified for the National History Bowl that was held in Arlington, Virginia, at the end of April. All five of the students are members of the Fox Chapel Area High School History Club.

The Western Pennsylvania History Bowl tournament was held at South Side Area High School January 21 in Hookstown, Pennsylvania. A total of 11 teams from Ohio, Pennsylvania, and West Virginia competed in the tournament where they answered questions about world and United States History. The contest was sponsored by International Academic Competitions.

- Fox Chapel Area High School senior **Elijah Conklin** placed in two individual events as part of the National History Bowl. In the United States Geography Championships, Elijah placed eighth in the nation and in the National Political Science Bee, he placed 21st.

Elijah was at the competition with teammates seniors **Nathaniel Green, Arvind Seshan,** and **Caleb Hahl** and junior **Logan Dressman** who qualified for the National History Bowl by being named semifinalists in

the varsity division of the 2023 Western Pennsylvania History Bowl tournament. At nationals, only a tiebreaker kept the team from qualifying for the playoff rounds. Additionally, senior **Prajval Sreenivas** also qualified for the national competition with the team, but was unable to attend. All six students are members of the Fox Chapel Area High School History Club.

The national competition was held April 28 and 29 in Arlington, Virginia, and was sponsored by International Academic Competitions.

- Three Fox Chapel Area School District students won first-place awards at the 84th Annual Pittsburgh Regional Science & Engineering Fair (PRSEF), and one of those students qualified for an international competition.

Fox Chapel Area High School senior **Arvind Seshan** was one of six overall winners and qualified to participate in the Regeneron International Science & Engineering Fair (Regeneron ISEF) for the third consecutive year. Judging for the international competition was held May 14-19, 2023, in Dallas, and hundreds of students in grades 9-12 from nations across the world competed for prizes worth millions of dollars. Arvind also won first place in the senior division computer science/math category. The name of Arvind's project is "An Iterative Neural Network Based Approach to Automated IFT-20 Sensory Neuron Identification in *Caenorhabditis elegans*."

Additionally, sophomore **Rohit Velankar** was named the first-place winner in the senior division physics & astronomy category, and sixth-grader **Rishabh Krishnamurthy** won first place in the junior division behavioral & consumer science category. The PRSEF also nominates all first-, second-, and third-place junior and intermediate division category winners to attend the Thermo Fisher Scientific Junior Innovators Challenge (formerly called the Broadcom MASTERS competition) that is held annually in October in Washington, D.C.

The PRSEF is open to students in grades 6-12 from the 21 counties within Western Pennsylvania and Garrett County in Maryland. Each year, approximately 1,000 students from more than 100 schools compete for cash, scholarships, and trips worth thousands of dollars. All of the students who participated in the fair conducted individual science research and presented their projects to a committee of judges. The judging took place March 28 and 29 at the Carnegie Science Center. An awards ceremony was livestreamed March 31.

- Seven Fox Chapel Area High School and Dorseyville Middle School students won first-place awards as part of the 89th Annual Region 7 Meeting of the Pennsylvania Junior Academy of Science (PJAS).

Fox Chapel Area first-place winners were seniors **Lawrence Liu** and **Arvind Seshan**; juniors **Lakshanya Rajaganapathi** and **Adhitya Thirumala**; sophomores **Etash Jhanji** and **Rohit Velankar**; and eighth-grader **Param Thawani**. The first-place winners qualified for the state PJAS competition which was held May 15-17, 2023, at Penn State University, Main Campus.

The participating students (from several schools from Allegheny and Westmoreland counties) researched their science projects for several months. During the competition, each of the students was required to make a presentation in front of a panel of judges. The regional competition was held February 4, 2023, at Baldwin High School.

- Four Fox Chapel Area School District students won awards in the State Competition of the Pennsylvania Junior Academy of Science (PJAS). Fox Chapel Area first-place state winners were juniors **Lakshanya Rajaganapathi** and **Adhitya Thirumala**; sophomore **Etash Jhanji**; and eighth-grader **Param Thawani**. Additionally, Lakshanya was named the Pennsylvania Science Talent Search (PSTS) Outstanding Junior, and Param received a Perfect Score award and a Director's Award for Junior High Excellence in Computer Science.

The participating Fox Chapel Area High School and Dorseyville Middle School students were among students in grades 7-12 from across Pennsylvania who competed at the state PJAS competition. The students researched their science projects for several months and were required to give an oral presentation on their projects in front of a panel of judges.

The state competition was held at Penn State University (Main Campus) May 14-16, 2023. All of the Fox Chapel Area students participating at the state level were named first-place winners at the 89th Annual Region 7 Meeting of the PJAS in February.

- Fox Chapel Area High School junior **Sofia Liberto** was named a winner in the Third Annual Prime Stage High School Drama Awards. Sofia won the award for best student costume design for Fox Chapel Area High School's fall play, "Arsenic and Old Lace."

The Fox Chapel Area High School students performed a scene from the fall play as part of the awards ceremony that was held April 24, 2023, at Prime Stage's New Hazlett Theater Center for the Performing Arts. The awards, sponsored by Prime Stage Theatre, recognize excellence in high school drama and were open to schools from across Southwestern Pennsylvania.

- Several Fox Chapel Area High School students placed in the 2022 Future Business Leaders of America (FBLA) Virtual Regional Leadership Conference and many qualified for the state competition. Fox Chapel Area first-place regional winners were seniors **Helia Hamidi** and **Jack Wilk**; juniors **Jacob Anthikad**, **Maria Costantino**, **Evelyn Healy**, **Madelyn Jones**, **Whitney Jones**, **Harry Littwin**, and **Angela Ngo**; sophomores **David Black**, **Jackson Hagler**, and **David Sorisio**; and freshmen **Marin Airik**, **Prachi Behal**, **Maeve Beresford**, **Michael Costello**, **Aavree Hill**, and **Rodrigo Silva**. Second-place regional winners were senior **Paul Kullmann**; juniors **Joseph Berger**, **Micah Cagley**, **Isaac Jacobs**, and **Dylan Work**; sophomores **Charles Larsen**, **Anna Mohn**, and **Kennedy Murton**; and freshmen **Joshua Shah** and **Nicolas Squeglia**. Third-place regional winners were 2023 early graduate **Zachary Sullivan**; juniors **Iris Doty**, **Jenna Lazaro**, **Tess Petrucelli**, and **Heidi Tong**; sophomores **Matthew Begg**, **Kai Edwards**, **Gabriella Hample**, and **Keegan Scanlon**; and freshman **Avery Jones**. Fourth-place finishers were senior **Diya Reddy**; juniors **Julia Hernaez** and **Jadyn Smouse**; and sophomores **Rayna Huang**, **Jonah Kline**, and **Asher White**. Fifth-place regional winners were sophomore **Rachel Pegher** and freshmen **Mira Owens** and **Emma Srodes**. Other winners included juniors **Ava McCaffrey** and **Gloria Wen**; and sophomores **Brennan Bielawski**, **Selin Geylani**, **Swati Mylarappa**, and **Holden Starz**. All of these students qualified to participate in the 2023 FBLA State Leadership Conference that was held in Hershey, Pennsylvania, April 17-19, 2023.

The FBLA Virtual Regional Leadership Conference was held in December 2022 and January 2023. Approximately 600 students from 11 school districts participated in the regional competition.

- Eleven Fox Chapel Area High School and Dorseyville Middle School students placed at the 2023 Future Business Leaders of America (FBLA) State Leadership Conference. Juniors **Micah Cagley** and **Dylan Work**, sophomores **Kai Edwards** and **Gabriella Hample**, and freshman **Joshua Shah** all won first places; and juniors **Harry Littwin** and **Gloria Wen** won second places. All seven of these students qualified to participate in the FBLA National Leadership Conference that will be held June 27-30 in Atlanta. Other Fox Chapel Area High School state place winners were juniors **Laney Porterfield** (second place) and **Jacob Anthikad** (seventh place) and sophomores **Kai Edwards** (two fifth places) and **Jackson Hagler** (sixth place). Additionally, Dorseyville Middle School sixth-grader **Matthew Bartolacci** also placed second at the state conference. This was the first year that Dorseyville Middle School had a chapter of FBLA at the school.

The Fox Chapel Area High School chapter of the FBLA also received the 5th Largest Local Chapter Membership Award with 117 total members. There are more than 200 high schools participating in FBLA within the state of Pennsylvania.

The FBLA State Leadership Conference was held in Hershey, Pennsylvania, April 17-19. More than 5,000 students from high schools across the state participated in the competition. The Fox Chapel Area High School FBLA sponsor is business education teacher **Christina Congalton**.

- Hartwood Elementary School fourth-grader **Charlene "Cici" Xu** was named the winner of the Allegheny County Sumdog Contest. The Sumdog contest consists of an online math quiz that students take on their own time. For the county contest, Cici took the online test in November 2022 and answered 991 out of 1,000 questions correctly, more than any other participating student in the county.

Additionally, in September 2022, Cici finished 32nd (in the top 1%) of all 26,524 students who competed in the national Sumdog September Slam Math Contest. In that contest, Cici answered 978 math questions

correctly out of 1,000. Also, as part of that national contest, Hartwood Elementary teacher Leah Rea's fourth-grade class as a whole, of which Cici is a member, finished in the top 10% overall out of 1,615 classes in the nation.

Cici also participated in the Sumdog Spring Fling math contest May 5-11 where she finished ninth in the nation from among 13,231 students.

Sumdog is a free online math contest offered throughout the year and students compete against other classes and schools, locally and/or nationally. Students' individual scores are based on the number of questions they answer correctly during the contest and the class score is based on the average of the number of questions answered correctly by every student in the class.

- A Fox Chapel Area High School student won a gold medal in the Tri-State Track Coaches Association (TSTCA) indoor track championships. Junior **Anna Troutman** won first place in the high jump at the meet that was held February 18 at PennWest Edinboro. Additionally, Anna qualified for the Pennsylvania Track and Field Coaches Association (PTFCA) indoor state championship meet in the high jump. The state meet was held February 26, 2023, at Penn State University (Main Campus).

- Two members of the Fox Chapel Area High School girls track & field team qualified for the 2023 PIAA Track & Field Championships. Junior **Anna Troutman** (100 meter hurdles) and freshman **Claire Conti** (discus) qualified for the state competition. The championships were held May 26 and 27 at Shippensburg University.

- The Fox Chapel Area High School boys varsity tennis team won the WPIAL Class 3A Section 3 team title. Members of the team were seniors **Jack Delaney, Christopher Ernharth, Cooper Friday, Arjun Golla, Ananth Kashyap, and Owen Patel**; juniors **Ben Hallman, Travis Malone, and William Siegel**; and sophomores **Mason Friday, Milan Golla, Parker Haberman, Ezra Shensa, and Henry Stallings**. The team was undefeated in the section with a record of 6-0 and the team finished with an overall record of 12-2.

- Four members of the Fox Chapel Crew Team qualified for the Scholastic Rowing Association of America (SRAA) National Regatta. The team members are freshmen **Charles Hahl, Keitaro Inada, Gavin Nguyen, and Nikolaj Vavpetic**. The SRAA National Regatta was held May 26 and 27, 2023, in Oak Ridge, Tennessee.

Twenty-eight Fox Chapel Area High School rising seniors are among the 50,000 highest-scoring participants on the 2022 Preliminary SAT/National Merit Scholarship Qualifying Test (PSAT/NMSQT) and have met the requirements to enter the 2024 National Merit Scholarship Program. More than 1.3 million students took the 2022 PSAT/NMSQT and these Fox Chapel Area students are among the 50,000 highest-scoring participants on that test from across the nation.

Approximately 16,000 of these highest scoring students will be named National Merit Scholarship Program Semifinalists in September 2023, representing the top scorers in each state, and approximately 34,000 of the students will be commended for their performance on the PSAT/NMSQT. The Semifinalists will have the opportunity to continue in the competition for about 7,250 Merit Scholarship awards to be offered in 2024.

#### •Students Win Awards at Regional Science & Engineering Fair

Four Fox Chapel Area School District students won awards at the 84th Annual Pittsburgh Regional Science & Engineering Fair (PRSEF). Fox Chapel Area High School junior **Adhitya Thirumala** won a scholarship award from Slippery Rock University. Additionally, three Dorseyville Middle school students were also named winners. Sixth-grader **Rishabh Krishnamurthy** won sponsor awards from Thermo Fisher Scientific, Society for Analytical Chemists of Pittsburgh & Spectroscopy Society of Pittsburgh, and the Naval Nuclear Laboratory. Eighth-grader **Param Thawani** won third place in the intermediate division engineering/robotics category and the Lemelson Early Inventor Prize affiliated sponsor award. The PRSEF also nominates all first-, second-, and third-place junior and intermediate division category winners to attend the Thermo Fisher Scientific Junior Innovators Challenge (formerly called the Broadcom MASTERS competition) that is held annually in October 2023 in Washington, D.C. In addition, seventh-grader **Divya Thirumala** won a Society for Women Engineers sponsor award.

The PRSEF is open to students in grades 6-12 from the 21 counties within Western Pennsylvania and Garrett County in Maryland. Each year, approximately 1,000 students from more than 100 schools compete for cash, scholarships, and trips worth thousands of dollars. All of the students who participated in the fair conducted individual science research and presented their projects to a committee of judges. The judging took place March 28 and 29 at the Carnegie Science Center. An awards ceremony was livestreamed March 31.

• **Students Win Special Awards at State FBLA Competition**

Several Fox Chapel Area High School students won special awards at the 2023 Future Business Leaders of America (FBLA) State Leadership Conference. Six students were inducted into the National Business Honor Society: senior **Stella Ruane** and juniors **Annalese Bartolacci**, **Maria Costantino**, **Whitney Jones**, **Angela Ngo**, and **Kieu Uyen Tong**. Big 33 Community Service Awards went to 2023 early graduate **Zachary Sullivan**, junior **Joseph Berger**, and sophomore **Sienna Siegel**. Business Achievement Awards were given to senior Stella Ruane (Contributor level, Advocate level, and Leader level), junior Annalese Bartolacci (Contributor level), and sophomore **Kai Edwards** (Contributor level, Advocate level, and Leader level).

The FBLA State Leadership Conference was held in Hershey, Pennsylvania, April 17-19. More than 5,000 students from high schools across the state participated in the competition. The Fox Chapel Area High School FBLA sponsor is business education teacher **Christina Congalton**.

• **High School Student Selected for NCWIT Affiliate Rising Star Award**

Fox Chapel Area High School junior **Lakshanya Rajaganapathi** was selected to receive the National Center for Women & Information Technology (NCWIT) Western Pennsylvania Affiliate Rising Star Award for Aspirations in Computing (AiC). Lakshanya was selected for the award based on her demonstrated aspirations in computing and technology. She received a medal and a certificate in honor of her achievements.

The NCWIT Western Pennsylvania Affiliate Rising Star Award for AiC recognizes high school students in grades 9-12 for their aptitude and interest in information technology and computing, solid leadership ability, successful academic history, and plans for postsecondary education. The Western PA affiliate of the NCWIT Award for AiC is a collaborative effort by dedicated volunteers from Saint Francis University, Penn State University New Kensington, the University of Pittsburgh, Carnegie Mellon University, and All Clear Translations.

• **High School Team Receives Honorable Mention in Governor’s STEM Competition**

A team of Fox Chapel Area High School students received an honorable mention in the ninth annual Pennsylvania Governor’s STEM Competition. The team members are juniors **Lakshanya Rajaganapathi**, **Adhitya Thirumala**, and **Gabriella Urso** and sophomores **Alex Kim** and **Swati Mylarappa**. The theme of the competition this year was “Innovating the Commonwealth through Collaboration and Computing.” The Fox Chapel Area High School team was one of 20 winning teams from across the state and one of only two from Western Pennsylvania to be named a winner.

The Fox Chapel Area group developed a product called TURBO, a low-cost turbidity sensor that repurposes the already-existing LifeStraws. TURBO addresses the needs of individuals struggling with various water quality issues and bridges the gap between individuals and communities from around the world to reduce water contamination. The device measures the turbidity of the water and relays the data via a mobile application to local water authorities who then alert the public about possible water contamination in the area.

This year, the Governor’s STEM Competition challenged 62 teams of students in grades 9-12 from across the state to research, design, and present a device or project that can help improve the lives of Pennsylvanians and fulfill real-world needs.

“The thought and innovation that went into this year’s projects continues to show us why Pennsylvania has long been seen as a national leader in STEM,” said Acting Secretary of Education, Dr. Khalid N. Mumin. “The commonwealth is fortunate to have such talented, knowledgeable, and creative students.”

• **Students Named Outstanding Young Citizen Awardees**

Three Fox Chapel Area High School students have been named among the top 163 in the 2023 Trib Total Media Outstanding Young Citizen program.
