



2024 / 2025 CRHS PARKING AGREEMENT

Driving to school is a privilege, and this privilege may be revoked for violation CRHS school rules. Students are expected to respect and obey regulations associated with parking and driving on campus.

Per Fort Mill School District policy, prior to parking on school campuses, students must complete the Alive @ 25 Defensive Driving course. **Freshman are not allowed to purchase a parking decal.**

CRHS is not responsible for property or damage to vehicles parked on campus, nor is the school responsible for settling disputes arising from such. All cars parked on the CRHS campus are subject to search by school administration. Students who park on the CRHS campus without the appropriate parking permit may be subject to fines and/or Discipline.

STUDENTS ARE EXPECTED TO ABIDE BY THE FOLLOWING CRHS PARKING RULES:

Vehicles must be operated on campus in a safe manner and not exceed the posted speed limit of 12 MPH.

Reckless driving will result in the loss of parking privileges.

- Vehicles must have a current parking permit. Stickers must be placed on the inside lower left, front windshield. Student cars will be checked for stickers during the school year.
- New vehicle or vehicle transfer of a sticker, and lost sticker: **MUST BE REPLACED.** Cost for the replacement permit is \$5.00. Parking stickers for new vehicles/transfers will need to be turned in and you will receive a new one for a new vehicle. You may only receive 1 replacement sticker. Any additional replacements will require full sticker price.
- Parking permits are not transferrable.
- Students may not register a car, duplicate, give, or sell a parking permit to another student. If this occurs, parking privileges will be revoked for both students and fines will be assigned.
- Students must park in their assigned parking space. The sticker number & parking space number must correlate.
- Students may not sit in cars or loiter around vehicles after arriving to school. Doors open at 8:10 AM.
- Stereo volume must not disrupt the school atmosphere before, during, or after school hours as determined by administration and staff.
- Students may not go to the parking lot without permission from an administrator.
- Students may not use an automobile to skip school, to drive dangerously, or to violate other school rules. Such actions can result in the loss of parking privileges.
- Automobiles should be locked to prevent theft. The school is not responsible for stolen items.
- **The 6th tardy to school will result in the loss of driving privileges for the remainder of the term.**
- NO REFUNDS will be given for any action that results in loss of parking privileges.
- Parking Without a Pass or Alive @ 25 – 1st offense -\$10.00 Fine, 2nd offense- \$25.00 Fine, 3rd offense – 3 days OSS, 4th offense- Referral to Alt Program or Expulsion.
- Parking Violations for Students with Pass – 1st offense- 1-hour detention, 2nd offense- Saturday Detention, 3rd offense- 2 days ISS & Parking permit revoked, 4th offense – 1-day OSS.
