RESOLUTION REGARDING SUFFICIENCY OR INSUFFICIENCY OF INSTRUCTIONAL MATERIALS

Statement of Sufficiency

WHEREAS, the Santa Barbara County Board of Education, in order to comply with the requirements of California Education Code §60119, held a public hearing on August 3, 2023, at approximately 4:45 p.m., which is on or before the eighth week of school and which did not take place during or immediately following school hours; and

WHEREAS, the Santa Barbara County Board of Education provided at least 10 days notice of the public hearing posted in at least three public places within the district that stated the time, place, and purpose of the hearing; and

WHEREAS, the Santa Barbara County Board of Education encouraged participation by parents, teachers, members of the community, and bargaining unit leaders in the public hearing; and

WHEREAS, sufficient textbooks and instructional materials were provided to each student, including English learners, that are aligned to the academic content standards

and consistent with the cycles and content of the curriculum frameworks in the following subjects:

- Mathematics,
- Science,

- History/social science,
- English language arts; and

WHEREAS, sufficient textbooks or instructional materials were provided to each student enrolled in health classes.

NOW, THEREFORE BE IT RESOLVED, sufficient textbooks and instructional materials in the above stated areas were provided to each student, including English Learners, that are aligned to the academic content standards and consistent with board adopted, standards-aligned materials in grades kindergarten through twelve and with the cycles and content of the curriculum frameworks.

Santa Barbara County School Safety Coalition

As I shared in my May 2023 Superintendent's Report, SBCEO is preparing to launch a Santa Barbara County School Safety Coalition in fall 2023. The coalition will include public, charter, and private schools, preschools, law enforcement, first responders, and external partners/entities. Associate Superintendent Bridget Baublits has been facilitating and leading many meetings to continually engage individuals into the fold as we move forward to establish a meaningful and practical countywide coalition.

Here is an update on some of the supports the coalition will provide to schools:

- Santa Barbara County School Safety Liaison We intend to hire a sworn officer for this role; this position will be posted online after Personnel Commission approval.
- Countywide school safety & first responder team workshops SBCEO is planning for a 2-day safety symposium (dates to be determined). We will be seeking training support from the "I Love U Guys" Foundation.
- Countywide common language for emergencies Over the course of input sessions and working groups, we are close to adopting the same Standard Response Protocols (SRP) as a common language across SB County. Santa Barbara County Civil Grand Jury Report on Cybersecurity in Santa Barbara County Schools

The Santa Barbara County Grand Jury (GJ) notified me on July 15 that its report on Cybersecurity in Schools (attached at the end of this report) may be found online at www.sbcgj.org. All responses to GJ reports are typically published on the GJ website; I will share my response with the County Board when submitted, for your information.

A note: Several weeks ago, the GJ requested I respond to their findings within a 3-day timeframe. At that time, I had not yet received the GJ report. After checking with the GJ recently, I believe my former responses have been invalidated, and my next submission will serve as the final response.

2023-24 State Budget

The governor signed the 2023-24 Budget Act on June 27, 2023. Please see the summary of the budget that follows this Superintendent's Report, prepared by Associate

SBCEO Associate Superintendent Presentation at State Board of Education

SBCEO Associate Superintendent of Curriculum and Instruction Ellen Barger presented at the State Board of Education (SBE) meeting on July 12 about the new mathematics framework. Ellen is the chair of the statewide Curriculum and Instruction Steering Committee (CISC) mathematics subcommittee and was asked to present by the California Department of Education (CDE).

The CISC mathematics subcommittee was included in events and activities with the writers of the new mathematics framework, and also led input and feedback sessions across the state for the Association of California School Administrators (ACSA), alongside the CDE. Now, the CISC mathematics subcommittee will work with state agency partners on implementation of the new mathematics framework.

I thank Ellen for her statewide leadership and for framing the new mathematics framework in a way that supports educators and students throughout California.

New SBCEO website (same domain: sbceo.org)

Last year, our website platform provider, Blackboard, was acquired by Finalsite. Finalsite is a website platform commonly used by school districts and county education offices across the country.

Our Communications team has led the complex work of migrating all of our content from Blackboard to Finalsite, as well as making many enhancements to our pages. We officially launched on July 21.

SBCEO DIVISIONS

Administrative Services Division

COVID-19 Test Kits: The final delivery of COVID-19 at-home rapid test kits from CPDH was received on June 22, 2023. The Internal Services Department coordinated with public, private, and charter schools to determine their needs and place the order. Test kits have been sorted and prepared for distribution to district and school sites.

Medical Therapy Unit (Building D): The roof replacement of Building D was completed in June 2023. All the damage to Building B resulting from the storms has now been repaired.

E-Safety Network Meeting: SBCEO conducted a meeting for district IT professionals on June 21, 2023, at the Jonata Middle School library in Buellton. The topics addressed included artificial intelligence, cybersecurity, and the K-12 high speed network. The meeting provided an opportunity for district IT professionals to collaborate and share esafety best practices and resources.

District Fiscal Support: District financial advisors in the School Business Advisory Services Department provided support to districts in preparation of their Estimated Actuals, Adopted Budgets, and LCAPs. Districts are required annually to take these items to their boards for approval prior to July 1st.

Curriculum and Instruction Division

Preliminary Administrative Services Credential (PASC): Our 16th cohort of PASC candidates finished their coursework on Sunday, June 25 and are in the process of completing their final requirements. The ten candidates are now eligible to apply and accept an administrative position. We are in the process of interviewing candidates for the 17th cohort, which will begin mid-August. This cohort will have approximately 20 candidates, who will complete 32 full days of weekend classes along with asynchronous coursework, 60 hours of field work, a presentation of their original action research project, a portfolio, and the three-cycle California Administrative Performance Assessment. SBCEO was recently contacted by the Commission on Teacher Credentialing (CTC) to learn more about our program because our candidates consistently score among the highest in the state on the assessment. Elsy Villafranca is the director of the PASC Program.

Local Control and Accountability Plans (LCAP) Review: During the months of July and August, the SBCEO LCAP team reads and reviews all 20 districts' LCAPs. Each district LCAP is reviewed by a C&I director and a district financial advisor. If an LCAP has missing elements, we will request clarification in writing by August 15. All LCAPs will be approved and posted by September 15.

Educator Workforce Investment Grant (EWIG): The partnership of Santa Barbara, Los Angeles, and Ventura county offices of education has been granted one of four state grants of \$2.5 million over two years to support districts, schools, and programs that serve multilingual learners in our three counties. The EWIG: Effective Language Acquisition Programs will allow us to partner with all interested districts to provide additional professional learning and coaching in the areas of designated and integrated English Language Development (ELD). Additionally, it will help us strengthen and expand multi-lingual programming in our Dual Language Immersion schools. In our model, we will also be developing language support instructional coaches across the county to ensure sustainability of improvement and support efforts after the grant sunsets.

Customized Professional Development: Districts have requested customized training, presentations and facilitation from our team for the start of the school year on a wide variety of topics and focus areas. For many, it will be the launch of extended customized work that will continue throughout the school year.

Special Education Division

Extended School Year (ESY): ESY began June 12 and continues through July 11. ESY is a service provided to students as deemed necessary by their Individualized Education Program (IEP) teams. The purpose of ESY is to continue work on students' IEP goals to prevent significant regression in skills over the summer.

2023-24 New Staff Orientation, Back to School, and Professional Development:

We are preparing our new staff orientation, back to school, and professional development meetings to begin the 2023-24 school year. There are 9 meetings, starting August 4 and continuing through August 22. Our staff calendars align with the calendars of the districts we serve, which means our staff return at various times in August. As part of this calendar alignment, we coordinate the scheduling of the SBCEO back-to-school and professional development meetings with the back-to-school meetings at the three direct service districts to ensure that our staff can participate in the district meetings.

CYBERSECURITY FOR SCHOOL DISTRICTS IN SANTA BARBARA COUNTY

The Need for Centralized Authority

SUMMARY

Santa Barbara County school districts are regularly targeted by cybersecurity threats, placing students and teachers directly in harm's way. If the response to the COVID pandemic has underscored anything, it is that the resiliency of the U.S. public education system is integral to the national economy and the well-being of communities, whether rural, suburban, or urban across the nation. Serving over 20 public school districts with approximately 70,000 students, the Santa Barbara County public education sector is an enormous albeit highly decentralized entity.

This report analyzing cybersecurity programs in Santa Barbara County's school districts follows last year's (2021) Grand Jury report entitled "Cybersecurity for Special Districts and County Service Areas in Santa Barbara County," which focused on all special districts within Santa Barbara County. This report centers directly on the status and effectiveness of cybersecurity programs in County schools.

County school districts have not mandated the use of multi-factor authentication (MFA)¹ nor formal cybersecurity training for teachers or students, both of which are well-

recognized "best practices" for combatting cyber-attacks. County school districts operate independently and without significant support or oversight from the Santa Barbara County Education Office (SBCEO) in instituting MFA or formal training. Most small, rural districts lack sufficient resources to address the best practices standards recognized by federal and state governments. Even the larger, financially equipped districts have struggled with mandating MFA and formal training. These efforts can and should be centralized within the authority of the SBCEO to formalize policies and procedures in a more cost-effective manner, thereby placing all County school districts on equal footing.

INTRODUCTION

County school districts' Information Technology (IT) members are committed to their mission to ensure that the technology offered in the schools best supports their students and teachers. However, they are often faced with inadequate and underfunded resources, particularly the smaller districts. Some smaller districts rely entirely on independent contractors who work offsite and are often unable to immediately respond to urgent security breaches. The SBCEO also operates with a limited IT budget. The question here is whether expenses associated with cybersecurity should be given higher priority.

Significant sources of K-12 cyber data threats and breaches derive from the actions of school district staff, who, whether from a lack of training or lax cybersecurity controls, inadvertently share the personal information of students and staff in the course of their duties. The other group of individuals commonly responsible for school data breaches is the students themselves. These threats are often facilitated by weak school district password policies and a lack of multi-factor authentication.

METHODOLOGY

The Jury interviewed IT staff members within several school districts and SBCEO. The Jury also interviewed independent IT contractors working for school districts that are too small to have an IT person on staff. Cybersecurity experts were also interviewed about the necessities for a successful cybersecurity program. Finally, the Jury reviewed current Federal and California statutes and public and private publications relating to the administration of cybersecurity within K-12 school districts.

OBSERVATIONS

In January 2023, the U.S. Department of Homeland Security, Cybersecurity and Infrastructure Security Agency (CISA) authored a report,² which outlined the urgent need for the K–12 communities to prevent and mitigate cyber-attacks.³ CISA recommended that K–12 schools begin with a small number of prioritized investments including deploying MFA and implementing a strong cybersecurity training program.

Santa Barbara County Education Office's Role in Supporting Cybersecurity

SBCEO supports 20 public school districts, students, and families within Santa Barbara County. The largest district in the County has an enrollment of 17,000 students, whereas the smallest school district has only 51 students enrolled.⁴

SBCEO's website defines its role as providing the schools with managed antivirus protection, file storage and file sharing, backup services, and purchasing, installing, configuring, and troubleshooting computer hardware and software. SBCEO recognizes

that it supports local school districts by providing services that can be delivered more efficiently and economically at the County level. These include implementing new standards, staff development, and training programs.⁵

Despite SBCEO's numerous cybersecurity responsibilities outlined above, it has provided minimal formal cybersecurity training to its school districts. SBCEO's IT Department is short staffed at present. SBCEO's IT Department primarily manages all school districts' financial systems, which is a complex undertaking for such a large school community.

Threats to Santa Barbara County School Districts

School personnel and people outside the school districts, share a responsibility to address the threats. They include:

- Teachers, administrators, and school board members who might lack the training and knowledge necessary to avoid the errant sharing of personal data and credentials;
- Tech-savvy students, who-in the absence of mentoring and adult guidance, might attempt to circumvent existing cybersecurity controls and/or be lured into using their legitimate access to school IT systems to disrupt, cheat, or even cause harm to others;
- School suppliers and vendors, whose security practices might not be adequately considered during school district procurement decisions and product/service implementation; and
- Online criminals, some based in the U.S., but many based overseas, who seek
 to profit from weak school district cybersecurity controls by stealing or extorting
 money from school districts, their employees, and vendors, or via credit and
 tax fraud enabled by stealing personally identifiable information from school
 districts.

School IT personnel regularly encounter and block cyberbullying in district emails, online searches for inappropriate content, and students playing online games. Most of the County's schools have reported repeated phishing attempts inadvertently transferred to school networks from outside vendors every week, many of which have successfully been blocked by filter software.⁶

In early 2020, SolarWinds, a major software company based in Tulsa, Oklahoma, which provided system management tools for network and infrastructure monitoring, was hacked by nation-state criminals who gained access to the networks of thousands of SolarWinds customers throughout the country. The hack compromised the networks and systems of more than 30,000 public and private organizations, including local, state, and federal agencies — one of which was the Lompoc Unified School System.

On July 2, 2021, a ransomware hacker group based in Russia, exploited vulnerability in the Santa Ynez Valley Union High School District's (SYVUHSD) remote access software, called "Kaseya", and initiated an attack that spread to all Kaseya servers, including one used by SYVUHSD. The ransomware attack encrypted 19 school staff's personal computers, three student laptops, and three servers in addition to about one million systems world-wide. The hackers demanded \$44,999 per machine to decrypt each machine. The SYVUHSD did not pay the ransom and immediately wiped and restored all its files from the backup software. No data was compromised because of the incident.

However, the impact could have been greater because regular school was not in session, - it was the last day of summer school, with very few teachers and students on campus.

In December 2021, a criminal enterprise hacked a district vendor's email. Using a purchase order found in the email, the hackers ordered computers shipped to Nigeria. Without the intervention of the Department of Homeland Security stopping the shipment, the school district and/or SBCEO were in danger of being billed for those computers.

To test students' compliance, staff sent fake emails to students to identify improper uses of the network. Several students opened links that could have infected the network with viruses and malware.

Although damage from these threats may seem unremarkable at present, efforts must be undertaken to limit the predictable increase in future cyber-attacks. According to the cybersecurity expert and IT staff the Jury interviewed, all internet users must begin instituting sound cybersecurity programs as soon as possible to stem the tide of an imminent threat posed by cybercriminals. To that end, the expert and IT staff recommend that the Districts centralize the training, use MFA, and purchase software and cyber insurance through the SBCEO. By placing the control in the hands of the schools' headquarters, the SBCEO would reap the benefits of lower costs because of bulk purchases and a central authority who could issue mandates for all districts in an equal and fair manner.

Zero Trust Architecture

The National Institute of Standards and Technology (NIST), and the expert the Jury interviewed, have recommended the use of Zero Trust Architecture (Zero).⁸ Zero assumes there is no implicit trust granted to:

- Assets (devices, infrastructure components, applications, virtual and cloud components);
- User accounts based solely on their physical or network location (i.e., local area networks versus the internet); or
- Based on asset ownership (enterprise or personally owned).

Authentication and authorization (both subject and device) are discrete functions performed before a session to an enterprise resource is established. The entire network is not considered an implicit trust zone. All assets should always act as if an attacker is present on the network, and communication should be done in the most secure manner available. This entails actions such as authenticating all connections and encrypting all traffic. Every asset must have its security posture evaluated before a request is granted to an enterprise-owned resource.

Obstacles to Training and Multifactor Authentication

In addition to inadequate IT funding, other problems are standing in the way of achieving the necessary fixes. The Jury learned that most of the County's school IT departments work independently and rarely interact with each other about decision-making. In addition, the Jury learned that some of the Districts want to maintain local control.

Most of the districts have instituted a written agreement between students, parents, and the schools, typically executed at the beginning of the school year. The agreement is distributed in simple, accessible language among parents, students, and school personnel, and outlines the terms of responsible use and consequences for misuse of hardware. Parents are expected to acknowledge that their child(ren) will follow basic guidelines, and students agree to the standards laid out in the policy. Multilingual versions of the agreements are made available. However, either execution of these agreements has not been required or school officials are not enforcing them. The Jury learned that many families cannot, or will not, sign the agreements.

The inconvenience inherent in the use of multi-factor authentication, which some interviewees described as daunting to busy teachers, must be overcome for the good of the school communities' safety from cyber threats.

Costs of Formal Cyber Training and Multi-Factor Authentication are Minimal When Compared to the Potential Consequences

Although the costs of the recommended cyber programs may initially result in necessary cost-cutting elsewhere, the need for IT training and MFA significantly outweigh the harm caused by ransomware, network interference, and emotional distress resulting from hacking, cyberbullying, phishing, and criminal acquisition of personal data.

Cyber training is offered free-of-charge by the Federal and State governments, and other non-profit organizations.

A study performed in 2019 revealed that 84 percent of parents worldwide were worried about their children's online safety, according to a survey commissioned by Kaspersky and conducted by the market research company Savanta.⁹

CONCLUSION

Santa Barbara County schools are at great risk if immediate action is not implemented. Cyber threats are targeting our education system and increased cybersecurity demands add strain to school districts. IT personnel provided extensive information for this report. Cybersecurity programs need resources and prioritization.

Collaboration Amongst IT Staff, More Robust Threat Reporting, and Written IT Policies

IT personnel need more opportunities to coordinate with other districts' IT staff and to share reported cyber threats, recommended updates to software and hardware, damage done because of hacking, and potential fixes.

Reporting of cyber-attacks must be a part of cybersecurity. Currently, very few schools report such instances to the SBCEO, which results in the lack of transparency needed to foresee and fix problems. The Jury learned that most threat attempts have not been reported because those efforts were blocked by network filters. If asked to provide such reports currently, IT staff would spend additional time searching through their data and compiling information.

Smaller school districts within the County do not have a technology handbook, manual, or policies and procedures regarding the use of hardware and software. A newly hired employee cannot learn proper cyber procedures without accessible guidelines. While poor outcomes from data threats remain manageable in County schools, most cybersecurity professionals, and much of the public, realize that current threat attempts are merely the tip of the iceberg and that such threats, and potential damage to the school population, will significantly increase with time. As many school districts throughout the country have already learned, it is best to tackle the problem before, not after, the damage has been done.

FINDINGS AND RECOMMENDATIONS

Finding 1

Santa Barbara County school districts have not mandated formal cybersecurity training for school administrators, teachers, staff, and students.

Recommendation 1

That the Santa Barbara County Education Office require all school administrators, teachers, staff, and students who use district networks and computers (including laptops, iPads, and any other electronic media) receive formalized cybersecurity training at least once per year.

Finding 2

Santa Barbara County school districts have not required the use of multi-factor authentication.

Recommendation 2

That the Santa Barbara County Education Office require multi-factor authentication for anyone logging onto the districts' networks.

Finding 3

That some Santa Barbara County school districts are not adequately insured for losses arising from cybersecurity incidents, not insured for cybersecurity or lack sufficient coverage limits.

Recommendation 3 a

That the Santa Barbara County Education Office purchase cyber insurance that will provide limits of between \$1-2 million for each district.

Recommendation 3b

That the Santa Barbara County Education Office require contribution of funds from all districts.

Finding 4

That the districts fail to report cyber-attacks.

Recommendation 4

That the Santa Barbara County Education Office require districts to report cyber-attacks.

Finding 5

Although some district IT members meet from time to time to discuss recent cyber updates, problems, and problem resolution, attendance is voluntary and many rarely attend.

Recommendation 5a

That the Santa Barbara County Education Office issue a written policy requiring collaboration amongst school district IT staff.

Recommendation 5b

That the Santa Barbara County Education Office issue a written policy requiring IT staff to attend regularly scheduled meetings at least four times per year.

of Education Meeting

On June 27, 2023, Governor Newsom signed an on-time budget. The budget maintained several proposals that were included in the May Revision, but some changes were incorporated into the final State Budget. The state's adopted budget successfully closed a \$31.7 billion budget deficit and fully funded the statutory COLA while safeguarding most education programs from cuts. However, the state is deficit spending in 2023-24 and using prior-year one-time funds to address the education revenue shortfall. LEAs should be aware that the state remains at risk for further revenue shortfalls that could result in additional cuts to education spending. The state's complete revenue will not be known until after all 2022 taxes are filed in October, because nearly all residents and some corporations were granted tax filing extensions.

Below are some of the major components of the TK-12 spending included in the 2023-24 adopted budget. The State Budget does provide three new funding sources for COEs: (1) \$200,000 for each COE operating a community school, (2) \$200,000 for each COE operating a juvenile court school, and (3) a Student Support and Enrichment Block Grant for each COE in the amount \$3,000 per alternative education grant ADA. Additional funding for COEs to support LEAs are included in the adopted budget, as well. The COLA increase is applied to the funding provided for LCAP Support and there is a 50% increase to the funding provided for Differentiated Assistance Support.

- 8.22% COLA for LCFF and select categorical programs
- \$200 million decrease to the Arts, Music, Instructional Materials Discretionary Block Grant (May Revision proposed \$1.8 billion decrease)
- \$1.6 billion decrease to the Learning Recovery Block Grant (May Revision proposed \$2.8 billion decrease)
- \$2 billion from the General Fund to the School Facilities Program
- \$938 million ongoing for Arts & Music Initiative (Prop 28) on top of Prop 98
- \$597 million for TK expansion
- \$300 million LCFF Equity Multiplier
- \$300 million increase for Universal Meals based on updated meal counts
- \$250 million to augment the Literacy Coaches and Reading Specialists Grant Program
- \$118 million federal funding for Stronger Connections Grant Program
- \$80 million for COE juvenile court and community schools
- \$20 million for Bilingual Teacher Grants

The certificated and classified personnel reports are provided to the board as an information item.

Certificated Personnel Report

Certificated employees are those whose positions require a specific credential issued by the California Commission on Teacher Credentialing.

The certificated personnel report is generated regularly and includes all actions made regarding employment of certificated employees at SBCEO such as appointments and separations.

Classified Personnel Report

Classified employees are those whose positions do not require a state-issued credential. Since 1975, the Santa Barbara County Education Office has operated a Merit System for the classified service. Merit System law (Education Code § 45240-45320) provides that classified employees are selected, retained and promoted on the basis of merit and fitness, exclusive of discrimination due to actual or perceived race, color, ethnicity, age, religion, political affiliation, marital status, disability, gender, sexual orientation or national origin. The Personnel Commission, composed of three members, is the impartial body authorized by the state to be responsible for implementing and interpreting Merit System rules and adjudicating appeals on those facets of employment within its purview.

The classified personnel report is generated monthly and includes all personnel actions affecting classified employees at SBCEO such as appointments, changes to status, and separations.
