Statewide Assessments

Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. The assessments were required to be:

- Aligned with CA CCSS for ELA and mathematics;
- Available to students in grades 3 through 8, and grade 11; and

Options

Note that the CAAs could only be administered in-person following health and safety requirements. - Combination of Smarter Balanced ELA and mathematics summative assessments and other assessments.

Percentage of Students Meeting or Exceeding the State Standard on CAASPP

2021-22 Opportunities for Parental Involvement

Fairview offers several opportunities for families to partner with the school. All families are invited to join the School Site Council(SSC), Site Based Decision Making Team (SBDM), Parent Teacher Association (PTA), the African American Student Achievement Initiative (AASAI) and the English Language Advisory Committee (ELAC). All of these groups have very important roles on campus. The School Site Council plays an intricate role in developing the School Plan for Student Achievement and ensures all funds resources are used appropriately. The Site Based Decision Making Team focuses on policy and procedure development and provides oversight of school rules to ensure a safe and efficient campus community. The PTA is focused on fundraising to provide fun, educational and morale-building activities for our community. The vision of AASAI is to partner with HUSD to design and implement a culturally responsive learning environment that will respond to the African American community's concerns for its students and that will yield dramatically improved engagement and achievement. Our ELAC is a very involved group of parents, who ensure our English Learners are receiving all the proper supports and accommodations that would allow equal access to the general curriculum.

During a non-pandemic period, parents are always welcome to volunteer in the classrooms to support the teacher and student learning. Parents also actively participating in fundraisers, book fairs, the winter carnival, movie nights and preparing for class projects. Fairview re-launched its Parent Center several years ago with a new room and easier access to resources for families. The center is open during school hours and provides computer access for parents, parenting classes, American Sign Language classes and conversational English classes for parents who's primary language is not English. This school year, Hayward USD and Fairview Elementary has been challenged with managing the impacts of the COVID-19 pandemic. This has led to the implementation of a Distance Learning model of instruction for most of the school year.

Due to the COVID-19 pandemic, parental involvement and events had to be done remotely via zoom or as a drive through as families stayed in their cars with masks and following proper protocols. Parent involvement opportunities continue to be done over zoom due to the pandemic.

At the time of the latest review of the School Site Safety Plan, all revisions were communicated to both the classified and certificated staff. The school's disaster preparedness plan includes steps for insuring student and staff safety during a disaster. Fire, disaster, and lockdown drills are conducted on a regular basis throughout the school year.

Students are supervised throughout the day by teachers, administrators, and yard duty supervisors. There is a designated area for student drop off and pick up. Visitors need to check in the front office and receive a badge verifying they've been cleared to be on campus. All school volunteers are required to be fingerprinted through the Department of Justice.

Safety is a high priority because it is necessary to ensure a successful and healthy educational environment. Students are supervised throughout the day by teachers, administrators, and other campus supervisors. There are designated areas for student drop-off and pick up. Visitors need to check in at the front office and receive a badge.

Fire, disaster, and lockdown drills are conducted on a regular basis throughout the school year so that all staff and students are familiar with what steps to take in an event of an emergency. The school is using an online application called Share911 to communicate with staff during emergencies. This online safety app is also used to coordinate safety/disaster drills.

Our school has an active School Safety Committee that includes administrators, teachers, maintenance, school supervisors, and other staff members. The committee works together in forming and revising the school safety plan as well as responding to day-to-day safety issues. At the time of the latest review of the School Site Safety Plan, all revisions were communicated to both the classified and certificated staff. During the 2020-21 school year, this has included all of the necessary safety, health and sanitizing protocols to ensure that staff and visitors to campus remain as safe as possible during the COVID-19 Shelter in Place status of our school.

In May 2021 HUSD opened for in person learning opportunities at all sites. HUSD developed district wide safety plans with schools also having plans specific to their site. The "Ready to Return" In-Person Learning Safety Plan was created in April 2021 that addressed questions/guidelines regarding face masks, daily health screenings using the Frontline Health Portal, social distancing, and cleaning procedures. Notifications of the plans were sent out to all staff and families. It was posted on the district/school websites for the entire HUSD community to access.

2020-21 Types of Services Funded

Fairview funds a wide range of services to assist our students to become grade level proficient and college ready. We have purchased supplemental reading materials to ensure that our students are provided reading instruction catered to their ability. Reading intervention support is provided through digital programs. Additional support services provided by Fairview include crisis counseling, general counseling, trauma informed teaching support, PBIS and alternative to suspension programs.

Fairview hired Reading Intervention Specialists to provide small group reading instruction to struggling readers (K-3). Fairview hired an ELD teacher to support long-term EL students (4-6) through intensive language development classes in addition to the ELD instruction provided by the classroom teacher. Fairview purchased Leveled Literacy Intervention and Fountas & Pinnel Guided Reading Materials as anchor materials for all intervention/acceleration support in reading classes.

Fairview Elementary School contracts with community-based agencies such as Kids to Pros Inc. to provide weekly hands on S.T.E.A.M. activities for our students. Fairview also contracted with Soul Shoppe Inc. to provide monthly grade level and school-wide workshops that promote character building, unity, healthy choices, effective communication and the development of interpersonal & coping skills.

Professional Development

Fairview school has focused its professional development in the areas of Socio-Emotional Learning Strategies, Culturally & Linguistically Responsive Teaching, Balanced Literacy and Guided Reading. Specific to the 2020-21 school year, Fairview has added a focus on developing Effective Online Instruction by offering professional development that increases our teachers digital toolboxes by providing training and access to a myriad of online instructional tools.

Fairview has an Instructional Leadership team comprised of teacher representatives from primary, intermediate, kinder and the special education department who work together to coordinate professional development opportunities for the entire staff. Fairview has five full-day professional development days, five minimum days that are used for professional development and we utilize all of our 10 monthly staff meetings for professional development. Teachers are also encouraged to participate in ongoing professional development in their weekly collaboration meetings using the Cycle of Inquiry learning process. Teachers are supported by whole staff professional developments, as well as focused grade level inquiry processes. Educators are supported to attend conferences and to share acquired knowledge with other staff members.
