2021-22 Opportunities for Parental Involvement

At Schafer Park Elementary we have many opportunities for parental involvement. First, we have our Parent Center which is a place for parents to network, learn about nutrition, attend important workshops, attend meetings, and exercise. Our Schafer Park PTA puts on cultural and educational events, but most importantly fund raises to supplement our school program with field trips, assemblies, transportation, online programs, and educational events. Our School Site Council (SSC) is a group of parents, teachers, staff, and the principal who review budgets, school wide programs, and approve the School Plan for Student Achievement to ensure student academic success. The English Learner Advisory Committee (ELAC) is a group of parents whose children are primarily English Language Learners (ELL), but not exclusive to that group. ELAC meets to review information and programs for ELL students and makes recommendations to the SSC in regards to their needs. Another opportunity for involvement is the Site Based Decision Making (SBDM) group. This group meets to discuss site issues that have school wide impact, such as day to day operations. Our Community Involvement Committee also puts on events such as Family Math Night, Talent Show, Musicals, and Science Fair. Every month we have Coffee with the Principal where the principal discusses school wide issues with parents. There's also time given to parents to bring up any issues they may have. Finally, parents are welcomed to volunteer in class, attend field trips or at the school site, but must first complete the district volunteer process.

2021-22 School Safety Plan

At the time of the latest review of the School Site Safety Plan, all revisions were communicated to both the classified and certificated staff. The school's disaster preparedness plan includes steps to ensure student and staff safety during a disaster. Fire, disaster, shelter in place, and lock down drills are conducted on a regular basis throughout the school years.

Safety is a high priority because it is necessary to ensure a successful and healthy educational environment. Students are supervised throughout the day by teachers, administrators, and yard duty supervisors. There is a designated area for student drop off and pick up. Visitors need to check in the front office and receive a badge.

Due to COVID-19, this school year, we were in shelter in place. Teachers who come on campus do the self assessment and sign in. Teachers schedule materials distribution which are drive thru events. Currently, we don not allow visitors on to campus. Tech issues and materials distribution are handled out outside of the library.

Fire, disaster, and lockdown drills are conducted on a regular basis throughout the school year so that all staff and students are familiar with what steps to take in an event of an emergency. The school is using an online application called Share911 to communicate with staff during emergencies. This online safety app is also used to coordinate safety/disaster drills.

Our school has an active School Safety Committee that includes administrators, teachers, maintenance, school supervisors, and other staff members. The committee works together in forming and revising the school safety plan as well as responding to day-to-day safety issues. At the time of the latest review of the School Site Safety Plan, all revisions were communicated to both the classified and certificated staff. During the 2020-21 school year, this has included all of the necessary safety, health and sanitizing protocols to ensure that staff and visitors to campus remain as safe as possible during the COVID-19 Shelter in Place status of our school.

In May 2021 HUSD opened for in person learning opportunities at all sites. HUSD developed district wide safety plans with schools also having plans specific to their site. The "Ready to Return" In-Person Learning Safety Plan was created in April 2021 that addressed questions/guidelines regarding face masks, daily health screenings using the Frontline Health Portal, social distancing, and cleaning procedures. Notifications of the plans were sent out to all staff and families. It was posted on the district/school websites for the entire HUSD community to access.

2020-21 Types of Services Funded

At Schafer Park we provide several supports and assists to students and their families. A large percentage of our categorical funds go towards personnel. We have a reading intervention specialist and a bilingual/biliterate paraeducator who provides intervention for our 1st and 2nd graders, as well as our newcomers in English and Spanish. We fund parent volunteers by paying for their fingerprinting fees. We use some funds to pay for the Accelerated Reader program which provides us information such as a student's reading level. We also set aside funds for after school intervention, books/magazines, and instructional materials.

Using our discretionary funds we provide other online learning programs such as Nearpod, Dreambox, and Starfall. Most of these funds go towards school supplies and copy paper.

Professional Development

This section provides information on the annual number of school days dedicated to staff development for the most recent three-year period.

For the past three years Schafer Park has focused on Cycles of Inquiry in Math and Reading Comprehension.

As part of the growth process, opportunities for training and staff development are provided at both the district and individual school sites to administrators, teachers, and classified staff. The district offered over five staff development days in 2020-21. The curricular focus of the current school year is Mathematics. Hayward Unified School District is also coordinating minimum days to provide ongoing professional development in mathematics.

This school year HUSD has provided all employees training in Anti-Bias/Anti-Racist and equity. The school district also provided two days of technology training to prepare staff for distance learning.

At Schafer Park teachers focus on strengthening our professional learning community by completing 1 cycle of inquiry during the year. Teachers have release time to focus on other school initiatives such as our developing Dual Language Immersion program and implementing our new math curriculum.

For the past 2 years we have implemented Math Workshop school-wide. We've used release days, professional development days, minimum days and PLC meeting time to focus implementation and growth.
